Background to Source Data

Background to Source Data

- ❖ HMRC Regional Trade Statistics (RTS) have been the basis of the analysis.
- ❖ Data are downloaded from the HMRC website:
<https://www.uktradeinfo.com/Statistics/RTS/Pages/default.aspx>
- ❖ Data are presented for the calendar years 2015, 2016 and 2017.
- ❖ A proportion of the import and export data from the HMRC database could not be attributed to any UK region. The data appear as 'unknown' within the tables.
- ❖ The HMRC database provided a figure for 'Low Value Trade' (LVT). LVT cannot be attributed to a geographical country therefore will only be included in the 'unknown' category in the slides for UK trade in goods with CPTPP Countries.
- ❖ The data are only available for goods. Trade in services is not included in this analysis.
- ❖ The data from companies who are not registered for VAT are not included in RTS.
- ❖ Figures may not add due to rounding.
- ❖ The RTS data may be subject to quarterly revisions. 2017 data at the time of this analysis (September 2018) are still provisional and therefore subject to change.

- ❖ The share of UK RoW exports to CPTPP countries increased from 13.8% in 2015 to 15% in 2017

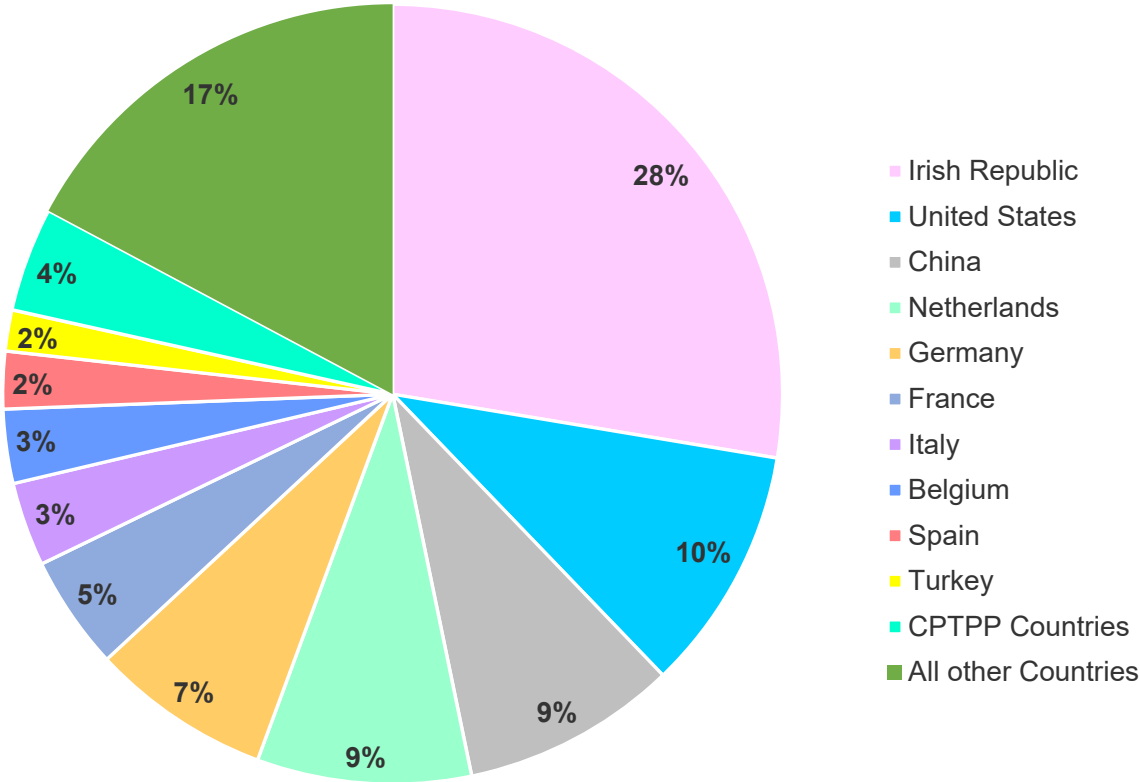

- ❖ Telecomms and electrical machinery & appliances sectors accounted for 29% of imports in 2015 and 31% in 2017
- ❖ Other transport equipment and medicinal & pharmaceutical products accounted for 54% of exports in 2015 and 63% in 2017

UK Trade in Goods with CPTPP Countries – Imports

Imports from CPTPP countries accounted for 4% of total NI imports in 2017

Northern Ireland Imports by origin in 2017



- Imports from CPTPP countries were £322m which was 4% of total NI imports in 2017.
- 63% of imports into NI came from 5 countries: RoI (28%), United States (10%), China (9%), Netherlands (9%) and Germany (7%).
- Total NI imports increased by 13% from £6,574m in 2015 to £7,443m in 2017.

Japan and Canada accounted for 63% of CPTPP imports to NI in 2017

- Japan and Canada had the highest proportion of imports into NI across all CPTPP countries in 2015 (64%), 2016 (63%) and 2017 (63%).
- NI imports from CPTPP countries increased by 18% between 2015-2017.

The share of total UK imports from CPTPP countries increased from 5.5% in 2015 to 6.1% in 2017

- Total UK imports increased by 31% from 2015-2017.
- The CPTPP share of total UK imports increased from 5.5% in 2015 to 6.1% in 2017.
- In 2017 NI imports from CPTPP countries were 4.3% which was the lowest importing region across the UK.

The share of total UK RoW imports from CPTPP countries increased from 12.3% in 2015 to 13.5% in 2017

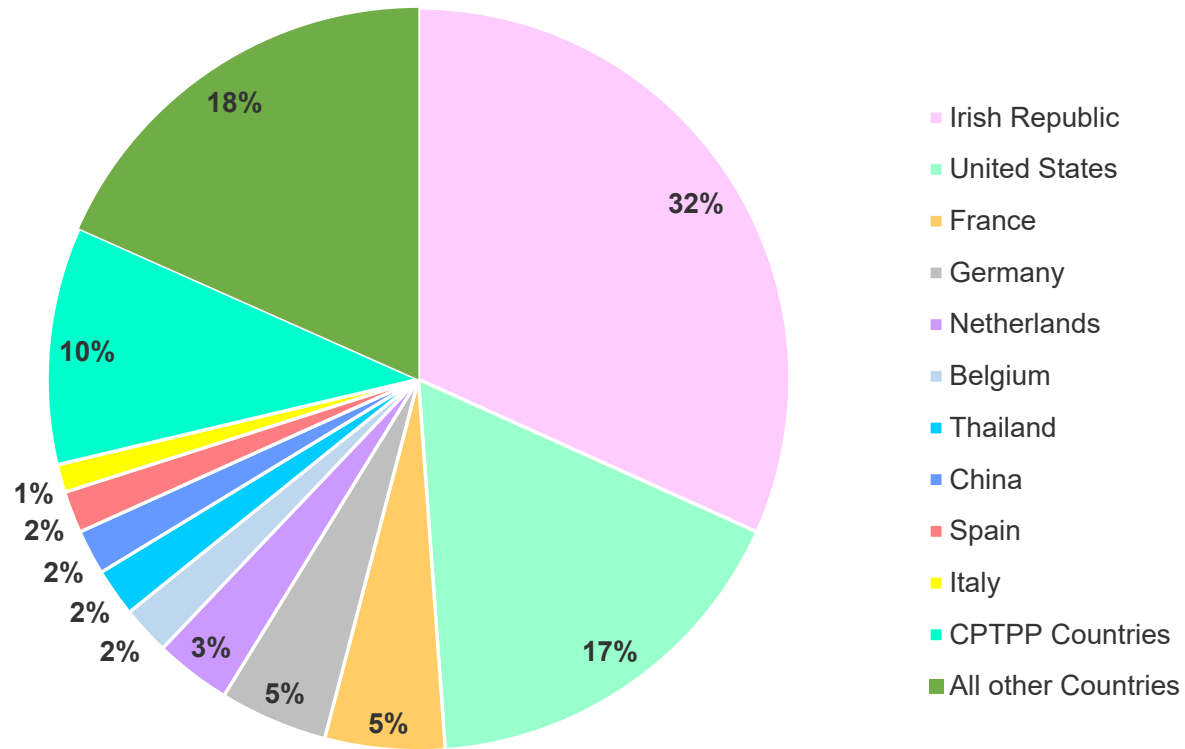

- The share of total NI RoW imports rose from 11.2% in 2015 to 12.2% in 2017.
- Total UK imports increased by 31% from 2015-2017.
- The share of total UK RoW imports increased from 12.3% in 2015 to 13.5% in 2017.
- In 2017 NI RoW imports from CPTPP countries were 12.2% which was the lowest importing region across the UK.

UK Trade in Goods with CPTPP Countries – Exports

Exports to CPTPP countries accounted for 10% of total NI exports in 2017

Northern Ireland Exports by origin in 2017



- Exports to CPTPP countries were £886m (10%) of total NI exports in 2017.
- 65% of exports went to 5 countries: RoI (32%), United States (17%), Canada (6%), France (5%) and Germany (5%).
- NI exports increased by 19% from £7,164m in 2015 to £8,553m in 2017.

Canada and Australia accounted for 69% of NI exports to CPTPP countries in 2017

- NI exports to CPTPP countries increased by 23% from 2015 to 2017.

- NI's exports to CPTPP countries increased by 23% from 2015-2017.
- The share of total NI exports increased from 10% in 2015 to 10.4% in 2017.
- Total UK exports increased by 28% from 2015-2017.
- The share of total UK exports increased from 7.1% in 2015 to 7.6% in 2016.
- In 2017 exports to CPTPP countries were more important to NI (10.4%) compared to Scotland (9%), England (7.8%) and Wales (6.4%).

The share of UK RoW exports to CPTPP countries increased from 13.8% in 2015 to 15% in 2017

- The share of total NI exports to CPTPP countries increased from 22% in 2015 to 23.7% in 2017.
- Total UK exports increased by 28% from 2015-2017.
- The share of total UK RoW exports increased from 13.8% in 2015 to 15% in 2017.
- In 2017 the share of NI RoW exports to CPTPP countries was 23.7%, which was the highest percentage across the UK compared to Scotland (17.5%), Wales (16.2%) and England (15.4%).

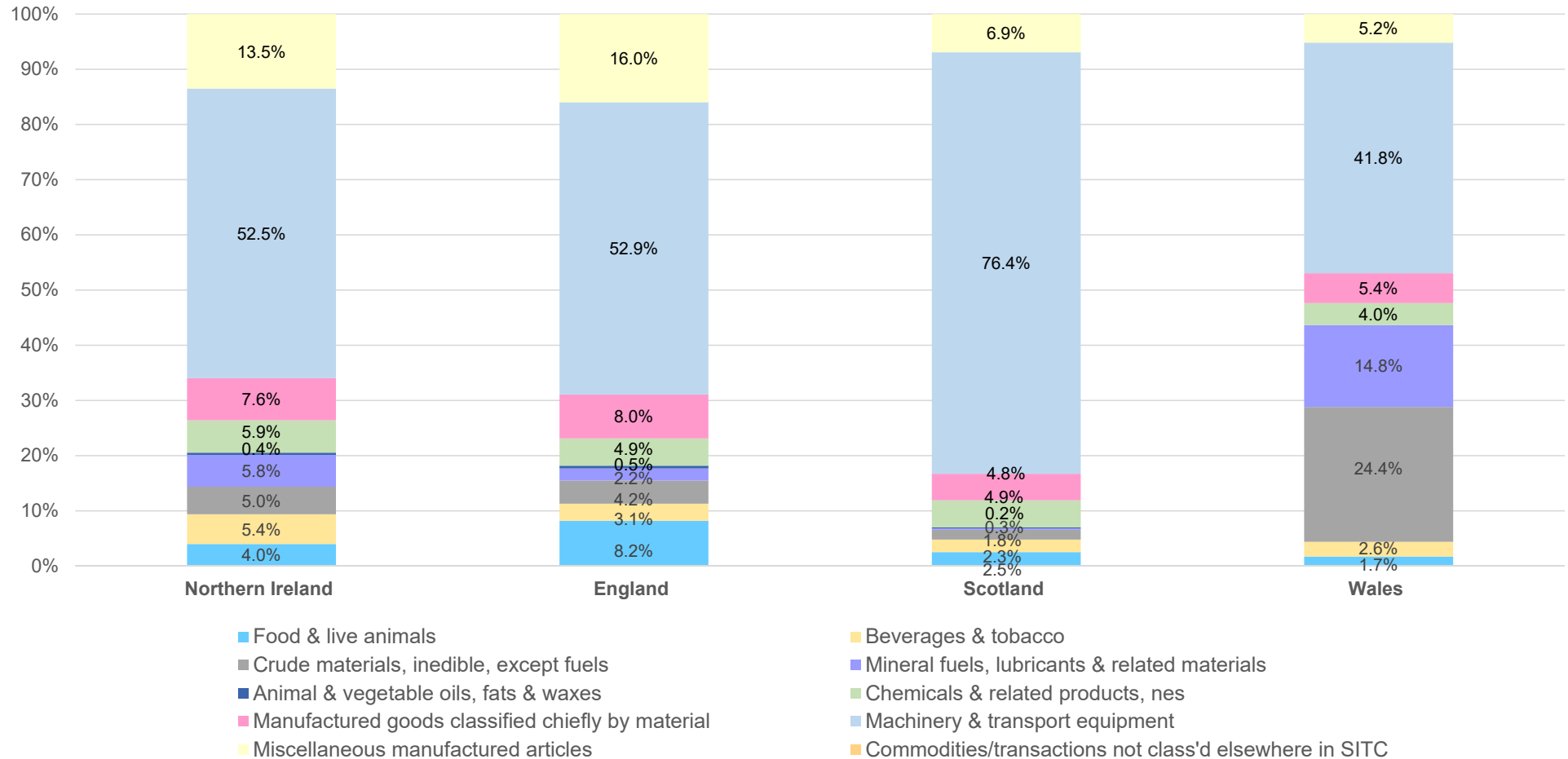

- There was strong growth within the mineral fuels, lubricants & related materials (+£17.8m) and in the machinery & transport sectors (+£11.4m) from 2015-2017.
- Miscellaneous manufactured articles was the only sector to experience a decline in imports from 2015-2017 (-£0.4m).

- Key sectors across all regions were machinery & transport, miscellaneous manufactured articles and manufactured goods.

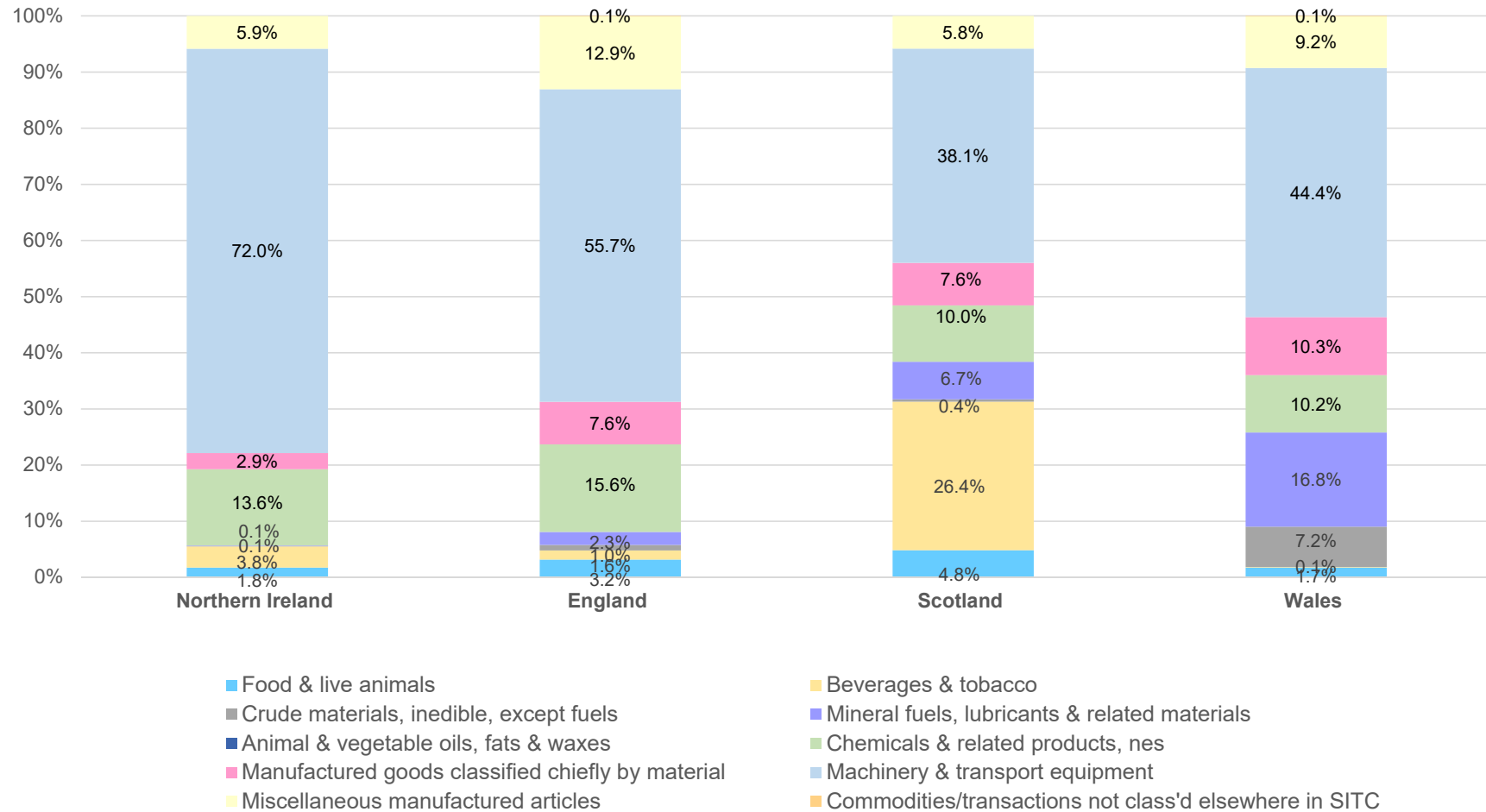

Total UK Export of Goods to CPTPP countries by SITC1 sector in 2017



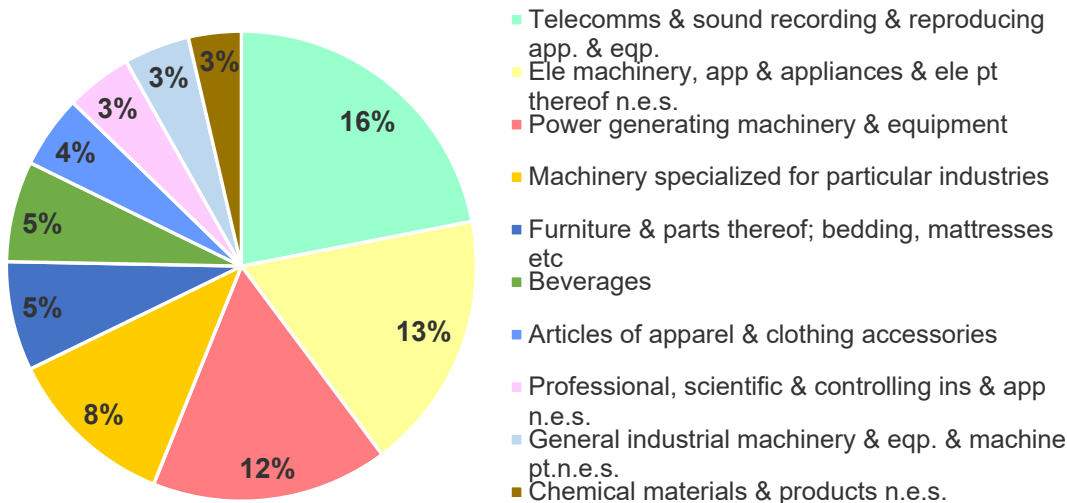
- Key sectors across all regions were machinery & transport and chemicals & related products.

Telecomms and electrical machinery & appliances sectors accounted for 29% of imports in 2015 and 31% in 2017

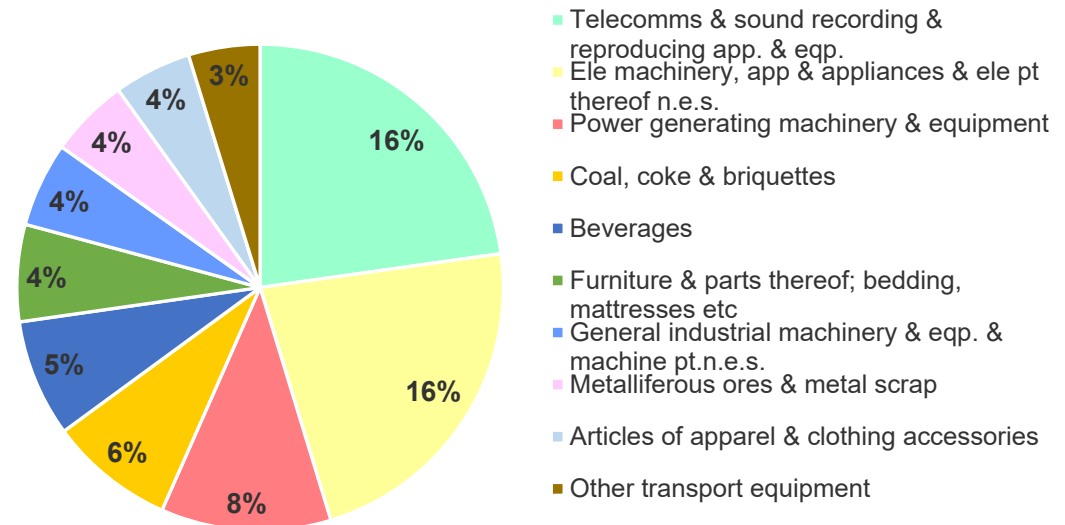
Top 10 NI Imports from CPTPP countries by sector – SITC2

Top 10 Imports: £222m

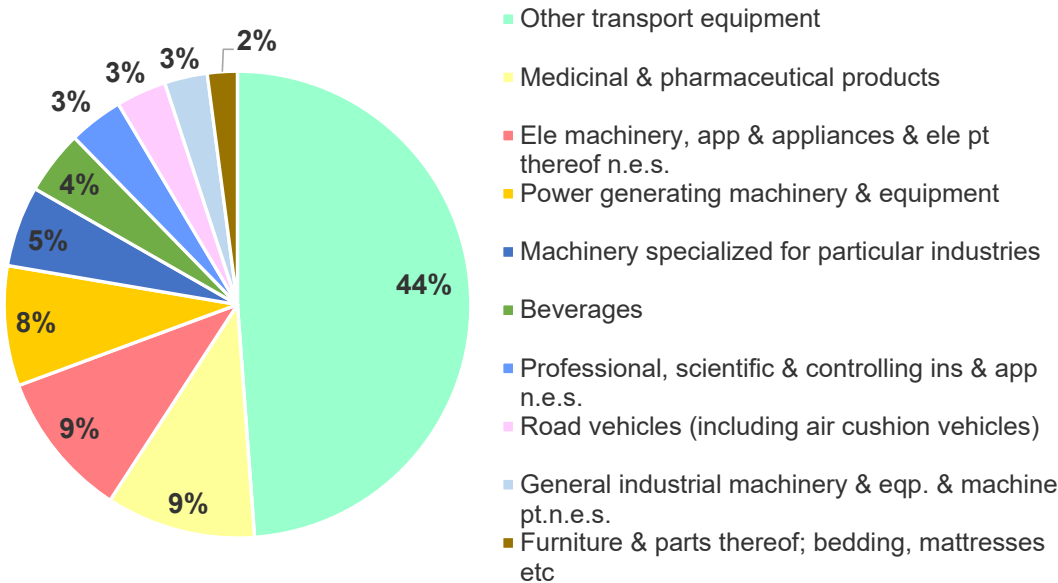
- Top 10 importing sectors (SITC2) accounted for 72% of imports in 2015 and 69% in 2017.

Other transport equipment and medicinal & pharmaceutical products accounted for 54% of exports in 2015 and 63% in 2017

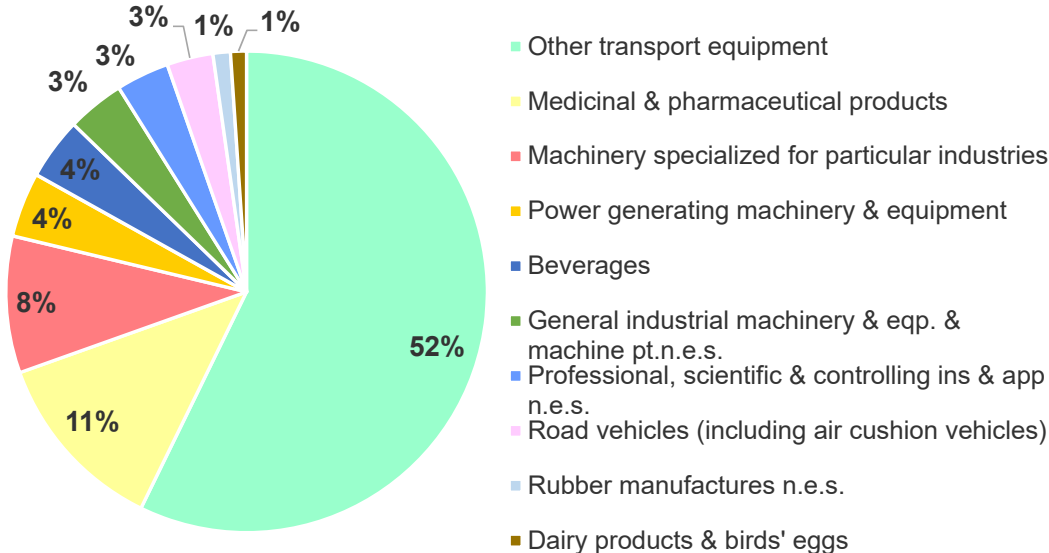
Top 10 NI Exports to CPTPP countries by sector – SITC2

- Top 3 sectors in 2015 were: other transport equipment (44%), medicinal & pharmaceutical products (9%) and electrical machinery & appliances (9%).
- Top 3 sectors in 2017 were: other transport equipment (52%), medicinal & pharmaceutical products (11%) and specialised machinery (8%).

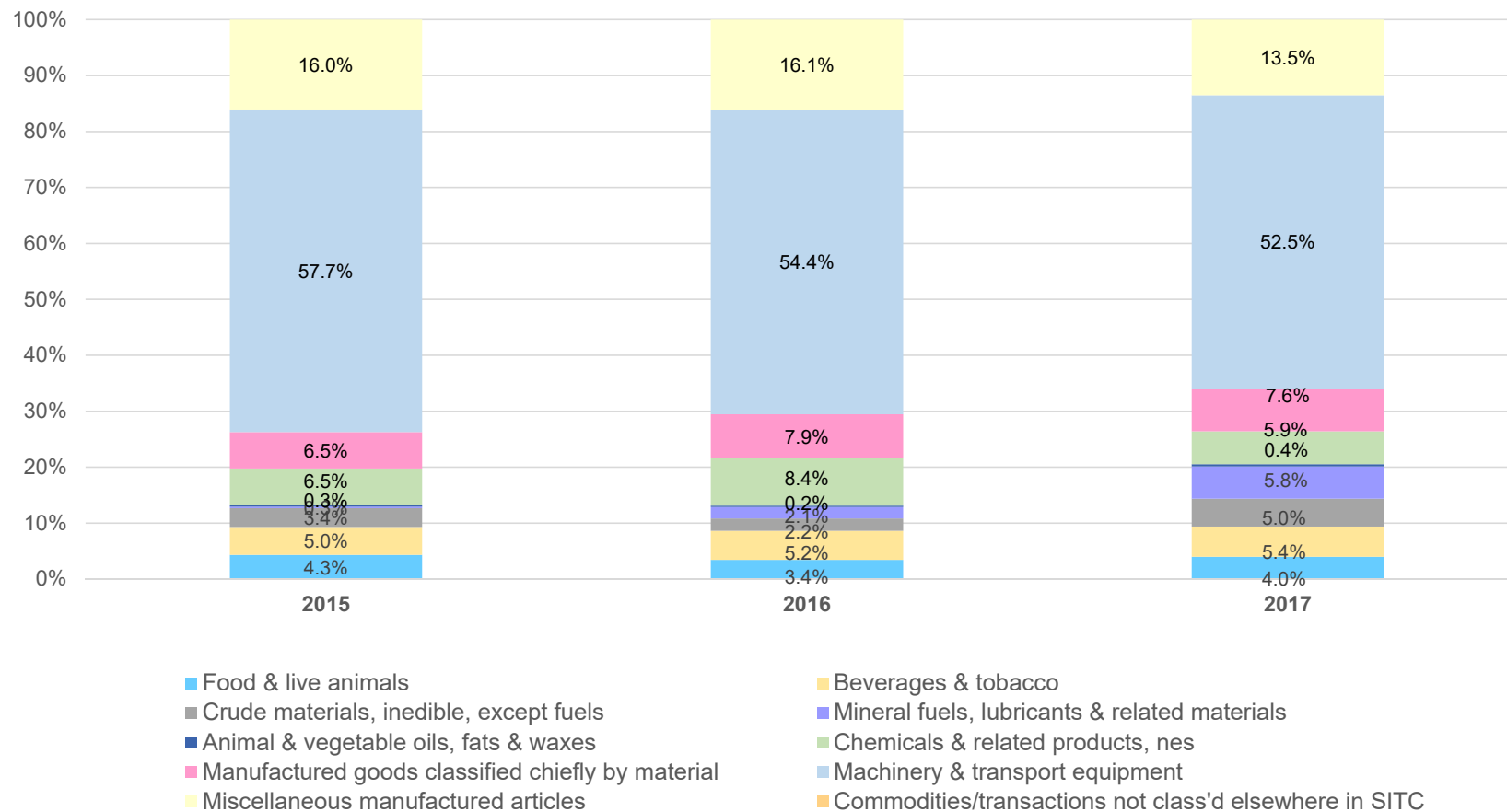

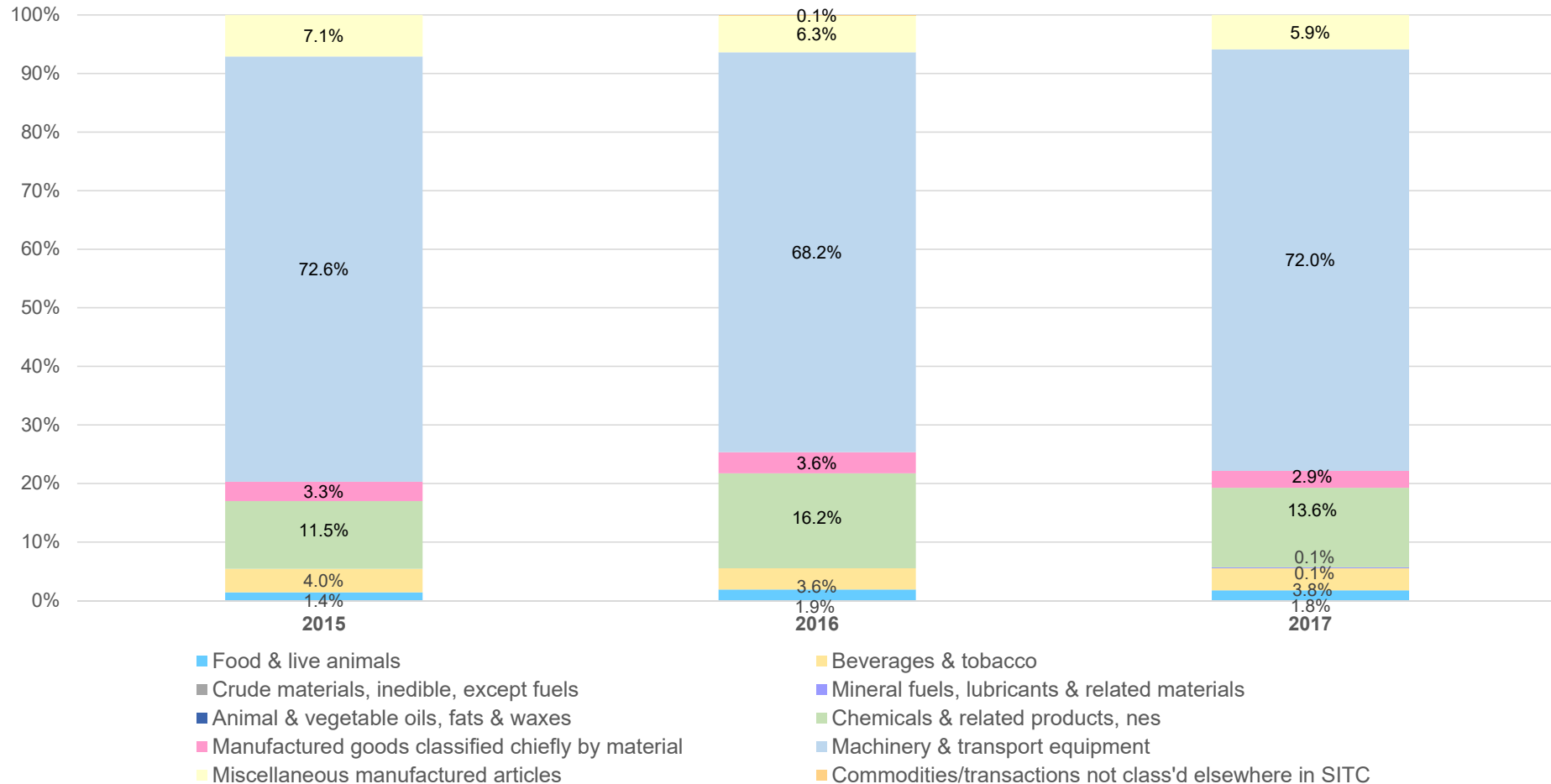

- From 2015-2017, NI import of goods from CPTPP countries increased by 18% which was the lowest increase of all the UK regions compared to Scotland (79%), Wales (33%) and England (27%).
- There was strong growth within the NI mineral fuels, lubricants & related materials (+£17.8m) and in the machinery & transport sectors (+£11.4m) from 2015-2017.

Machinery & transport and chemicals & related products provided 84% of NI exports in 2015 and 2016 and 86% in 2017

- NI export of goods to CPTPP countries increased by 23% from 2015-2017 which was the lowest increase of all the UK regions compared to Wales (35%), Scotland (32%) and England (27%).
- There was significant growth in the NI machinery & transport (+£116m) and chemicals & related products (+£37.4m) sectors from 2015-2017.
