

Mineral Prospecting Licence Applications MPLA1/19 and MPLA2/19

Consultation Overview

13 September 2021

(closing date for response 05 December 2021)

Purpose of Consultation

In accordance with the provisions of the Mineral Development Act (Northern Ireland) 1969, the Department for the Economy (the Department) has received two applications from Dalradian Gold Limited (the applicant), for Mineral Prospecting Licences (MPL). The Department has accepted the applications as valid.

The purpose of this document is to provide consultees with an overview of both applications and the consultation process for the applications. This consultation will run from 13 September 2021 for a period of 12 weeks, ending on 05 December 2021.

General Information

- The two applications are for areas previously licensed by the Department to the applicant. The previous licences ended on 31 December 2019 and were referenced DG1 and DG2.
- 2. The applicant already holds Crown Estates Options for both areas. Precious metals i.e. gold and silver are vested in the Crown and the applicant has continued, and intends to continue, gold exploration in both these areas under their Crown Estates Options.
- 3. While there are two separate MPLs applications under consideration, given that they involve the same applicant, are in adjacent geographical locations and are for similar activities, the Department has decided to combine the two consultations into one. Any issue raised in conjunction with either application that is not applicable to the other, will be considered as required.
- 4. The Department received these applications in July 2019. The delay to the consultation process was initially a result of a legal issue and more recently due to Covid-19 restrictions. Part of the consultation process requires hard copies of the documentation to be displayed in public buildings in the locality of the application area. The Department decided that the risk to public health was such that the consultation should be postponed until such times as the restrictions eased. It is now clear that risk from the display of the documentation can be managed within current Covid guidelines. Please note that as a result of the delay, the Department required the applicant to update both their application and their Company brief both versions of these documents are provided on the Department's website for information.

Consultation Process

The objective of this consultation is to ensure that the Department publises its' intention to grant the two MPLs and provide the general public with an opportunity to submit comments. This will help ensure that the Department receives a wide range of views and can take an informed decision on either the granting, or not, of the MPLs and/or on any additional terms and conditions that should be included in the MPLs.
