

Trade in Goods Data Analysis Northern Ireland – Israel (2018-2020)

This pack draws on publically available information collected by HMRC in relation to the Regional Trade Statistics for imports and exports from/to Israel for Northern Ireland (NI). This slide pack includes information and analysis on:

Background to Source Data

• HMRC Regional Trade Statistics have been the basis of the analysis. Data are downloaded from the HMRC website:

Regional Trade Data Table

- Data are presented for the calendar years 2018, 2019 and 2020.
- A proportion of the data from the HMRC database could not be attributed to any UK region. The data appears as 'unallocated' within the tables.
- The data are only available for goods. Trade in services is not included in this analysis.
- The data from companies who are not registered for VAT are not included in RTS.
- Figures may not add due to rounding.
- The data may be subject to quarterly revisions.

Summary of Key Messages

UK Trade in Goods with Israel – Imports

- Total NI imports in 2020 were £6.9bn. Imports from Israel were £16m which was 0.2% of total NI imports. Israel is the 35th largest country for NI imports.
- Ni's imports from Israel increased from £11m in 2018 to £16m in 2019 (+43%). Imports remained at £16m in 2020.
- Across the UK, total imports from Israel increased from £1,114m in 2018 to £1,399m in 2020 (+26%). In 2020 Ni's, Scotland and Wales share of imports from Israel was 0.2% compared to 0.4% for England.

UK Trade in Goods with Israel – Exports

- Total NI exports were £7.9bn in 2020. Exports to Israel were £21m, which was 0.3% of total NI exports. Israel is 37th largest country for NI exports.
- Ni's exports to Israel decreased from £35m in 2018 to £29m in 2019 (-18%). Exports decreased further to £21m in 2020 (-27%). Overall, from 2018 to 2020 there was a 40% decrease in Ni's exports to Israel.
- Across all UK regions, total exports to Israel increased from £1,092m in 2018 to £1,579m in 2020 (+45%). In 2020 NI, Scotland and Wales share of exports to Israel was 0.3% compared to 0.6% for England.

Import Analysis by Sector - SITC1

- Miscellaneous manufactured articles, manufactured goods and machinery & transport accounted for 89% of NI imports in 2018, 93% in 2019 and 89% in 2020.
- Imports from Israel increased in England by 25%, NI by 43% and Scotland by 17% from 2018-2020. Imports to Wales decreased by 17% over this period.
- From 2018-2020, the sector which had the largest increase in imports for England (£239.1m), Scotland (£7.6m) and Wales (£2.9m) was machinery & transport equipment. For NI, miscellaneous manufactured articles increased by £5.9m over this period.

Export Analysis by Sector - SITC1

- Machinery & transport equipment was the largest exported good to Israel in 2020 across all UK regions, with the exception of Wales were almost 50% of exports are chemicals.
- From 2018-2020, exports from England to Israel increased by 65% while exports from Wales increased by 0.4%. In contrast, NI exports decreased by 40% and Scotland decreased by 15%.
- Across the UK, sectors which had the largest increase in exports from 2018-2020 were miscellaneous manufactured articles in England (£304.8m), food & live animals in NI (£342,000), manufactured goods in Scotland (£1.5m) and chemicals in Wales (£3.8m).

Import Analysis by Sector - SITC2


- The top 10 SITC2 sectors for NI provided 91% of total imports to Israel in 2020, which was higher than Wales (89%), Scotland (88%) and England (73%).
- In 2020, 68% of NI imports to Israel were provided by the top 5 SITC2 sectors Professional, scientific & controlling instruments & apparatus (28%), Non-Metallic mineral manufactures (15%), Electrical machinery, app & appliances & ele (10%), Textile yarn, fabrics, made up articles etc (8%) and Articles of apparel & clothing accessories (7%).
- Professional, scientific & controlling instruments & apparatus n.e.s was the largest SITC2 sector for NI accounting for 28% of imports in 2020. Imports from this sector increased from £0.4m in 2018 to £4.6m in 2020 (+1050%). It was the 2nd largest sector for England (9%), 2nd for Scotland (11%) and 9th for Wales (4%).
- Looking at the UK as a whole, the top 5 largest imports to Israel in 2020 were: Power generating machinery & equipment (£359.4m), Professional, scientific & controlling instruments & apparatus (£123.6m), Miscellaneous manufactured articles (£79.4m), Vegetables & fruit (£75.1m) and Non-metallic mineral manufactures (£64.8m).

Export Analysis by Sector – SITC2

- The top 10 SITC2 sectors for NI provided 93% of total exports to Israel in 2020, which was higher than Scotland (86%), Wales (83%) and England (76%).
- In 2020, 80% of NI exports to Israel were provided by the top 5 SITC2 sectors Medicinal & pharmaceutical products (27%), Machinery specialised for particular industries (22%), Power generating machinery & equipment (18%), General industrial machinery & equipment & machine (7%) and Beverages (6%).
- Medicinal & pharmaceutical products was the largest SITC2 sector for NI accounting for 27% of exports in 2020. It was the 4th largest sector for England (9%), 5th for Scotland (5%) and 2nd for Wales (18%).
- Across the UK, the top 5 largest export sectors to Israel in 2020 were: Power generating machinery & equipment (£288.8m), Articles of apparel & clothing accessories (£229.2m), Road vehicles (£123.6m), Medicinal & pharmaceutical products (£131.5m) and Footwear (£76.2m).

UK Trade in Goods with Israel - Imports

Imports from Israel were £16m in 2020 which was 0.2% of total NI Imports.



- Total NI imports in 2020 were £6.9bn. Imports from Israel were £16m which was 0.2% of total NI imports. Israel is the 35th largest country for NI imports.
- Ireland accounted for almost one-third (32%) of Ni's imports in 2020. This was followed by China (10%), Netherlands (9%), United States (8%) and Germany (6%). Collectively the top five countries made up 65% of Ni's imports (£4.5bn).

The share of total UK imports from Israel was 0.3% in 2020.



- Ni's imports from Israel increased from £11m in 2018 to £16m in 2019 (+43%). Imports remained at £16m in 2020.
- The share of total NI imports from Israel increased from 0.1% in 2018 to 0.2% in 2019/2020.
- Across all UK regions, total imports from Israel increased from £1,114m in 2018 to £1,399m in 2020 (+26%).
- In 2020 Ni's, Scotland and Wales share of imports from Israel was 0.2% compared to 0.4% for England.
- NI had 1.1% of UK imports from Israel in 2020, which was the lowest share amongst all UK regions. England accounted for 85.4%, followed by Scotland at 3.3% and Wales at 1.9%. The remaining 8.2% was unallocated.

UK Trade in Goods with Israel - Exports

Exports to Israel were £21m in 2020, which was 0.3% of total NI exports.





- Total NI exports were £7.9bn in 2020. Exports to Israel were £21m, which was 0.3% of total NI exports. Israel is 37th largest country for NI exports.
- Ireland accounted for 40% of NI's exports in 2020. This was followed by United States (12%), Canada (5%), Germany (4%) and the Netherlands (4%). Collectively the top five countries made up 65% of NI's exports (£5.1bn).

The share of total UK exports to Israel was 0.5% in 2020.

- Ni's exports to Israel decreased from £35m in 2018 to £29m in 2019 (-18%). Exports decreased further to £21m in 2020 (-27%). Overall, from 2018 to 2020 there was a 40% decrease in Ni's exports to Israel.
- The share of total NI exports to Israel decreased from 0.4% to 0.3% in 2019/2020.
- Across all UK regions, total exports to Israel increased from £1,092m in 2018 to £1,579m in 2020 (+45%).
- In 2020 NI, Scotland and Wales share of exports to Israel was 0.3% compared to 0.6% for England.
- NI had 1.3% of UK exports to Israel in 2020, which was the lowest share amongst all UK regions. England accounted for 85.6% followed by Scotland at 5.3% and Wales at 2.4%. The remaining 5.4% was unallocated.





- From 2018-2020, chemicals, manufactured goods, machinery & transport equipment and miscellaneous manufactured articles accounted for the vast majority of Nl's imports from Israel.
- Imports of manufactured goods accounted for approx. £15.2m (35%) of total imports from Israel from 2018-2020. This was followed by miscellaneous manufactured articles at £12.8m (30%) and machinery & transport equipment at £11.0m (26%).
- Imports of miscellaneous manufactured articles increased by £5.9m from 2018 to 2020 (+454%). In contrast, manufactured goods fell by around £1.1m (-22%).

Key sectors across all regions in 2020 were miscellaneous manufactured articles, machinery & transport equipment, manufactured goods and chemicals.





- Key sectors across all regions in 2020 were miscellaneous manufactured articles, machinery & transport equipment, manufactured goods and chemicals.
- Machinery & transport was an important sector for Scotland as it accounted for 65% of imports from Israel. It was also an important sector for both England (41%) and Wales (38%).
- The top 3 importing sectors for NI were miscellaneous manufactured articles (45%), manufactured goods (24%) and machinery & transport (19%).

NI import of goods from Israel increased by 43% from 2018-2020.

- Imports from Israel increased in England by 25%, NI by 43% and Scotland by 17% from 2018-2020. Imports to Wales decreased by 17% over this period.
- The sector which had the largest increase in imports for England (£239.1m), Scotland (£7.6m) and Wales (£2.9m) was machinery & transport equipment from 2018-2020. For NI, miscellaneous manufactured articles increased by £5.9m over this period.
- Manufactured goods had the largest decrease in England (-£96.4m), NI (-£1.1m) and Wales (-£10.6m) while Miscellaneous manufactured articles fell by -£1.3m in Scotland over the period.

Export Analysis by Sector (SITC1)

Machinery & transport and chemicals sectors accounted for 88% of NI exports in 2018, 85% in 2019 and 85% in 2020.



- Machinery and transport equipment and chemicals accounted for the majority of NI exports to Israel from 2018-2020.
- From 2018-2020, exports of machinery & transport equipment accounted for approx. £44.9m (53%) of total exports to Israel, followed by chemicals at £28.6m (34%) and miscellaneous manufactured articles at £5.5m (6%).
- Exports of machinery & transport equipment decreased by £6.7m from 2018-2020 (-36%), while chemicals fell by £6.1m (-50%). In contrast, exports of food & live animals increased by £342,000 (261%).

Machinery & transport and chemicals provided 85% of NI exports to Israel in 2020.

Total UK Export of Goods to Israel by SITC1 sector in 2020



- Machinery & transport equipment was the largest exported good to Israel in 2020 across all UK regions, with the exception of Wales where almost 50% of exports are chemicals. Beverages & tobacco is an important sector for Scotland as it accounted for 29% of exports in 2020.
- The top importing sectors for NI in 2020 were machinery & transport (56%) and chemicals (29%).

NI export of goods to Israel decreased by 40% from 2018-2020.

- From 2018-2020, exports from England to Israel increased by 65% while exports from Wales increased by 0.4%. In contrast, NI exports decreased by 40% and Scotland decreased by 15%.
- Across the UK, sectors which had the largest increase in exports from 2018-2020 were miscellaneous manufactured articles in England (£304.8m), food & live animals in NI (£342,000), manufactured goods in Scotland (£1.5m) and chemicals in Wales (£3.8m).
- Machinery & transport sector had the largest decline in exports from 2018-2020 in NI (-£6.7m), Scotland (-£9.6m) and Wales (-£2.3m), while beverages & tobacco fell by £6.9m in England.

Import Analysis by Sector (SITC2)

Professional, scientific & controlling instruments & apparatus accounted for 3% of NI imports in 2018, 22% in 2019 and 28% in 2020. Top 10 SITC2 Sectors for NI Imports from Israel (2018-2020) (£m)

- The top 10 SITC2 sectors for NI provided 91% of total imports from Israel in 2018, 94% in 2019 and 91% in 2020.
- Non-metallic mineral manufactures, electrical machinery, app & appliances and professional, scientific & controlling instruments & apparatus were all in the top 5 sectors for 2018-20.
- Professional, scientific & controlling instruments & apparatus was the largest SITC2 sector for NI accounting for 28% of imports in 2020. Imports from this sector increased from £0.4m in 2018 to £4.6m in 2020 (+1050%). The second largest SITC2 sector for NI was non-metallic mineral manufactures (15%) followed by electrical machinery, app & appliances (10%).
- Over the period 2018-2020 non-metallic mineral manufactures accounted for the largest value sector (£11.5m), followed by professional, scientific & controlling instruments and appliances (£8.5m) and electrical machinery, app & appliances (£7.9m).

Power generating machinery & equipment was the top SITC2 sector for both England and Scotland in 2020, however it did not feature within NI's top 10 sectors.

Import Analysis by Sector – SITC2

- The top 10 SITC2 sectors for NI provided 91% of total imports to Israel in 2020, which was higher than Wales (89%), Scotland (88%) and England (73%).
- In 2020, 68% of NI imports to Israel were provided by the top 5 SITC2 sectors Professional, scientific & controlling instruments & apparatus (28%), Non-Metallic mineral manufactures (15%), Electrical machinery, app & appliances & ele (10%), Textile yarn, fabrics, made up articles etc (8%) and Articles of apparel & clothing accessories (7%).
- Professional, scientific & controlling instruments & apparatus n.e.s was the largest SITC2 sector for NI accounting for 28% of imports in 2020. It
 was the 2nd largest sector for England (9%), 2nd for Scotland (11%) and 9th for Wales (4%). Other sectors which featured within the top 10
 sectors across all UK regions included: Electrical machinery, app & appliances, Miscellaneous manufactured articles and Essential oils &
 perfume materials; toilet preps etc.
- Articles of apparel & clothing accessories accounted for £1.2m (7%) of NI's imports to Israel in 2020. This sector did not feature within the top 10 sectors for England, Scotland and Wales.
- Power generating machinery & equipment featured within the top 10 sectors for England, Scotland and Wales, however did not fall within NI's top 10 sectors.
- Looking at the UK as a whole, the top 5 largest imports from Israel in 2020 were: Power generating machinery & equipment (£359.4m), Professional, scientific & controlling instruments & apparatus (£123.6m), Miscellaneous manufactured articles (£79.4m), Vegetables & fruit (£75.1m) and Non-metallic mineral manufactures (£64.8m). Professional, scientific & controlling instruments & apparatus, Miscellaneous manufactured articles and Non-metallic mineral manufactures are the only 3 sectors that feature within NI.

Export Analysis by Sector (SITC2)

Medicinal & pharmaceutical products accounted for 32% of NI exports in 2018, 35% in 2019 and 27% in 2020.

- The top 10 SITC2 sectors for NI provided 91% of total exports to Israel in 2018, 94% in 2019 and 93% in 2020.
- Medicinal & pharmaceutical products, power generating machinery & equipment, specialised machinery and general industrial machinery were the top 4 sectors for 2018-20. Medicinal & pharmaceutical products was the top sector accounting for 32% of NI exports in 2018, 35% in 2019 and 27% in 2020.
- Over the period 2018-2020 medicinal & pharmaceutical products accounted for the largest value sector (£26.8m), followed by power generating machinery & equipment (£13.3m) and specialised machinery (£12.4m).

Export Analysis by Sector – SITC2

- The top 10 SITC2 sectors for NI provided 93% of total exports to Israel in 2020, which was higher than Scotland (86%), Wales (83%) and England (76%).
- In 2020, 80% of NI exports to Israel were provided by the top 5 SITC2 sectors Medicinal & pharmaceutical products (27%), Machinery specialised for particular industries (22%), Power generating machinery & equipment (18%), General industrial machinery & equipment & machine (7%) and Beverages (6%).
- Medicinal & pharmaceutical products was the largest SITC2 sector for NI accounting for 27% of exports in 2020. It was the 4th largest sector for England (9%), 5th for Scotland (5%) and 2nd for Wales (18%). Other sectors which featured within the top 10 sectors across all UK regions included: Professional, scientific & controlling instruments & apparatus and Machinery specialised for particular industries.
- Dairy products & birds' eggs (2%) and Other transport equipment (5%) accounted for £1.5m of Nl's exports to Israel in 2020. These sectors did not feature within the top 10 sectors for England, Scotland and Wales.
- Electrical machinery, app & appliances featured within the top 10 sectors for England, Scotland and Wales, however they did not fall within NI's top 10 sectors.
- Across the UK, the top 5 largest export sectors to Israel in 2020 were: Power generating machinery & equipment (£288.8m), Articles of apparel & clothing accessories (£229.2m), Medicinal & pharmaceutical products (£131.5m), Road vehicles (£123.6m) and Footwear (£76.2m). Power generating machinery & equipment and Medicinal & pharmaceutical products are the only 2 sectors that feature in the NI top 10.
