# Introduction

# What is Community Care?

**Community care** describes the wide range of services and support which enable individuals to live in their own home or in community settings.

It is designed to maintain and promote the independence and well-being of disabled and older people, and has as its overriding objective, the aim to enable people to live as full a life as possible, in whatever setting best suits their needs.

Community care services should respond flexibly and sensitively to the needs of individuals as well as the relatives and friends who care for them. Wherever practicable it should offer users a range of options and intervene no more than is necessary to foster independence.

In the future, many factors, including a growing and ageing population will cause an increase in demand on community care services, particularly the elderly.

# What is included in this publication?

This is the annual publication of **Statistics on Community Care for Adults in Northern Ireland**. It details analyses on a range of community activity gathered from HSC Trusts including:

- Contacts with HSC Trusts (by persons in the Elderly Care, Learning Disability and Physical & Sensory Disability Programmes of Care)
- Care Packages in Effect (Residential and Nursing)
- Meals on Wheels Services
- Residential and Nursing Accommodation
- Day Care Registrations.

# What are the main findings?

# 1. Contacts with HSC Trusts

# **Key Findings**

- Between 1 April 2017 and 31 March 2018, 29,228\* persons in the Elderly Care, Learning Disability and Physical & Sensory Disability POC's were in contact with HSC Trusts in Northern Ireland.
- Over a third of the 29,228\* contacts with HSC Trusts were by persons in the Elderly Care POC (36%), almost a third were by persons in the Physical & Sensory Disability (31%) POC and a third were by persons in the Learning Disability (33%) POC.
- Of those persons in contact with HSC Trusts whose age was known (29,223\*), 11,065 (38%) were aged 65 and over.

A **contact with an HSC Trust** refers to a face-to-face contact between a person or their carer(s) and a social worker or other member of statutory social services staff.


This contact can occur, for example, when a client attends a clinic or a domiciliary visit is made to see the client. The result of any face-to-face contact may lead to the client receiving a service, such as meals on wheels, a care package or registration at a day care facility.

# (a) Overall Position

Between 1 April 2017 and 31 March 2018, 29,228\* persons in the Elderly Care, Learning Disability and Physical & Sensory Disability POC's were in contact with HSC Trusts in Northern Ireland.

Figure 1 below shows that the number of persons in contact with HSC Trusts (excluding mentally ill persons) has increased by 2% from the same period last year, and has increased by 3% since the same period four years ago\*.

# (b) Programme of Care (POC)

Over a third of the 29,228\* contacts with HSC Trusts were by persons in the Elderly Care POC (36%), almost a third were by persons in the Physical & Sensory Disability (31%) POC and almost a third were by persons in the Learning Disability (33%) POC, as shown in Figure 2 below.

Figure 2: Persons (excluding Mentally ill) in Contact with HSC Trusts during 2017/18, by Programme of Care\*^



# (c) Disability

Figure 3 below shows that the number of persons with a visual impairment in contact with HSC Trusts has increased by 623 (10%) over the past 5 years, while the number of persons with a physical disability\*# has decreased by 729 (10%) during the same period.



# (d) Age Group\*

Figure 4 below shows that of those persons whose age was known (29,223\*), almost one third (29%) in contact with HSC Trusts were aged 45-64.

However, considering the latest population figures published by NISRA<sup>3</sup>, Table 1 below shows that the proportion of people in contact with HSC Trusts was much greater in the '75 & Over' age group.

Figure 4 also shows that of those persons in contact with HSC Trusts whose age was known (29,223\*), 11,615 (40%) were aged 65 and over.

Using the latest population figures, one person in every twenty six aged 65 and over had contact with a HSC Trust.



# (e) HSC Trust\*

Between 1 April 2017 and 31 March 2018, the highest proportion (over one in four) of the 29,228\* persons in contact with HSC Trusts was in the Belfast HSC Trust\* while the lowest proportions (approximately one in six) were in the Northern and Southern HSC Trusts, as shown in Figure 5 below.

# 2. Care Packages in Effect <sup>4</sup>

# **Key Findings**

- At 30 June 2018, 11,781 residential and nursing home care packages were in effect in Northern Ireland, a decrease of <1% since 30 June 2017<sup>R</sup>.
- Of the 11,781 care packages in effect, over two thirds (70%) were nursing home care packages and under one third (30%) were residential care packages.
- Over four fifths (81%) of care packages were in effect in the Elderly Care POC.
- The vast majority (92%) of residential and nursing home care packages were provided by the private sector. The voluntary and statutory sectors provided much smaller proportions of residential and nursing home care packages (both 4%).

A care package is the form of care recommended through care management.

The term care management is used to describe the whole concept which embraces the key functions of assessing need; care-planning; and managing, co-ordinating and reviewing services. HSC Trusts carry out care management assessments to identify a person's needs and determine the best form of care to meet those needs i.e. a care package.

The services provided in each care package for each individual client differ in terms of intensity and length.

# (a) Overall Position

At 30 June 2018, 11,781 residential and nursing home care packages were in effect in Northern Ireland, a decrease of <1% since 30 June 2017<sup>R</sup>.

Figure 6 below shows that the total number of residential and nursing home care packages in effect in Northern Ireland was relatively constant from 30 June 2014 to 30 June 2018 (12,154 on average).

# (b) Care Type

At 30 June 2018, of the 11,781 care packages in effect, over two thirds (70%) were nursing home care packages and under one third (30%) were residential care packages.

Figure 7: Residential and Nursing Home Care Packages in Effect at 30 June 2018, by Care Type





# (c) Programme of Care (POC)

At 30 June 2018, of the 11,781 residential and nursing home care packages in effect in Northern Ireland, over four fifths (81%) were in the Elderly Care POC, as shown in Figure 8 below. This means that the majority of care packages were provided to persons aged 65 and over.

The proportion of residential and nursing home care packages in effect by POC has remained relatively constant from 30 June 2014 to 30 June 2018, with the vast majority of care packages in effect in the Elderly Care POC i.e. mainly persons aged 65 and over were receiving a care package.


At 30 June 2018, approximately one in nine (11%) care packages were in effect in the Learning Disability POC, one in twenty (5%) were in effect in the Mental Health POC and a small proportion (3%) were in effect in the Physical & Sensory Disability POC. Similar proportions have been observed in previous years.

### (d) Care Type & Programme of Care (POC)

Figure 9 overleaf, shows the extent to which there were fewer residential than nursing home care packages in effect in each POC.

Figure 9: Residential and Nursing Home Care Packages in Effect at 30 June 2018, by Care Type and Programme of Care



At 30 June 2018, there were more than twice as many nursing home care packages than residential care packages in effect for persons in the Elderly Care POC while there were more than seven times as many nursing home care packages than residential care packages in effect for persons in the Physical & Sensory Disability POC.


In both the Mental Health POC and the Learning Disability POC, over half of all care packages in effect were nursing home care packages (60% and 55% respectively).

### (e) Sector


Figure 10 below shows that over nine tenths (92%) of residential and nursing home care packages were provided by the private sector. The voluntary and statutory sectors provided much smaller proportions of residential and nursing home care packages (4% and 4% respectively).

Figure 10: Residential and Nursing Care Packages in Effect at 30 June 2018, by Sector




Since 30 June 2014, the number of residential care packages in the private sector has increased but those in the statutory and voluntary sectors have decreased. These trends can be seen in Figure 11 below.

During the same period, the number of nursing home care packages have decreased in both the private sector and voluntary sectors as shown in Figure 12 below.

At 30 June 2018, there were no nursing home care packages in effect in the statutory sector.



# (f) HSC Trust

At 30 June 2018, Belfast HSC Trust had the largest number of residential and nursing home care packages in effect (one in four) while Western HSC Trust had the lowest proportion (approximately one in six) in effect, as shown in Figure 13 below.

# 3. Meals on Wheels Services

# **Key Findings**

- At 31 March 2018, 1,575 persons were in receipt of meals on wheels services in Northern Ireland. This was 271 (15%) less than the number in receipt at the end of the previous year and 1,526 (49%) less than the number in receipt four years ago.
- Over nine in ten (92%) persons receiving a meals on wheels service were aged 65 and over. This was comprised of 12% aged 65 - 74, 28% aged 75 - 84 and 52% aged 85 & over \*

'Meals on wheels' are nutritional meals delivered to people who are unable to, or find it difficult to, prepare a meal for themselves. A range of meals are produced, taking into account people's cultural and religious requirements, personal preferences and dietary needs.

HSC Trusts carry out an assessment of clients' needs by visiting a clients' home. If it is agreed a client should receive a Meals on Wheels service, a simple 'service agreement' detailing which days meals will be delivered is provided to the client.

Some clients may be offered a frozen meal service. HSC Trusts often only deliver hot meals to clients every day if they cannot manage the frozen meals service. Clients may also be able to borrow equipment to reheat meals themselves.

# (a) Overall Position

At 31 March 2018, 1,575 persons were in receipt of meals on wheels services in Northern Ireland. This was 271 (15%) less than the number in receipt at the end of the previous year and 1,526 (49%) less than the number in receipt four years ago.

The decrease from 31 March 2014 may be due to a number of factors including clients availing of the increased choice of ready meals from supermarkets, an increase in the number of people being supported by family members and a growing number of cases where reablement<sup>5</sup> is offered.


# (b) Age Group\*

At 31 March 2018, over nine in ten (92%) persons receiving a meals on wheels service were aged 65 and over. This was comprised of 12% aged 65 - 74, 28% aged 75 - 84 and 52% aged 85 & over. (Figure 15).

Considering the latest population figures published by NISRA<sup>6</sup>, Table 2 below shows that the greatest population proportion receiving a meals on wheels service in Northern Ireland was the '85 and Over' age group at 2.2%.

# (c) Client Group\*7

Almost five sixths (1,301) of persons receiving a meals on wheels service did not have a material disablement.\*

Of the remaining (274) persons receiving a meals on wheels service, Figure 16 overleaf shows that 2% were mentally ill, 8% had a learning disability, 5% were visually impaired, 2% were hearing impaired and 84% had another physical disability.

Figure 16: Persons with a Material Disablement Receiving a Meals on Wheels Service at 31 March 2018, by Client Group\*



# (d) HSC Trust

At 31 March 2018, over half (54%) of all persons receiving a meals on wheels service were located in the Western HSC Trust, with no-one in the Southern HSC Trust in receipt of a meals on wheels service, as shown in Figure 17 below. The Southern HSC Trust meals service ceased prior to March 2016 however other variances may be due to different processes in place within HSC Trusts and the availability of services such as reablement.

It is of note, that while the Western HSC Trust had the highest proportion of persons receiving a meals on wheels service in Northern Ireland, the latest population figures published by NISRA<sup>8</sup> indicate that the Western HSC Trust had the lowest population in Northern Ireland for both all persons and those over 65. This is shown in Table 3 overleaf.

# 4. Residential & Nursing Accommodation<sup>R, 9</sup>

There is no category for 'dual registered nursing home' under current residential and nursing home legislation. The RQIA is leading on a process with historically recognised dual nursing homes to address this.

The nursing home providers will chose one of the following 3 options:


- discontinue their residential places and change these beds to nursing care;
- retain a temporary registration for named residents who are already accommodated in the home on the condition that these beds will eventually revert to nursing;
- register their residential care beds under a separate residential care home registration.

### This will result in:

- a substantial decrease in the number of nursing homes with residential beds,
- a rise in the overall number of independent residential care homes,
- in real term, a negligible change in the number of registered residential and nursing beds, as the process affects classification of the facility that houses the beds, rather than the type of bed they are,
- in time, the disappearance of the category 'dual registered nursing home'.

### Residential homes

Residential care takes place in either statutory, voluntary or private residential care homes. They are staffed 24 hours a day, providing board and general personal care to the residents. Such premises are provided for those who require ongoing care and supervision in the circumstances where nursing care would normally be inappropriate.

Defined in Article 10 of the Health and Personal Social Services (Quality, Improvement and Regulation) (Northern Ireland) Order 2003.


# Nursing care homes


Nursing home care takes place in nursing homes. They are residential facilities providing nursing care 24 hours per day.

Defined in Article 11 of the Health and Personal Social Services (Quality, Improvement and Regulation) (Northern Ireland) Order 2003.

# (a) Overall Position<sup>10</sup>

At 30 June 2018, there were 5,147° residential care beds available in Northern Ireland, of which 4,872 and 275 are located in residential and nursing homes facilities respectively. This represents a 2% decrease in the total number of residential beds compared to June 2017 (5,238). The greatest decrease in residential care beds was observed in the Western HSC Trust (-64, 10%).





In total, there were also 10,859° available nursing care beds in Northern Ireland. This represents a 1% increase compared to June 2017. The greatest increase, and proportional increase in nursing care beds was observed in the Belfast HSC Trust (+97, +5%).

# (b) Sector<sup>11</sup>

At 30 June 2018, there were twice as many nursing care beds available in Northern Ireland than residential places (10,859° compared to 5,147°).

4,872 of residential places available were in registered residential homes (excluding those in dual categorised nursing homes). Of these, over seven out of ten (77%) were in independent residential homes while almost one in four were in statutory residential homes (23%).

Of the 10,859 nursing care beds available in sole-purpose nursing homes (excluding dual categorised homes), almost all (99.8%) were in the independent sector, and only a small proportion (0.2%) were in the statutory sector.



# (c) HSC Trust<sup>12</sup>

At 30 June 2018, the Northern HSC Trust had the highest number of residential beds available while the Southern HSC Trust had the lowest.

The Northern HSC Trust had the highest number of nursing care beds available, while the Western HSC Trust had the lowest number. This is reflective of the latest HSC Trust populations for both all persons and those over 65<sup>12</sup>.



Since 30 June 2014, the Western HSC Trust has seen a reduction of 22% in the number of residential beds available, while the Northern HSC Trust has seen the greatest increase of 7%.

Since 30 June 2014, the South Eastern HSC Trust has seen an increase of 7% in the number of nursing care beds available, while Western HSC Trust has seen no change (0%). The only HSC Trust to experience a decrease (-3%) in the number of available nursing care beds over the last four years was Southern (Figure 20).



# (d) Programme of Care (POC)

Figure 21 below shows that over the last five years\*, there has been a higher number of average available places in residential accommodation for those persons aged 65 and over than for those persons who have a learning disability or a physical or sensory disability. Due to changes in recording practices for the Belfast HSCT figures for the Elderly Care POC, this Trust has been excluded from the below figures.

In 2011, recommendation 10 of 'Transforming Your Care (TYC): A Review of Health and Social Care in Northern Ireland' proposed a major reduction in residential accommodation for older people, over the next five years. Due to potential changes in recording practices for the Belfast HSCT for the Elderly Care POC, the below figure has been calculated on the basis of all registered residential accommodation recorded by RQIA, rather than on figures from the KEL1 return as in previous years. As the previous section shows, the majority of available residential places are provided to elderly persons.

'Transforming Your Care (TYC): A Review of Health and Social Care in Northern Ireland' was published in December 2011 and set out 99 proposals aimed at improving the quality and efficiency of Health and Social Care in Northern Ireland. One of these, recommendation 10, proposed a major reduction in residential accommodation for older people, over the next five years.

Figure 21 above shows that since TYC's publication over 5 years ago, the number of available residential beds has decreased by <1%.

The vision of Transforming Your Care includes that services will regard the home as the hub for care and as such, older people will be enabled to remain at home for as long as possible using services such as domiciliary care<sup>14</sup> and reablement.

# Day Care Registrations

Day care facilities offer a range of services for the elderly and disabled, whether living alone or with their family or carer, providing social stimulation for the individual and respite for their carers. Day care facilities consist of Adult Training Centres / Social Education Centres, Workshops and Day Centres. These centres provide a variety of services and facilities such as social and occupational training, and social and craft activities.

Day care services are designed to meet the assessed needs of individuals for care, support, supervision or rehabilitation by reason of mental illness, functional impairment, cognitive impairment, learning disability, ill-health, age, family or life circumstances.

Day care services are crucial to the support of carers and assist people in maintaining their quality of life within their own community.

# (a) Overall Position

At 31 March 2018, 6,961 persons were registered at statutory day care facilities in Northern Ireland. This was 212 (3%) less than the number registered at the end of the previous year and 664 (9%) less than the number registered four years ago.

# (b) Facility Type

At 31 March 2018, over two thirds (70%) of all registrations at statutory day care facilities were in Day Centres and almost one third (30%) were in Adult Training/Social Education Centres and Workshops.



Figure 24: Persons Registered at Statutory Day Care Facilities at 31 March 2018, by Programme of Care <sup>16</sup>





Figure 26 below shows that across almost all POC's, a higher proportion of persons were registered at statutory day centres than adult training/ social education centres and workshops. This was most notable in the Elderly Care POC where almost all persons (99.5%) were registered at day centres with only a small number (0.5%) registered at adult training/ social education centres and workshops. The Learning Disability POC was the only exception, where more persons (52%) were registered at adult training/ social education centres and workshops than day centres (48%).

Figure 25: Persons Registered at Statutory Day Care Facilities at 31 March 2018, by Facility Type and Programme of Care<sup>16</sup>





# Appendix 1: Programmes of Care

Programmes of Care (POC's) are divisions of health care, into which activity and finance data are assigned, so as to provide a common management framework. They are used to plan and monitor the health service, by allowing performance to be measured, targets set and services managed on a comparative basis.

In total, there are nine POC's, full definitions of which can be found on page 76. Information relating to five of these POC's is presented in this publication. Key points<sup>19</sup> on each of them are detailed below:

# Elderly (POC 4)

- Include all community contacts to those aged 65 and over except where the reason for the contact was because of mental illness or learning disability.
- Include all community contacts where the reason for the contact was dementia, regardless of the client's age. (However, Down's syndrome clients who develop dementia should remain in POC 6 for any dementia related care or treatment).
- Include all physical and/or sensory disabled clients aged 65 and over.
- Include all work relating to homes for the elderly, including those for the Elderly Mentally Infirm.

# **Learning Disability (POC 6)**

- Include all community contacts where the primary reason for the contact was learning disability, regardless of age.
- Include community contacts with Down's syndrome clients who develop dementia.

#### Mental Health (POC 5)

- Exclude all community contacts where the reason for the contact was dementia.
   (Dementia activity should be allocated to POC 4. However, Down's syndrome clients who develop dementia should remain in POC 6 for any dementia related care or treatment).
- Exclude all activity relating to residential accommodation for the Elderly Mentally Infirm. (This activity should be included in POC 4).

# Physical and Sensory Disability (POC 7)

• Include all community contacts where the primary reason for the contact was physical and/or sensory disability, except those aged 65 and over. (These contacts should be allocated to POC 4 upon reaching 65).

# **Primary Health and Adult Community (POC 9)**

 Include community clients aged between 16 and 64, for whom the primary reason for the contact is other than mental illness, learning disability, dementia or physical and sensory disablement should be allocated to POC 9 i.e. clients aged 16 to 64 with no material disablement.

The diagram below describes the age of clients in each of the Programmes of Care 4, 5, 6, 7 & 9. However, it must be noted that age alone is not the determining factor in allocating clients to a Programme of Care. Community contacts are allocated by the primary reason for the contact. If the reason is not due to mental illness, learning disability or physical and sensory disability the contact will be allocated by age; for example, POC 4 for the Elderly.

Full definitions of all nine POC's are listed below:

# **Acute Services (POC 1)**

Includes all activity, and resources used, by any health professional, relating to an inpatient episode where the consultant in charge of the patient is a specialist in an acute specialty. It also includes all activity, and resources used, by a hospital consultant in an acute specialty, in relation to an outpatient episode, day case, regular day admission, regular night admission or day care.

Acute specialties are all hospital specialties with the exception of the following (specialty codes in brackets); Geriatric Medicine (430), Obstetrics (501), Obstetrics Ante Natal (510), Obstetrics Post Natal (520), Well Babies Obstetric (540), Well Babies Paediatric (550), GP Maternity (610) and mental health specialties (710 to 715).

# Maternity & Child Health (POC 2)

Includes all activity, and resources used, by any health professional, relating to an inpatient episode where the consultant in charge of the patient is a specialist in one of the following specialties; Obstetrics (501), Obstetrics Ante Natal (510), Obstetrics Post Natal (520), Well Babies Obstetric (540), Well Babies Paediatric (550), and GP Maternity (610). It also includes all activity, and resources used, by a hospital consultant in one of the above specialties, in relation to an outpatient episode, day case, regular day admission, regular night admission or day care.

In addition, this programme includes all community contacts by any health professional where the primary reason for the contact was maternity or child health reasons. All community contacts to children under 16 are included as long as the contact was not in relation to mental health, learning disability or physical and sensory disability.

#### Family & Child Care (POC 3)

This programme covers activity and resources relating to the provision of social services support for families and/or children. This includes Children in Care; Child Protection; Child Abuse; Adoption; Fostering; Day Care; Women's Hostels/Shelters and Family Centres. This is not a definitive list of the type of support which may be offered under this programme. This programme includes community contacts by any health professional where the primary reason for the contact is because of family or child care issues.

# **Elderly Care (POC 4)**

This programme covers all activity, and resources used, by any health professional, including all community contacts with those aged 65 and over except where the reason for the contact was because of mental illness or learning disability. All community contacts where the reason for the contact was dementia should also be included, regardless of the patient's age. However, Down's Syndrome patients who develop dementia should remain in the Learning Disability Programme of Care for any dementia related care or treatment. All physically and/or sensory disabled patients aged 65 and over should be included as well as all work relating to homes for the elderly, including those for the Elderly Mentally Infirm. Age alone is not the determining factor in allocating patients and clients to the Elderly Care Programme of Care - community contacts are allocated by the primary reason for the contact which could result in a person aged 65 or over being allocated to the Mental Health Programme of Care if the reason for the contact was because of mental illness.

#### Mental Health (POC 5)

This programme covers all activity, and resources used, by any health professional, including all community contacts where the primary reason for the contact was due to mental health. If the reason for contact is that the patient has dementia, the activity should be allocated to the Elderly Care Programme of Care. However, Down's Syndrome patients who develop dementia should remain in the Learning Disability Programme of Care. All work and resources relating to residential accommodation for the Elderly Mentally Infirm should be excluded. This is included in the Elderly Care programme.

# **Learning Disability (POC 6)**

This programme covers all activity, and resources used, by any health professional, including all community contacts where the primary reason for the contact was learning disability, regardless of age. All community contacts with Down's Syndrome patients who develop dementia, for any dementia related care or treatment should be included. All contacts in learning disability homes and units should also be included.

#### Physical & Sensory Disability (POC 7)

This programme includes all community contacts by any health professional where the primary reason for the contact is physical and/or sensory disability. All patients and clients aged 65 and over are excluded. These contacts should be allocated to the Elderly Care programme.

# **Health Promotion & Disease Prevention (POC 8)**

This programme includes all community and GP based activity relating to health promotion and disease prevention. This includes all screening, well women/men clinics, child health surveillance, school health clinics, family planning clinics, health education and promotion clinics, vaccination and immunisation and community dental screening and prevention work.

#### **Primary Health & Adult Community (POC 9)**

This programme includes all work, except screening, carried out by General Medical Practitioners, General Dental Practitioners, General Ophthalmic Practitioners and Pharmacists. It includes contacts by any health professional with community patients aged between 16 and 64, for whom the primary reason for the contact is other than mental illness, learning disability or physical and sensory disability.

It is important to note however that only five Programmes of Care are considered in this publication. They are as follows:

- Elderly Care (POC 4)
- Mental Health (POC 5)
- Learning Disability (POC 6)
- Physical & Sensory Disability (POC 7)
- Primary Health & Adult Community (POC 9)

# Appendix 2: Definitions of Terms

# **Average Available and Occupied Places**

Average availability and occupancy should be calculated by HSC Trusts from data collected on a daily basis. However, when this is not possible averages are calculated using weekly or monthly data and dividing by 52 or 12 respectively.

# **Care Package**

A care package is a combination of services designed to meet a person's assessed needs i.e. the form of care recommended through care management, which includes the functions of assessing need, care planning, co-ordinating and reviewing services.

#### Residential Care

This refers to care which takes place in residential homes as defined in Article 10 of the Health and Personal Social Services (Quality, Improvement and Regulation) (Northern Ireland) Order 2003<sup>20</sup>. They are staffed 24 hours a day, providing board and general personal care to the residents. Such premises are provided for vulnerable persons (e.g. children, the elderly, the physically disabled and those mentally ill or with a learning disability) who require ongoing care and supervision in the circumstances where nursing care would normally be inappropriate.

# Nursing Home Care

This refers to care which takes place in nursing homes as defined in Article 11 of the Health and Personal Social Services (Quality, Improvement and Regulation) (Northern Ireland) Order 2003<sup>20</sup>. They are residential facilities staffed by nurses 24 hours per day, which provide services for clients/ patients requiring residential nursing care. Medical care continues to be the responsibility of the client/ patient's GP.

# **Client Groups**

Client groups are categories into which persons are classed dependent on their disability / impairment.

#### Elderly

Refers to persons who are aged 65 years or more and who are not included in any of the other client groups.

# • Designated Mentally III

Refers to persons who in the professional opinion of a doctor - GP or Psychiatrist - are suffering from a mental or psychiatric illness. Mental illness means a state of mind which affects a person's thinking, perceiving, emotion or judgement to the extent that he/ she requires care or medical treatment in his/ her own interests or in the interests of other people.

#### Learning Disabled

Refers to persons who have a state of arrested or incomplete development of mind which includes significant impairment of intelligence and social functioning. To be included in this group a person must be on the Trust's register of learning disabled people.

#### Physically Disabled / Sensory Impaired

Refers to persons who are substantially and permanently disabled by illness, or otherwise, including the chronically sick. This group will include the following groups: blind, partially sighted, deaf with speech, deaf without speech, hard of hearing and general classes (i.e. those whose primary disablement is neither visual nor auditory).

#### Blind and Partially Sighted

Refers to persons who are either registered or registerable as blind or partially sighted.

#### Without Material Disablement

Refers to those persons, without a physical or mental impairment or learning disability, who have not been included in other client groups.

# **Contact**

A contact which is made by a social worker with a person or their carer(s). The contact occurs when the patient/ client or their carer(s) attends a clinic or a domiciliary visit is made to see the patient/ client. The data in the tables refer to the number of people who had at least one face-to-face contact during the year and not the actual number of contacts made.

#### **Day Care Facilities**

#### Adult Training/ Social Education Centres

These are establishments mainly for people over 16 years of age with a disability in which social and occupational training is provided with the objective of preparing those, who have the ability, to progress into workshops.

# Workshops

This is where industrial therapy and contract work is undertaken, aimed at preparing those who are suitable for placement in open or sheltered employment in the community.

#### Day Centres

These are centres which have a full time organiser and where professional staff are employed. They are open five or more days each week and provide a variety of activities for members and facilities for meals.

#### In the Community

This refers to the client's own home, the home in which the client lives, for example that of a parent/ relative, and sheltered dwellings.

#### **Homes**

# Statutory sector homes

Statutory sector homes are those operated by community based Health and Social Care Trusts and are provided by virtue of Article 10 of the Health and Personal Social Services (Quality, Improvement and Regulation) (Northern Ireland) Order 2003 <sup>21</sup>.

# Voluntary sector homes

Voluntary sector homes are those which are operated by voluntary organisations i.e. organisations that are not for profit and non-governmental, and are registered as either residential or nursing homes in accordance with the Health and Personal Social Services (Quality, Improvement and Regulation) (Northern Ireland) Order 2003 <sup>26</sup>.

#### Private sector homes

Private sector homes are those operated by profit making organisations which are not a part of government, established by statute or royal charter, or under a substantial degree of executive control by government, and which are registered as a home for persons in need in accordance with the Health and Personal Social Services (Quality, Improvement and Regulation) (NI) Order 2003<sup>21</sup>.

#### Dual Registered

Refers to homes registered to provide both residential and nursing care.

#### Hospital

This refers to any type of hospital.

# Meals on Wheels

'Meals on wheels' are hot, nutritional meals delivered to people who are unable to, or find it difficult to, prepare a meal for themselves. A range of meals are produced, taking into account people's cultural and religious requirements, personal preferences and dietary needs.

#### Reablement

Reablement is a service which aims to help people learn or relearn the skills necessary for daily living which may have been lost through deterioration and/ or increased support needs. It is designed to help people "do things for themselves" rather than "having things done for them". Reablement is time limited, outcome focused, intensive and dynamic. It also helps to build confidence and independence and works towards positive change.

# **Appendix 3: Technical Notes**

All information in this publication refers to the period 1st April 2017 - 31st March 2018 or position at 31st March 2018 unless stated otherwise.

#### **Data Sources**

The majority of information presented in this publication derives from a number of annual Korner Aggregate Returns (KARs) provided by each of the five Health and Social Care Trusts in Northern Ireland to Community Information Branch in the Department of Health, Social Services & Public Safety.

The KARs are aggregated statistical counts, which were introduced from 1 April 1988, and relate to a range of community activity including contacts, meals on wheels, residential homes and day care.

The following annual Korner Aggregate Returns (KARs) are used:

Tables 2.15 & 2.16 present data provided by the Regulation and Quality Improvement Authority (RQIA) and Table 2.19 presents data provided by Human Resource, Payroll, Travel & Subsistence (HRPTS) system.

#### **Data Quality**

Any information published is fully quality assured. HSC Trust service area and information staff liaise to validate their information returns prior to submission. On receipt of returns, statisticians in Community Information Branch (CIB) conduct internal consistency checks using historical data to monitor annual variations and/ or emerging trends, both regionally and for specific HSC Trusts. Queries arising from validation checks are raised with HSC Trusts for clarification and if required returns may be amended and re-submitted. The HSC Trusts are also asked to provide appropriate explanations for any inconsistent or missing information.

Belfast Trust HSC reviewed recording practices across older persons' services. Due to staff resource issues it was not possible for them to conclude ongoing work on activity definitions prior to the submission deadline, resulting in the use of an imputed figure, based on previous years' data. Work is ongoing to resolve this issue ahead of the next reporting deadline.

Imputed figures are consistent with historical trends of Belfast HSC Trust, and demographic profile of the region.

#### **HSC Trusts**

This publication presents data broken down by HSC Trust. It is important to note that in a minority of cases the community service provided by the HSC Trust may have taken place in a hospital setting. When comparing data at HSC Trust level with earlier years it is important to note that due to a reorganisation of facilities within some HSC Trusts the comparison may not be on a like with like basis.

# **Programmes of Care (POC's)**

Programmes of Care (POC's) are divisions of health care, into which activity and finance data are assigned, so as to provide a common management framework. They are used to plan and monitor the health service, by allowing performance to be measured, targets set and services managed on a comparative basis. In total, there are nine Programmes of Care which are detailed in Appendix 1.

This publication has been structured on a POC basis in order to facilitate analysis by individuals with an interest in specific POCs. The POCs considered are as follows:

- Elderly Care (POC 4)
- Mental Health (POC 5)
- Learning Disability (POC 6)
- Physical & Sensory Disability (POC 7)
- Primary Health & Adult Community (POC 9)

An 'Activity Trends' section has also been included in the publication, for those individuals requiring an overall view of activity in Northern Ireland. This section relates to All Programmes of Care, Elderly Care (POC 4), Mental Health (POC 5), Learning Disability (POC 6), Physical & Sensory Disability (POC 7) and No Material Disablement.

Please note, information regarding Acute Services (POC 1), Maternity & Child Health (POC 2), Family & Child Care (POC 3)<sup>22</sup> and Health Promotion & Disease Prevention (POC 8) has not been considered in this publication.

A number of tables in the 'All Programmes of Care' section are not replicated for individual POC sections, either because the activity contained in the table is not relevant to a particular POC or because it is not possible for the data to be broken down to individual POC level. Conversely, in some cases tables are presented for individual POCs which are relevant only within those POCs.

#### Sector

Where possible, this publication presents data broken down by sector i.e. statutory, voluntary and private. In such cases, the services are commissioned by HSC Trusts from the Independent (voluntary and private) sector.

Where information has been suppressed the method used is indicated in the publication.

The KMI1 information collection was discontinued in February 2014 having taken into account the views of HSC Trust staff and DoH policy. Therefore data on residential accommodation for mentally ill persons have not been included since.

The KMI2 information collection was discontinued in February 2014 having taken into account the views of HSC Trust staff and DoH policy. Therefore data on mentally ill persons in contact with HSC Trusts have not been included since.

The HSC Board in conjunction with the DoH and HSC Trusts are currently working towards finalising an information collection on Non-Inpatient Mental Health (NIMH) activity and another one on Non-Inpatient Psychological Therapy (NIPT) activity which will provide information on both new and review contacts with services.

Releases of this publication prior to 2008/09 included information on domiciliary care packages in effect. The DoH discontinued the collection of this information from 30 September 2007 and instead publish a comprehensive picture of all domiciliary care services provided in the community in the 'Domiciliary Care Services for Adults in Northern Ireland' publication.

No new data items were requested for this publication.


