

PROJECT STRATUM DISCRETE SUPERFAST RE-CONSULTATION - SUMMARY OF RESPONSES AND OUTCOMES

1. INTRODUCTION

This is the Department for the Economy (DfE) report of the summary of responses to, and outcomes of, the Project Stratum Discrete Superfast Re-consultation (DSR) exercise carried out between 1 July 2022 and 15 August 2022. The DSR consultation document can be found on the DfE website at [Project Stratum - discrete state aid public review](#).

This document summarises the outcomes of the consultation and provides an explanation of how the information submitted has been treated.

All responses to the DSR have been considered and, where appropriate, incorporated into the final map of the eligible Intervention Area, which can be seen at Annex A. Postcodes in which eligible premises are located and be found at Annex B, This summary report confirming details of the changes made to the eligible Intervention Area is published on the DfE's website.

2. BACKGROUND

Project Stratum is a broadband intervention scheme, managed by DfE and developed to improve connectivity for premises unable to access broadband services of at least 30 Megabits per second (Mbps). Public funding of £197m has been allocated to the project, which will deliver gigabit-capable (i.e. capable of speeds of 1,000 Mbps) broadband to approximately 85,000 eligible premises in predominantly rural areas of Northern Ireland. Funding of £150m was secured under the 2017 Confidence and Supply Agreement, with additional funding subsequently allocated by DfE, the Department of Agriculture, Environment and Rural Affairs (DAERA), and the UK Government's Department for Digital, Culture, Media & Sport (DCMS). The contract to deliver Project Stratum was awarded to Fibrus Networks Ltd. in November 2020.

DfE conducted an Open Market Review (OMR) between 19 June 2018 and 27 July 2018 to establish existing and planned (within the next three years) coverage of broadband infrastructure across Northern Ireland. This was followed by a public consultation between 3 December 2018 and 14 January 2019, during which further information was received. This

information, together with DfE's own data, was used to define the original intervention area for Project Stratum.

The DSR consultation document set out postcodes in which premises were identified as eligible, or were placed Under Review¹, following the previous public consultation. DfE recognised that, in line with the 2016 National Broadband Scheme for the UK (NBS 2016), a significant amount of time has passed since the original public consultation, and there may have been changes to providers' plans. The potential additional eligible intervention area was set out in the annexes to the DSR consultation document, to enable interested stakeholders (including the public, businesses, internet service providers and broadband infrastructure operators), to comment on the proposals. In particular, this provided an opportunity for broadband infrastructure operators to review DfE's mapping, to ensure they have no further information relevant to determining whether premises in an area are eligible.

The Department made the consultation available on its website, provided information for Local Councils to put on their websites, gave presentations to Local Council representatives, publicised this consultation on the NIBusinessInfo website, and publicised the consultation on the Department's social media channels.

3. RESPONSES AND OUTCOMES

Summary

Responses received included information from members of the public, Local Councils, infrastructure providers, and elected representatives. A total of 73 responses were received.

All responses were analysed to ascertain whether the information provided would allow premises to be considered as eligible for intervention under Project Stratum. It should be noted that being classified as eligible does not guarantee that premises will be included in the project.

Respondents were asked to provide the following information:

¹ A mechanism under NBS 2016 applied against areas where there was doubt about the nature of a network deployment or planned deployment, including uncertainty regarding the technology deployed, the timing of the deployment or confirmation in respect of adequate financing for the plans, and were subject to continued monitoring and verification of network operators' plans. In the event that these commercial plans fall away within the three-year period following the public consultation, the implementing body is entitled to include them within the project's intervention area and consider them eligible for intervention.

- Name
- The address of the property and postcode area for which the submission relates
- Contact landline telephone number (if available)
- E-mail address (if available).

To allow for further analysis, information was requested at premises level. This should have included at least a postal address, including the house number and postcode. The consultation also asked if a landline telephone number could be provided. Although not essential, the provision of this information allowed the Department to undertake further checks.

This consultation only considered postcodes classified as White or Under Review following the previous consultation. As noted in the previous consultation, all postcodes in Northern Ireland are considered to have basic broadband available, so this consultation related only to the availability of Next Generation Access (NGA) broadband².

Response Categories

Responses fell under several broad categories. These categories, and DfE's responses, are summarised below.

Category

Responses were provided claiming coverage of NGA services for premises on the Under Review list.

DfE Response

Where a response was received claiming NGA coverage for premises which were on the Under Review list within the consultation, the Department has retained these premises as Under Review as there was insufficient evidence provided in order to categorise the premises as Grey / Black. The Department continues to consider the potential eligibility of these premises under Project Stratum, along with eligibility for planned broadband intervention initiatives, including Project Gigabit.

² the objective of NBS 2016 is to provide access to NGA infrastructure capable of delivering speeds of at least 30 Mbps to as many homes and businesses as possible.

Premises which were on the Under Review list, but for which no response to the consultation was received which claimed an NGA service, or for which the Department had information to indicate that an NGA service could not be provided, have been reclassified as White, and are therefore eligible for intervention under Project Stratum.

Category

Requests for premises to be added to the list of eligible premises as they cannot get NGA services.

DfE Response

Under NBS 2016 State aid guidance, the re-consultation was conducted with regards to premises residing in White postcodes that had, not previously been considered for Project Stratum, or premises that had been categorised as Under Review. Only responses relating to such premises, and meeting the requirements of an NGA qualifying technology that meets the requirements of NBS 2016, could be considered under the DSR.

Category

Comments about limited publicity for the consultation.

DfE Response

The main focus of the consultation was with the broadband providers to establish if their plans for infrastructure improvements had changed since the previous telecoms consultation in 2019.

DfE publicised this DSR on its website, its social media platforms, presented information on the consultation to Local Council representatives, and provided information for Local Councils to use on their websites.

Category

Comments about the impact on some Internet Service Providers of Government funding for broadband interventions.

DfE Response

The aim of Project Stratum is to ensure that available Government funding is used within the contract to make NGA services available to as many eligible premises as possible, under State aid rules aligned with NBS 2016. To ensure that Project Stratum, and any future

Government funded interventions, are directed to eligible premises, DfE engages with broadband providers to assess NGA availability (where meeting the requirements of an NGA qualifying technology and with services provided greater than 30 Mbps download is the benchmark) and broadband providers' plans in line with State aid requirements. DfE encourages broadband providers to provide credible evidence of their current and planned coverage to ensure funding is not mis-directed.

Outcomes of Review

The number of White and Under Review premises and postcodes considered in the DSR was as follows:

Of the 8,730 premises that were Under Review within the consultation 2,396 have been retained as Under Review, 4,782 are no longer considered potentially eligible for intervention based on updated NGA supplier plans meeting the requirement of an NGA qualifying technology, and 1,566 have been reclassified as White, based on the information available following the consultation.

Of the 4,393 premises that had not previously been considered for Project Stratum, 830 were found to be able to access an NGA service, or are in suppliers' compliant NGA plans, while 3,563 have been categorised as White and are eligible for intervention under Project Stratum.

Therefore, the Department will categorise 5,129 premises as White, which are located across 2,861 postcodes.

4. UNDER REVIEW PREMISES

As part of the original OMR process, and in line with NBS 2016 State aid rules, where a claim was made that premises are supplied, or would be supplied within the measured period, with an NGA capable service, but there remained uncertainty on its technical

capability, the premises were classified as grey, but kept Under Review. This applied to a number of service providers.

The Department recognises that these service providers provide an important service to customers, many of whom reside in deeply rural areas; without these providers broadband services would be limited. However, the Department also wants to ensure that premises deemed eligible for public intervention benefit in as timely a manner as possible in the event that qualifying broadband services are not provided by commercial operators.

The Under Review process was underpinned by independent technical analysis and engagement with Building Digital UK (BDUK), as the National Competence Centre. The Under Review process is intended to ensure that claimed coverage by the service providers will actually be delivered to premises, to seek evidence in support of operators' plans to invest in their networks, and respond to needs to increase their capacity within their coverage areas. The assessment of these claims involves technical details about the network design and performance, as set out in technical guidance and the NGA Assessment template and examples, available at [2016 NBS Tech Guidelines](#).

The findings of the Under Review process were mixed and a number of clarifications were sought by the Department to further assess the information provided. The process outlined above was extended to take into consideration the coverage claims and commercial plans beyond the initial measured period, and at the same time determine whether there may result in re-categorisation of some premises from Under Review to White with regards to Project Stratum, and therefore be eligible for public intervention.

The DSR determined that the number of premises Under Review has reduced, due to updated broadband connectivity data and commercial rollout plans. Although unrelated to the DSR process itself, it should be noted that the Department encourages all service providers to consider providing their services through the open access network as a result of Project Stratum, and engagement is ongoing with those service providers and the Project Stratum contractor, Fibrus Networks Ltd., regarding the onboarding process for suppliers wishing to be a part of the open access network.

Taking into consideration the responses from the service providers to the DSR under Project Stratum, and ongoing engagement with suppliers as outlined above, the remaining

premises categorised as Under Review will continue to be held Under Review under Project Stratum.

5. NEXT STEPS

The finalised eligible Intervention Area has received BDUK's National Competence Centre (NCC) approval against the State aid framework.

5,129 premises have been identified as eligible for Project Stratum as a result of this DSR. However, for any of these premises to be built to, a change to the contract will need to be agreed between the Department and Fibrus Networks Ltd. The Department is carrying out a separate exercise aimed at maximising coverage under Project Stratum. Where delivery to specific premises becomes feasible, relevant information will be available via the [HyperfastNI website](#). Please note that, due to the availability of funding and/or capacity, it may not be possible to address all of the premises which have been identified as eligible following this Review.

6. WHAT TO DO IF YOUR PREMISES HAS NOT BEEN DEEMED ELIGIBLE FOR PROJECT STRATUM

Although the Department is not currently able to provide any additional subsidy that would allow us to intervene beyond the eligible intervention area, premises not currently included can still register interest with Fibrus Networks at [HyperfastNI website](#).

Furthermore, Fibrus Networks has developed a Self-Fund / Self-Build product whereby if a premises is within proximity of the network, but not included in Project Stratum, and there is a cost to connect them, a contribution from both Fibrus Networks and the end-user can be made to allow the property to connect to the new network. Interest can be registered by emailing details to sfsb@fibrus.com. Please note, this is not a Department for the Economy initiative, and take up may prevent inclusion in any potential future intervention.

7. FUTURE POTENTIAL GOVERNMENT INTERVENTION

In addition to supporting the above intervention area update, the Department is also supporting the UK Government's ambition to deliver nationwide gigabit capable broadband as soon as possible. The UK Government has committed £5bn for the hardest to reach parts of the country, ensuring that all areas of the UK can benefit. This will be spent through a

package of coordinated and mutually supportive interventions, collectively known as Project Gigabit. To achieve this, the Department and Building Digital UK (BDUK) intend to procure further coverage to target Gigabit White areas across Northern Ireland.

8. CONCLUSION

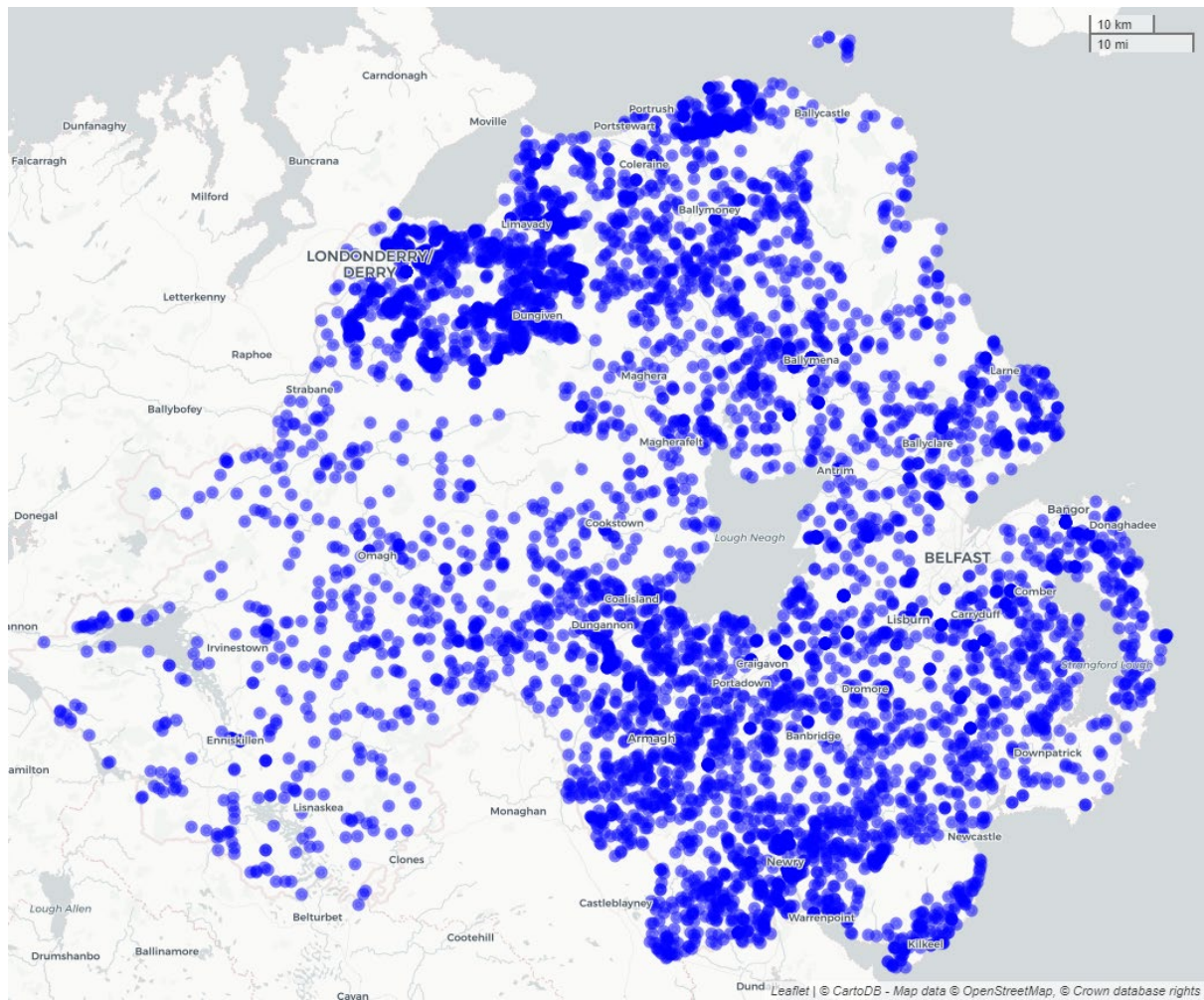
As indicated, 5,129 premises have been identified as eligible for Project Stratum as result of this DSR.

Please note that, due to the availability of funding and/or capacity, it may not be possible to address all of the premises which have been identified as eligible following this Review.
