INVITATION TO RESPOND TO THE CONSULTATION ON PROPOSED MARINE CONSERVATION ZONES IN NORTHERN IRELAND INSHORE REGION

I am writing to invite you to respond to a consultation on proposals for Marine Conservation Zones in the Northern Ireland inshore region (out to 12 nautical miles). The four sites and the features for which they are being proposed for designation are as follows:

- Rathlin Deep-sea bed, Black guillemot and Geological/geomorphological features (Submerged lagoons and Sea arches);
- Waterfoot Subtidal (sublittoral) sand with subtidal seagrass beds (Zostera marina);
- Outer Belfast Lough Ocean quahog (Arctica islandica) and associated habitat
 Subtidal (sublittoral) sand;
- Carlingford Lough Subtidal (sublittoral) mud containing Sea-pen and white sea slug communities.

The consultation document is aimed at organisations, groups, and people who undertake activities, or have a general interest in the marine area.

Background

Each of the UK Administrations is responsible for designating Marine Conservation Zones, for the protection of nationally important habitats and species, in their territorial waters (out to 12 nautical miles).

MCZ designation powers became available in Northern Ireland under the Marine Act (Northern Ireland) 2013, which was enacted in September 2013.

Since that time, the Department has been developing potential sites for MCZ designation based on sound scientific evidence and with the involvement of stakeholders from all marine sectors including angling, fishing, renewable energy, ports and harbours, and environmental groups.

- Draft Regulatory Impact Assessment for Marine Conservation Zones in the Northern Ireland Inshore Region; and
- Frequently Asked Questions.

As part of the site selection process the Department is seeking views on the proposals and in particular the following specific aspects.

- The pMCZ protected features.
- The pMCZ boundaries.
- The potential management options for each pMCZ.
- The Draft Regulatory Impact Assessment.

In an effort to reduce the environmental impact of the production of consultation papers, the Department is opting to send notification of this electronic consultation exercise to stakeholders.

The proposals detailed in this consultation package are aimed at affording greater protection to our nationally important habitats and species through the designation Marine Conservation Zones. It is important that these unique areas of the marine environment are managed sustainably and promoted as a valuable social and economic asset. By ensuring that our seas remain clean, healthy, safe, productive and biologically diverse, rural businesses and communities will be enhanced.
