### **Historic Environment Division's Aim**

# To help communities to enjoy and realise the value of our historic environment.

#### **Historic Environment Fund**

The Historic Environment Fund has been set up by the Department to stimulate action across the historic environment in support of this aim. It is divided into four streams: Heritage Repair; Heritage Research; Heritage Regeneration; and Heritage Revival.

#### What do we Fund?

Investment in heritage has been shown to deliver significant benefits to our society, environment and economy<sup>1</sup>.

Wider understanding, better management, and better use of heritage assets, can ensure that the significant potential they hold for our community is fully realised.

### **Support for Heritage Research**

#### **1. Heritage Research Fund.**

Support to stimulate heritage research work in Northern Ireland by funding initiatives that aim to carry out and/or share the results of research into the historic environment.

Under Section 225 (2) of the Planning Act (NI) 2011, the Department for Communities can 'make grants to any body of persons (not being a body carried on for profit) which appears to the Department to have among its principal objectives furthering the preservation, conservation and regeneration of historic buildings'. Under Article 26 of the Historic Monuments and Archaeological Objects (Northern Ireland) Order 1995: 'The Department may - (a)provide advice and disseminate knowledge about historic monuments and the protection and enhancement of historic monuments; and (b)provide, or assist in the provision of, publicity, mapping and information services relating to historic monuments.'

For research into historic buildings, therefore, applications can be considered from District Councils, voluntary groups, University departments, other third level research teams, and training bodies that comply with the above legislative requirements.For research into historic monuments or archaeological objects, applications can, in addition, be considered from private companies or partnerships. Research that can be supported under this stream can cover a wide range of activity. However, **Limited funds** have been allocated to this route and because of this we envisage that most awards offered will not exceed £10,000. Applications will be considered relative to their impact upon the main HEF criteria. Projects that can demonstrate match funding or greater are likely to be able to deliver better impact and this will be taken into account in the assessment. Consideration will also be given to the methodology and deliverability of the project.

Heritage Research Fund Criteria:

- 1. Conservation and enhancement of the historic environment. (15%)
- 2. Economic impact influence or impact upon future economic activity. For example, net zero, tourism, craft skills, specialist research to augment archaeological or architectural knowledge now or in the future. (10%)
- Social benefits creating broader and deeper understanding of our heritage. (40%)
- Social benefits enhancing public engagement with the historic environment, now and/or in the future. (10%)
- 5. Methodology and Deliverability. (25%)

Projects that score less than 50% will not be considered for support. Applications must be submitted by the closing date. Late applications cannot be considered. Following the closing date, applications will be assessed and scored according to the weighted criteria. Funding will be awarded to those applications receiving the highest scores until the available budget is fully allocated.

Since June 2016 the Historic Environment Division has embarked upon a structured engagement with key stakeholders which has, among other things, identified priorities for research work. This has isolated: work to establish the economic value of heritage; the impact and mitigation of climate change; strategic archaeological research and heritage skills as key areas of interest. **Applications for projects in these areas are encouraged**.

In return for support the Department will require the following:

### Support for Heritage Revival

# Enhancing public awareness of heritage value:

Support aimed at stimulating heritage projects that aim to increase public awareness of the heritage value of historic buildings and monuments in Northern Ireland. Such information can be communicated through a range of arts and media including conferences, seminars, awards and publications.

Heritage value may be understood as the intrinsic architectural, archaeological or historic value of buildings, monuments, and places, or it may be the economic, environmental and social value provided by such assets. Applications which seek to highlight overlooked aspects of heritage are particularly encouraged.

Under Section 225 (2) of the Planning Act (NI) 2011, the Department for Communities can 'make grants to any body of persons (not being a body carried on for profit) which appears to the Department to have among its principal objectives furthering the preservation, conservation and regeneration of historic buildings'. Under Article 26 of the Historic Monuments and Archaeological Objects (Northern Ireland) Order 1995: 'The Department may - (a)provide advice and disseminate knowledge about historic monuments and the protection and enhancement of historic monuments; and (b)provide, or assist in the provision of, publicity, mapping and information services relating to historic monuments.'

Applications can be considered from District Councils, voluntary groups, University departments, other third level teams, and training bodies that comply with the above legislative requirements.

- 3. Social benefits creating broader and deeper understanding of our heritage. (10%)
- Social benefits enhancing public engagement with the historic environment, now and/or in the future. (40%)
- 5. Methodology and Deliverability. (25%)

Projects that score less than 50% will not be considered for support. Applications must be submitted by the closing date. Late applications cannot be considered. Following the closing date, applications will be assessed and scored according to the weighted criteria. Funding will be awarded to those applications receiving the highest scores until the available budget is fully allocated.

# How we will process your application

**Stage 1. Receipt of Applications.** On receipt of a completed application form together with supporting information, we will acknowledge your application. We will normally expect to do this within 5 working days. Please note that incomplete applications will be rejected and will be returned to you at stage 2.

**Stage 2. Assessment.** The Division will consider all applications relative to the HEF criteria and identify which projects will be supported this year. Applications must be submitted by the closing date. Late applications cannot be considered. Following the closing date, applications will be assessed and scored according to the weighted criteria. Funding will be awarded to those applications receiving the highest scores until the available budget is fully allocated. **Stage 3. Agreement of Proposals.** Successful applicants will be notified and a member of our staff will arrange to meet with you to discuss the proposed scheme. The detail of the proposal including a programme of work with clear measurable outputs will be agreed in advance of the drawing up of a letter of offer.

#### If we approve your scheme for HEF funding.

For successful applications, we will issue an offer letter detailing the amount of funding available. This will also set out the conditions which will apply to the offer. You will be required to formally accept any offer before your application is progressed further. **You must not start work until you have received written approval to do so from the Department.** 

#### **Monitoring of Works and Payment**

We will agree regular review dates with you to ensure that work is being carried out to programme.

#### Note on the allocation of Scores

Assessment panels will consider the information provided on the application form relative to the published criteria. Scores will be allocated following the following weighting mechanism:

SCORE	MEANING
<b>0</b> Zero	No evidence that the project is consistent with the criteria
<b>1</b> Very Poor	Evidence is insufficient to meet the minimum criteria
<b>2</b> Poor	<ul><li>Meeting certain aspects to a minimum extent but fails in others</li><li>Little evidence of ability to meet or deliver to the strategic criteria of the scheme</li></ul>
<b>3</b> Satisfactory	<ul> <li>Meeting the majority but not all aspects of the scheme</li> <li>Adequate evidence of ability to meet or deliver to the strategic criteria of the scheme</li> </ul>
<b>4</b> Good	<ul> <li>Meeting all aspects of the criteria</li> <li>Comprehensive clear proposal demonstrating a good understanding of the strategic criteria</li> <li>Clear evidence of ability to meet or deliver the strategic criteria</li> </ul>
<b>5</b> Very Good	<ul> <li>Materially exceeding the strategic context, through a creative or innovative response or</li> <li>Where additional 'added value' areas have been identified</li> <li>Clear evidence of ability to exceed the strategic criteria.</li> </ul>

This score between 1 and 5 will then be converted into a percentage. The final weighted mark will be the percentage value of the marks available. For example a score of 4 is 80%. In some routes criterion 1 has 40 available points, this equates to 32 i.e. 80% of 40
