#### FISHERIES ACT (NORTHERN IRELAND) 1966, AS AMENDED

## MR. STEPHEN O'HARE - APPLICATION TO AMEND FISH CULTURE LICENCE FOR A SITE NEAR MILL BAY IN CARLINGFORD LOUGH

I am writing to inform you that Mr. Stephen O'Hare, 40 Leestone Road, Maghereagh, Kilkeel, Co. Down, BT34 4NW (known as Knockshee Oysters) has applied to the Department to amend the Fish Culture Licence granted to him on 27 August 2013. Mr O'Hare has applied for two amendments to his Licence, namely:

- to add mussels (Mytilus edulis) to the list of species authorised to be cultivated;
   and
- to increase the number of trestles authorised to be placed on the licensed area from 1,000 to 3,000.

A chart of the licensed area, which totals 29 hectares, is attached for ease of reference. The proposed amendments will not increase the size of the site.

The owner of the seabed, Mourne Country Park Ltd, has confirmed it has no objection to the increase in the number of trestles to be placed on the site. The Maritime and Coastguard Agency has also confirmed that it has no objection from a navigational point of view.



The existing Fish Culture Licence authorises the trestle culture of Pacific oysters (*Crassostrea gigas*) and European or Native oysters (*Ostrea edulis*). Mr. O'Hare proposes to also cultivate Mussels (*Mytilus edulis*), in bags on trestles, sourced from on-site naturally occuring spat settlements.

As is currently the case, Mr. O'Hare will only be permitted to cultivate triploid or sterile Pacific oysters. In addition, servicing the site will continue to be limited to 30 hours per month, spread over seven low tides, and will be undertaken at a time and in a manner that minimises disturbance to birds.

In accordance with the provisions of the Habitats Directive 92/43/EEC, DARD commissioned assessments, carried out by the Agri-Food and Biosciences Institute (AFBI), on both the potential individual and cumulative impacts of Mr. O'Hare's proposed amendments on the Carlingford Lough Special Protection Area (SPA). These assessments concluded that the proposed amendments will not have a negative impact on the SPA conservation features of the Lough. In addition, an assessment carried out by AFBI on the potential impacts of the proposed amendments on the Carlingford Lough Area of Special Scientific Interest (ASSI) features concluded that the proposed amendments will not negatively impact the designated ASSI features of the Lough.

The Department is therefore minded to amend Mr. O'Hare's Fish Culture Licence. In accordance with the provisions of the Fisheries Act (Northern Ireland) 1966, as amended, notice of Mr. O'Hare's application is being published in the *Newry Reporter*, *Mourne Observer* and *Belfast Gazette*. A copy of the Notice is attached for your information.
