

INTRODUCTION

On 24 September 2015 the Education Authority (EA) published Development Proposal (DP) 403 to extend the approved enrolment for Bocombra PS from 300 to 320 pupils. This would permit the school to increase its admission number from 43 to 46 pupils with effect from 1 September 2016 or as soon as possible thereafter.

- 2. The statutory two-month objection period ended on 24 November 2015. A copy of the published DP is attached at **Appendix A** and the proposer's Case for Change is attached at **Appendix B**.
- 3. In accordance with Article 14 of The Education and Libraries (NI) Order 1986, the EA have confirmed that consultation was carried out with the Board of Governors, staff and parents of pupils at the school, and with other schools which would, in its opinion, be affected by the DP.

BACKGROUND

Bocombra PS.

- 4. Bocombra PS is a controlled co-educational primary school situated on the Old Lurgan Road on the outskirts of Portadown in County Armagh. It currently has an approved admissions number of 43 and an enrolment number of 300. In 2014/15 the school admitted 46 Year 1 pupils and had an enrolment of 319 Year 1-7 pupils. The school also had 27 part time pupils enrolled in its nursery.
- 5. In June 2012 you approved DP 255 for the establishment of a nursery unit at Bocombra PS to provide a 26 pupil part-time nursery unit. The unit became operational in September 2013 and a minor works scheme is currently ongoing to provide nursery accommodation.
- 6. Prior to 2010, Bocombra PS had admissions and enrolment numbers of 41 and 290 respectively. During 2010 the school then received additional accommodation and the admission and enrolment numbers were subsequently increased to 46 and 300 respectively with an intention to phase up the approved enrolment number to 320. It was subsequently discovered that this increase had been implemented in the absence of an approved DP. In June 2014 you agreed that from September 2015 the enrolment number would be frozen at 300 and the admissions number reduced to 43 to bring the admissions and enrolment numbers in line with each other.

Area Planning

7. The nearest controlled primary schools within a three mile radius to Bocombra PS are as follows:

Edenderry PS – 0.9 miles Millington PS – 2.2 miles Ballyoran PS – 2.4 miles Drumgor PS – 2.9 miles Hart Memorial PS – 3.1 miles

- 8. The former SELB Primary Area Plan published in June 2014 noted that each of the above schools was considered to be sustainable within the local area context in relation to enrolment and financial viability.
- 9. Portadown Integrated PS, which is located 1.1 miles away, published DP 324 in April 2015 to increase its admissions number from 29 to 46 pupils thereby increasing its approved enrolment number from 203 to 320. In December 2015 you approved a modified proposal to increase its admissions number from 29 to 58, resulting in an overall enrolment number of 406 from 1 September 2016 or as soon as possible thereafter.
- Seagoe PS, is a voluntary maintained primary school which is located 0.9 miles from Bocombra PS has published a proposal to increase the approved enrolment from 249 to 313 allowing the school to increase its admission number from 36 to 45, to take effect from 1 September 2016 or as soon as possible thereafter.

Needs Model

- 11. The Needs Model provides long-term projections of the requirement for places in each year across the planning horizon based on the former 26 District Council areas. Craigavon Borough Council area is bounded by the council areas of Dungannon and South Tyrone, Banbridge, Armagh and Lisburn. Primary education provision is mostly available in the towns of Lurgan, Portadown and Craigavon. Some pupils travel across council boundaries to access primary education.
- 12. Bocombra PS is situated in the Kernan Ward of Armagh City, Banbridge and Craigavon Borough Council. It is included along with all other controlled primary schools in the Needs Model. The projected primary school numbers for controlled schools within the former Craigavon DC area are expected to increase from 5,050 in 2014 to 5,659 in 2025.

CASE FOR CHANGE

13. The EA has brought forward DP 403 and a copy of the Case for Change is attached at **Appendix B**. The proposal is to increase the level of provision at Bocombra PS and the rationale contained within the Case for Change is to meet the increasing demand for places in the school. The school had requested temporary variations from the Department in each of the last three years as the number of first preference applications have exceeded the approved admissions number.

CONSULTATION

Pre-publication consultation

- 14. Consultations were carried out on 29 April 2015 with the Board of Governors, staff and parents of Bocombra PS. They received 126 letters of support in respect of the proposal and one letter of objection.
- 15. The letter of objection cited concerns regarding the additional teaching resources, accommodation and play space required along with car parking hazards outside the school gates if the increase was permitted.

EA Pre-publication Consultation and EA Comments

- 16. The EA also carried out a pre-publication consultation exercise with all those schools that were likely to be affected by the proposal. The EA received one letter of objection to the proposal from the Principal and Secretary to the Board of Governors of Edenderry PS. The reasons for objection were that the school felt that any additional pupils can and should be accommodated within the existing structure as a number of schools have the capacity.
- 17. At the EA Education Committee meeting held on 11 June 2015 the proposal to increase the approved enrolment number for Bocombra Primary School from 300 to 320 pupils was outlined. It was noted that there had been two objections but that letters of support had been received from other schools in the area.
- 18. On 10 September 2015 the EA received a letter from the Controlled Schools Support Council (CSSC) in relation to DP 403. The CSSC confirmed that the level of applications for primary schools in the area had been reviewed against the number of Year 1 places available and they remained of the view that the proposal would not have an adverse impact on other controlled schools in the immediate area.

Two-month objection period

19. The statutory two-month objection period began on 24 September 2015 and closed on 24 November 2015. No objections were received during this period.

SUSTAINABILITY ASSESSMENT

- 20. The Department's Sustainable Schools Policy (SSP) sets out the six criteria which provide the framework for consideration of a school's longer-term sustainability. The primary objective of this policy is to ensure that all children and young people receive a high quality education in schools that are educationally and financially viable in the longer term.
- 21. An assessment of Bocombra Primary School set against the six criteria is outlined below:

(i) Quality Educational Experience

- 22. The Education and Training Inspectorate (ETI) carried out a Focused Inspection on 19 October 2009 and it was noted that the standards of literacy and numeracy achieved by the children at the end of KS2 were good and that there was good provision for children with special needs. At an ETI District Visit on 21 October 2015 the following key points were noted from their report :
 - The children were well motivated to learn.
 - Standards in literacy and numeracy were good.
 - The teaching was good or better.
 - The provision for special educational needs was very good.
- 23. ETI reported that between these two inspections the quality of education has been maintained and that the provision for special educational needs had improved to very good. A full copy of ETI's comments is contained in **Appendix C**.
- 24. ETI have noted that Bocombra PS currently operates composite classes in several year groups due to the school having been oversubscribed for the last five years.
- 25. The school did not submit Key Stage data for 2013/14 however the previous year's data shows that for pupil outcomes at Key Stage 2 the school has been performing consistently above the NI average. The most recent data available is for the 2012/13 school year:
 - In 2012/13, 88.2% of pupils (30 pupils) attained L4 or above KS2 Communication (English). This was above the NI average (77.1%).
 - In 2012/13, 88.2% of pupils (30 pupils) attained L4 or above KS2 Using Maths – this is above the NI average of (78.5%).
- 26. The school's outcomes at Key Stage 2 in Communication and Using Mathematics were above the NI average in 2012/13 (the last year for which data was submitted to DE).
- (ii) Stable Enrolment Trends
- 27. The current approved admissions and enrolment numbers for Bocombra PS are 43 and 300 respectively. In 2014/15 the school admitted 46 pupils to Year 1 and enrolled a total of 319 Year 1-7 pupils, meaning that the school had no surplus places. Table 1 below shows the 2014/15 and provisional 2015/16 enrolment at Bocombra PS:

- 28. The 2014/15 and provisional 2015/16 enrolment levels are above the approved enrolment numbers of 300 with admissions into P1 exceeding the approved 43 in both years.
- 29. Bocombra PS has been oversubscribed in the last five years with first and second preferences for Year 1 applications. There has been a significant increase in first preference applications in the last four years. Table 2 below sets out the numbers of applications for first and second preferences at the school as set out in the Case for Change:

30. Since 2013/14 the school has sought Temporary Variations (TVs) to both its admissions and enrolment numbers which, following approval by the Department, allowed the school to admit more pupils than its approved admissions and enrolment numbers. Table 3 below provides details of the TVs approved in recent years:

(iii) Sound Financial Position

31. Bocombra PS held a cumulative budget surplus of £33,935, or 3.80% of available delegated resources, at March 2015. At July 2015, the EA expressed no concerns about the school's financial plans; the forecast position at March 2018 is a surplus of £4,269, or 0.47% of available delegated resources.

- 32. The most recent available projection, from the EA Monthly Expenditure Monitoring Report (MEMR) for August 2015, is a surplus of £26,549 at March 2016.
- (iv) Strong Leadership and Management by Boards of Governors and Principals
- 33. During an ETI focussed inspection in October 2009 it was noted that the Principal, who had been in post for sixteen months, had set high standards in all aspects of the school's provision. He provided good leadership and was effectively promoting a collegial approach to school development and decision making with support from the Vice Principal.
- 34. During ETI's visit of 21 October 2015 it was noted that the Principal monitors and evaluates planning, learning and teaching through observation and detailed collation and analysis of data. The school's development plan was comprehensive with extensive action plans. There have been new appointments due to retirements; a specialist mathematics teacher has been appointed who has a very thorough overview of the school provision and children's attainments. Co-ordinators now observe the learning and teaching for their subjects by their colleagues.
- (v) Accessibility
- 35. Bocombra PS is situated on the Old Lurgan Road on the outskirts of Portadown. It has a high percentage of the pupils living within a two mile radius of the school. **See Map 1 in Appendix D.**
- (vi) Strong links with the Community
- 36. The Department launched the Community Relations, Equality and Diversity Policy (CRED) in 2011 which Ballyoran Primary School participates in conjunction with Bocombra Primary School. The objectives of the policy are:
 - ensure that learners, at each stage of their development, have an understanding of and respect for the rights, equality and diversity of all without discrimination;
 - educate children and young people to live and participate in the changing world, so that they value and respect difference and engage positively with it, taking account of the ongoing intercommunity divisions arising from conflict and increasing diversity within our society; and
 - equip children and young people with the skills, attitudes and behaviours needed to develop mutual understanding and recognition of, and respect for difference.
- 37. Pupils from Ballyoran PS visit Bocombra PS to enable social interaction and to participate in joint activities which contributes towards improving relations between communities.

<u>Summary</u>

38. The quality of education and leadership provided by Bocombra PS was good when last inspected in 2009. The enrolment levels at the school are above the required threshold within the SSP. There are no concerns with regards to the school's finances. The school has positive links with the community and the majority of pupils who attend the school come from within the local area.

OTHER CONSIDERATIONS

Finance – Resource

39. This proposal, if approved, would have minimal impact on the Aggregated Schools Budget, as it involves a redistribution of pupils between schools.

Accommodation

- 40. Currently Bocombra PS has 11 classrooms which are all suitably sized with an extension having been completed to replace some temporary classrooms and which includes a resource area, library and nursery accommodation. If the proposal is approved there would be no need to provide any additional classrooms.
- 41. However it would be anticipated that some work would be required to provide additional multi-purpose rooms and toilet provision. The estimated figures based on an extension of 153m² would be £240,000 (excluding professional fees, VAT etc) with an estimated timescale of 5 months for implementation. This work would be carried out through the minor works programme.
- 42. While there are unfilled controlled places in the area, the modest growth proposed in this school to regularise it position is unlikely to have a wider negative impact. The former SELB plan states that those schools are sustainable.

CONCLUSION

- 43. While the proposed increase at Bocombra PS has not been referenced in the former SELB Primary Area Plan, it notes that the school is currently considered to be sustainable within the local area context in relation to enrolment and financial viability.
- 44. It is not anticipated that the proposed increase in the enrolment would have any significant impact either positively or negatively on the quality of education provided by the school.
- 45. There has been a steady increase in the total enrolment numbers at Bocombra PS in recent years, from 291 in 2010/11 to 319 in 2014/15. Provisional enrolments for 2015/16 are 323. Admissions into P1 have exceeded the approved 43 with TVs

having been approved in each of the last 3 years to allow the school to admit pupils to Year 1 over and above its approved admissions number.

RECOMMENDATION

46. It is recommended that you;

- Approve the proposal to increase the approved enrolment at Bocombra PS and
- Agree that this submission (with any appropriate redactions) can be published on the Department's website once the Education Authority and the school has been notified.

It is proposed to extend the approved enrolment for Bocombra Primary School from 300 pupils to 320 pupils. This would permit the school to increase its admission number from 43 pupils to 46 pupils with effect from 1 September 2016 or as soon as possible thereafter.

BACKGROUND TO THE PROPOSAL

Bocombra Primary School is a controlled co-educational primary school situated on the Old Lurgan Road on the outskirts of Portadown in County Armagh. In June 2012 a development proposal was approved to provide a 26 pupil part time nursery unit at Bocombra Primary School. This was operational from September 2013 and a minor work scheme is currently ongoing at the school to provide nursery accommodation.

The table below outlines the current accommodation (excluding nursery unit) at Bocombra Primary School against that recommended for an 11 classbase school.

SUSTAINABLE SCHOOLS POLICY

Bocombra Primary School is currently considered to be sustainable within the local area context in relation to enrolment and viability.

The enrolment is currently 319 pupils which is above the recommended threshold of 105 pupils. The school currently has a budget surplus of 5.48% and this is expected to be maintained for the next 2 years. There are currently no issues in relation to the quality of education provided at Bocombra Primary School.

RATIONALE FOR THE PROPOSAL

The Board seeks approval for a development proposal to increase the approved enrolment from 300 pupils to 320 pupils (ie 11 class base school) to meet the increasing demand for places in the school. The school has requested temporary variations from the Department of Education in each of the last three years, as the number of first preference applications have exceeded the approved admissions number (this is detailed on page 5).

Area Planning

In the context of Area Planning an increase in the approved enrolment at Bocombra Primary School is unlikely to have a significant impact on other schools as the pupils tend to live within the immediate vicinity of Bocombra Primary School. As Bocombra Primary School currently has an enrolment of 319 pupils this development proposal will formalise the current enrolment and provide an approved enrolment of 320 and an admission number of 46 pupils.

(a table on page 7 indicates the position of the schools neighbouring Bocombra Primary School. It should be noted that although Ballyoran Primary School has a considerable number of surplus places, due to its location in Portadown the majority of children attending are from the Roman Catholic community (82%).

The majority of controlled schools in close proximity to Bocombra Primary School have very few places available for Primary 1 children in the 2015/16 school year and in subsequent years it is anticipated that less places will be available for Primary 1 children.

An analysis of the pre-school applications for September 2015 for this area compared to the Primary 1 places available are detailed below;

The above table shows that 235 children applied for pre-school places in September 2015. Based on the number of primary one places available in this area of Portadown (hospital side) for September 2015, if all these children apply for admission to Primary 1 in September 2016 in this locality, there will be a significant shortfall of primary places.

It should be noted that a development proposal was published on 23 April 2015 for Portadown Integrated Primary School which proposed an increase to the approved enrolment number from 203 pupils to 320 pupils (11 class base school).

EDUCATIONAL IMPACT

If the development proposal is approved it will allow the approved enrolment to increase to 320 pupils which will formalise Bocombra Primary Schools position as an 11 class base school.

STATISTICAL INFORMATION

Enrolments

Bocombra Primary School has an approved enrolment number of 300 pupils and an admissio number of 43 pupils. The school enrolment trend has continually increased, over the past 1 years the enrolment has increased from 254 pupils to 319 pupils, an increase of 26%.

It is important to note that the majority of pupils attending Bocombra Primary School live in the Kernan and Killicomain wards. This indicates that the enrolment at Bocombra Primary School

. I be maintained and is highly likely to increase in the future. There are currently several housings developments in the immediate vicinity of Bocombra Primary School which are likely to have a significant impact on enrolments in the future.

Although the birth rate in the area has a significant impact on enrolments there is also substantial migration into this area of Portadown. Bocombra Primary School is situated on the hospital side of Portadown therefore the school obtains a lot of pupils from families working in Craigavon Area Hospital and other local industries. One of the major industries in the town which is currently expanding is located on this side of Portadown. The school has reported that this has led to a lot of in-migration and parents are regularly contacting Bocombra Primary School to enrol their children not just in Primary 1 but throughout the school as they move to the area.





It is evident from this map that the majority of pupils attending Bocombra Primary School live within a mile of the school. In recent years due to the demand for places the majority of pupils are from within a mile of the school and those children shown on the above map that live 3 plus miles from Bocombra Primary School tend to be in the older classes within the school. In the future it is anticipated that there will be little or no children attending the school from outside a 2 mile radius.

IMPLEMENTATION PLAN

It is anticipated that the development proposal will be published in May 2015. If the decision is made prior to January 2016, Bocombra Primary School could admit 46 pupils in September 2016 without applying for a temporary variation.

Currently Bocombra Primary School has 11 classrooms which are all suitably sized. This together with the associated ancillary space meets the majority of requirements outlined in the DE Building Handbook.

derefore if the proposal is approved for 320 pupils there will be no need to provide an additional classroom. It is anticipated that some work could be carried out to provide multipurpose rooms and additional toilet provision.

RESOURCE IMPLICATIONS

If the proposal is approved the school would require;

- · No additional teaching staff are required.
- No extension is necessary although the school would benefit from the provision of a multi-purpose rooms as detailed in the DE Building Handbook. This would cost approximately £80k.

I am writing on behalf of the Board of Governors of Edenderry Primary School to object to Development Proposal No 403 for Bocombra Primary School. The governors are of the opinion that this proposal would have a detrimental effect on the delicate educational balance within the Portadown area. In East Portadown there are four medium sized primary schools located within a mile radius of each other and a number of other schools within a three mile radius of this area.

The Board of Governors feel that any additional pupils coming into the Portadown area can <u>and</u> <u>should</u> be accommodated within the existing enrolment structure as a number of these schools have the capacity to meet the temporary demand for places. The Board of Governors feel that the figures presented on page 3 regarding the demand for PreSchool/Nursery Places are misleading as parents applying for places in Nursery School/Unit often choose another Primary School not associated with the Nursery School/Unit. In the instance of Edenderry Nursery School the criterion of age is used as opposed to distance thus allowing parents from a very wide catchment to apply for places in the Nursery School, very often parents who have no intention of sending their child to one of the named primary schools.

The Board of Governors would assert that the increase in births experienced in the Kernan Ward and Killicomaine areas will be absorbed by the primary schools that serve these wards, namely Edenderry P.S., Drumgor P.S., Bleary P.S., P.I.P.S., Seagoe P.S., St Brendans P.S. and St Anthonys P.S. Furthermore the governors feel it should be noted that the increase in the percentage birth rates in these wards is counterbalanced by the decrease or minimal increase in other neighbouring wards served by the schools mentioned.

This assertion is borne out by the fact that Bocombra P.S. was unable to accept <u>4</u> pupils in 2014/15, a fact that strongly suggest the available places across the area meet the demand.

On examination of the figures published on page 7 Edenderry Primary School has 38 places available, Hart Memorial Primary School has 113 places available, Drumgor Primary School has 112 places available, Bleary Primary School has 47 places available and Ballyoran Primary School has 208 places available. These schools are all dependant on a limited number of children for their financial viability. The Board of Governors are concerned over the long term sustainability of the current system if one or more schools have their Enrolment and consequently Admission Numbers increased and the damaging effect on the smooth running of these schools should one school be allowed to grow at the expense of others. Such a scenario would not be in keeping with the concept of area planning.

The Board of Governors of Edenderry Primary School are of the opinion that decisions on increasing the enrolment capacity of primary schools within this area should not be taken until all the schools in this catchment area are at full capacity. The governors believe that the decision should then be based on suitability for growth in terms of buildings, grounds and the ability of a school to safely transfer in and out the parent/pupil body of the school without placing members of the school community at risk and gridlocking roads assuming that all the schools concerned continue to successfully serve the local community as they currently are doing.

Co-ordinators now observe the learning and teaching for their subjects by their colleagues. The principal monitors and evaluates planning, learning and teaching through observation and detailed collation and analysis of data.

ETI EVIDENCE

ETI support the proposal to increase the approved enrolment from 300 to 320 children. The school has 323 children at present and there have been temporary variations each year from 2013.

There has been an extension completed to replace some temporary classrooms. The rooms

are now in use as classrooms, resource areas, library and nursery accommodation. Due to the demands of the pupil numbers, the classes are: Two Year 1 classes Y2




