## The Draft Food Information Amendment Regulations (Northern Ireland) 2016

#### Who will this consultation be of most interest to?

Manufacturers, wholesalers and retailers of foods suitable for people intolerant to gluten. The consultation will also be of interest to enforcement authorities, health professionals, caterers, consumer groups and consumers intolerant to gluten (i.e. people who suffer from coeliac disease).

## What is the subject of this consultation?

The draft Northern Ireland Regulations are needed to provide for the enforcement of Commission Implementing Regulation (EU) No 828/2014 on the requirements for the provision of information to consumers on the absence or reduced presence of gluten in food. The EU Regulation sets out the requirements, based on internationally accepted safe levels, related to the claims "gluten-free" and "very low gluten" for foods which have been specifically manufactured to satisfy the particular nutritional requirements of people who are intolerant to gluten. The EU Regulation also allows "normal foods" that meet the compositional requirements of the Regulation to be labelled as "gluten-free". The proposed Northern Ireland Regulations (Northern Ireland) 2010.

#### What is the purpose of this consultation?

To seek comments on the draft Statutory Rule The Food Information (Amendment) Regulations (Northern Ireland) 2016. Parallel regulations will be produced in England, Scotland and Wales and consultations on these will be issued in due course.

## The Food Information (Amendment) Regulations (Northern Ireland) 2016

#### **DETAIL OF CONSULTATION**

The Food Standards Agency in Northern Ireland would welcome your comments on the proposed changes to the Food Information Regulations (Northern Ireland) 2014.

## **Background**

In January 2009, the European Commission published Regulation (EC) No 41/2009 concerning the composition and labelling of foodstuffs suitable for people intolerant to gluten. The Regulation introduced compositional criteria for the claims "gluten-free" (not more than 20 mg/kg of gluten) and "very low gluten" (not more than 100 mg/kg of gluten) for foods which have been specifically manufactured to satisfy the particular nutritional requirements of people who are intolerant to gluten as provided for by Council Directive 2009/39/EC. The Regulation also allows normal foods and other foods for particular nutritional uses (that are not specially prepared for people intolerant to gluten but meet the compositional requirements of the Regulation) to be labelled as "gluten-free".

Following a revision of the legislation on foodstuffs intended for particular nutritional uses (i.e. PARNUTS), Regulation (EU) No 609/2013 of the European Parliament and of the Council on food intended for infants and young children, food for special medical purposes, and total diet replacement for weight control will repeal Regulation (EC) No 41/2009 and Directive 2009/39/EC from 20 July 2016. The introduction of the Northern Ireland Regulations to enable the enforcement of Regulation (EU) No 609/2013 will be the subject of a separate consultation.

It is important that information on the absence or reduced presence of gluten in food must be presented clearly and accurately to consumers and the rules for doing so will be retained under Commission Implementing Regulation (EU) No 828/2014.

The gluten levels permitted by Regulation (EU) No 828/2014 for the terms "gluten free" and "very low gluten" are identical to those set previously in Regulation (EC) No 41/2009 (as quoted above). However, Article 3 states that these terms may now be supported by the statements: "suitable for people intolerant to gluten" or "suitable for coeliacs".

Additionally, the supporting information "specifically formulated for people intolerant to gluten" or "specifically formulated for coeliacs" may be used if the food has been specially produced, prepared and/or processed to:

- (a) reduce the gluten content of one or more gluten-containing ingredients; or(b) substitute the gluten-containing ingredients with other ingredients free of gluten.
- The phrase "no gluten-containing ingredients" can no longer be applied to "normal" foods.

Regulation (EU) No 609/2013 has a more restricted scope than the previous Parnuts Directive 2009/39/EC and foods making gluten claims will in future be treated as normal foods covered by the general food labelling requirements of the Food Information for Consumers Regulation (EU) No 1169/2011 (FIC). This means that the enforcement of all food allergen and intolerance related labelling requirements will be provided by the Food Information Regulations (Northern Ireland) 2014 (as amended).

Therefore, the Food Information (Amendment) Regulations (Northern Ireland) 2016 (see Annex B) are needed to reflect this change in the European legislative framework and to provide for the enforcement of Regulation (EU) No 828/2014 in Northern Ireland.

## **Proposals**

The options being considered are:

**Option 1** – Do nothing. This means that the directly applicable European Regulation on gluten claims could not be enforced in Northern Ireland.

**Option 2** – Introduce legislation to provide enforcement provisions in Northern Ireland for Regulation (EU) No 828/2014.

#### Key proposal(s):

- To provide enforcement provisions for Commission Implementing Regulation (EU) No 828/2014
- To introduce improvement notices for the provisions of Regulation EU 828/2014
- Revoke the Foodstuffs Suitable for People Intolerant to Gluten Regulations (Northern Ireland) 2010

#### Enforcement

Failure to introduce enforcement provisions for Regulation (EU) No 828/2014 could result in infraction proceedings against the UK. It is necessary to ensure that EU labelling requirements for gluten claims will continue to be enforced in Northern Ireland beyond 20 July 2016. The proposed Food Information (Amendment) Regulations (Northern Ireland) 2016 will enable district councils in Northern Ireland to take action if information on the absence or reduced presence of gluten in food is not provided correctly.

The draft Food Information (Amendment) Regulation (Northern Ireland) 2016 intends to follow the same approach to enforcement as is taken in FIR which will be via an improvement notice. This would be used as part of the hierarchy of enforcement when informal measures are no longer appropriate and the labelling contravention or issue should be elevated to formal enforcement action. If the conditions set by an improvement notice are not met then the non-compliance with those conditions will be a criminal offence. Businesses will have the opportunity to appeal against an improvement notice; appeals will be heard by Magistrates' court.

## **Engagement and Consultation Process**

A seven-week public consultation is being launched to provide interested parties with an opportunity to comment on the proposals and its associated impacts. Any comments that interested parties are able to provide in relation to the proposed Regulations would be gratefully received. We are particularly keen to hear from Small and Medium Enterprises (SMEs) on any likely impact and would encourage them to comment on all aspects of this proposal.

## **Impact Assessment**

Costs and benefits from this change are not quantified as this will not have an additional impact on businesses or district councils. These rules are already in place. This is an administrative change to how the European legislation on the gluten provisions sits in domestic law. If however, the consultation should bring to light any impact on enforcement bodies or industry which has not been anticipated, we will reconsider the need for an Impact Assessment.

#### Questions asked in this consultation:

Q1: Do you have any comments on the proposal to move the rules on gluten into the Food Information (Amendment) Regulations (Northern Ireland) 2016?

Q2: Do you have any information on costs and benefits of the proposed Regulations?

# Food Information (Amendment) Regulations (Northern Ireland) 2016

Made - - - - Oth Month 2016

Coming into operation - 20th July 2016

The Department of Health, Social Services and Public Safety(**a**) makes the following Regulations in exercise of the powers conferred by Articles 15(1), 16(2), 25, 26(3), and 47(2) to the Food Safety (Northern Ireland) Order 1991(**b**) and paragraph 1A of Schedule 2 to the European Communities Act 1972(**c**).

These Regulations make provision for a purpose mentioned in section 2(2) of the European Communities Act 1972, and it appears to the Department of Health, Social Services and Public Safety that it is expedient for references to provisions of Regulation (EU) No 1169/2011(d) of the European Parliament and of the Council on the provision of food information to consumers, amending Regulations (EC) No 1924/2006 and (EC) No 1925/2006 of the European Parliament and of the Council, and repealing Commission Directive 87/250/EEC, Council Directive 90/496/EEC, Commission Directive 1999/10/EC, Directive 2000/13/EC of the European Parliament and of the Council, Commission Directives 2002/67/EC and 2008/5/EC and Commission Regulation (EC) No 608/2004 specified in Regulation 2(2)(b) to be construed as a reference to those provisions as amended from time to time.

Insofar as these Regulations are made in exercise of powers under the Food Safety (Northern Ireland) Order 1991, the Department of Health, Social Services and Public Safety has had regard to relevant advice given by the Food Standards Agency in accordance with Article 47(3A) of that Order.

As required by Article 9 of Regulation (EC) No. 178/2002(e) of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety, there has

#### Citation and commencement

**1.** These Regulations may be cited as the Food Information (Amendment) Regulations (Northern Ireland) 2016 and come into operation on XXX

- **2.**—(1) The Food Information Regulations (Northern Ireland) 2014(**a**) are amended in accordance with paragraphs (2)-(5).

        - ""Regulation 828/2014" means Commission Implementing Regulation (EU) No. 828/2014 on the requirements for the provision of information to consumers on the absence or reduced presence of gluten in food."

      - "Any reference to FIC, or a provision of FIC (including a reference to an Article of, or Annex to, FIC to which paragraph (2) applies) or to Regulation 828/2014 or a provision of Regulation 828/2014, in a provision of these Regulations listed in Schedule 1 is a reference to that provision as amended from time to time."
  - (3) In regulation 12 (application of provisions of the Order)—
    - (a) for paragraph (1)(a)(i) substitute—
      - "a provision of FIC or Regulation 828/2014 specified in Schedule 5, to the extent provided for in Article 9 of the Order as applied by paragraph (1) and modified by Schedule 4 Part 1;"
    - (b) in paragraph (2)(a) after "provision of FIC" insert "or Regulation 828/2014."
  - (4) In Schedule 1—
    - (a) in the heading after "FIC" insert "or Regulation 828/2014"; and
    - (b) in the first line after "except for the definition of "FIC" insert "and Regulation 828/2014".
  - (5) In Schedule 4 (application and modification of provisions of the Order)—
    - (a) in Part 1, paragraph 1—
      - (i) at the end of paragraph (1A)(c) omit "or";
      - (ii) for paragraph (1A)(d)(iv) substitute—
        - "(iv) regulation 8(1) or (3); or
        - (e) a provision of Commission Implementing Regulation (EU) No 828/2014 on the requirements for the provision of information to consumers on the absence or reduced presence of gluten in food specified in Part 2 of the table in Schedule 5, Part 2 to the Food Information Regulations (Northern Ireland) 2014 (as read with regulation 2(3) of, and Schedule 1 to, those Regulations)."
    - (b) in Part 2, paragraph 1—
