

Asset Valuations

We provide valuations of property assets for inclusion in financial statements and departmental resource accounting and budgeting. We also provide values of building components, estimates of remaining life and residual values or insurance valuations.

Compulsory Purchase/Compensation

We advise public sector bodies acquiring land or property compulsorily for their functions. We can advise the authority on all aspects of compulsory purchase and negotiate individual claims for compensation on their behalf.

Acquisition by agreement

Valuation

Advising local councils

We provided advice to a District Council on the feasibility of letting out a portfolio of property. This resulted in an agreement of new lease terms which provided the council with a new income stream. We were also able to advise on and agree the subsequent rent reviews.

Working with Government Departments

We advise Government Departments on the disposal of surplus land, providing input with valuations, suitable disposal methods and development potential of lands. Over the last three years this has helped Government Departments realise an average of £13m from open market sales and over £7m through public sector transfers.

Assessing compensation

A major part of our ongoing work involves assessing compensation for various clients under different legislative frameworks. During 2014/15 financial year our network of offices completed over 750 compensation cases including disturbance claims with a total value of £35.5m for more than 20 different clients.
