## **1.0 BACKGROUND TO STUDY**

- 1.1 Hilden is situated on the outskirts of Lisburn Town Centre. It comprises properties located between Glenmore and Roseville (for a map of the survey area see Figure 1)
- 1.2 At the time of the survey Hilden had approximately 1,400 properties of different tenure: Housing Executive, housing association, privately rented and owner occupied.
- 1.3 Hilden Community Association was established in 2001 to address issues of concern for residents of the Hilden area including housing, recreational, social and environmental issues. Hilden Community Association was involved with the campaign to save the local post office and renovate two children's play parks; it also runs a yearly festival.
- 1.4 Hilden Community Association was selected by the Housing Executive's community Cohesion Unit to participate in the Shared Communities Programme in early 2013, the overall purpose of the programme being to develop shared communities where people choose to live with others regardless of their religion, race or nationality in a neighbourhood that is safe and welcoming to all, and threatening to no-one.
- 1.5 The programme is community led and provides an opportunity for residents to engage in good relations projects within their own area as well as neighbouring estates. Central to the programme is a survey designed by the Housing Executive's Research Unit, in consultation with groups selected, to assess attitudes to community relations as well as determine the needs of the community.
- 1.6 This report details the method by which the Hilden survey was conducted and resultant research findings.

## **2.0 SAMPLE AND METHODOLOGY**

- 2.1 Members of the Housing Executive's Research and Community Cohesion Units met with Hilden Community Association in 2015. Following consultation with community representatives the questionnaire design and methodology for the survey were agreed.
- 2.2 The objectives of the survey were to:
- measure satisfaction with local facilities/services;
  - identify activities or services that could be provided at a local community level;
  - assess attitudes to community relations and community safety in the area; and
  - identify areas of work needed in order to develop and implement an action plan.
- 2.3 The area to be surveyed had approximately 1,400 properties of different tenure (see Figure 1 for a map of the area). A random sample of 200 properties was taken.
- 2.4 Each of the 200 properties in the sample received a letter inviting the household to participate in the survey. Included with the letter was a copy of the questionnaire to be completed by the occupier and collected by Housing Executive research staff.
- 2.5 The questionnaire was designed for self-completion; however research officers helped complete questionnaires to those residents who requested assistance during the fieldwork period. A copy of the questionnaire is included in Appendix 1 (p. 17).
- 2.6 Research officers carried out the fieldwork in March 2015.
- 2.7 In line with organisational policy Research Unit staff carry photographic ID at all times when conducting fieldwork. Visits to properties are made at varying times of the day and a total of five attempts are made to collect surveys. However, in practice, when passing an address every opportunity is made to encourage occupants to participate. Therefore the minimum of five visits is often exceeded. If, at the end of the fieldwork period, Research Officers have been unable to contact a household member the address is recorded as a non-contact.
- 2.8 On completion of the fieldwork 7 addresses were identified as ineligible due to being vacant or non-existent which reduced the number of valid addresses to 193. A total of 96 completed questionnaires were returned which yielded a response rate of 50 per cent.

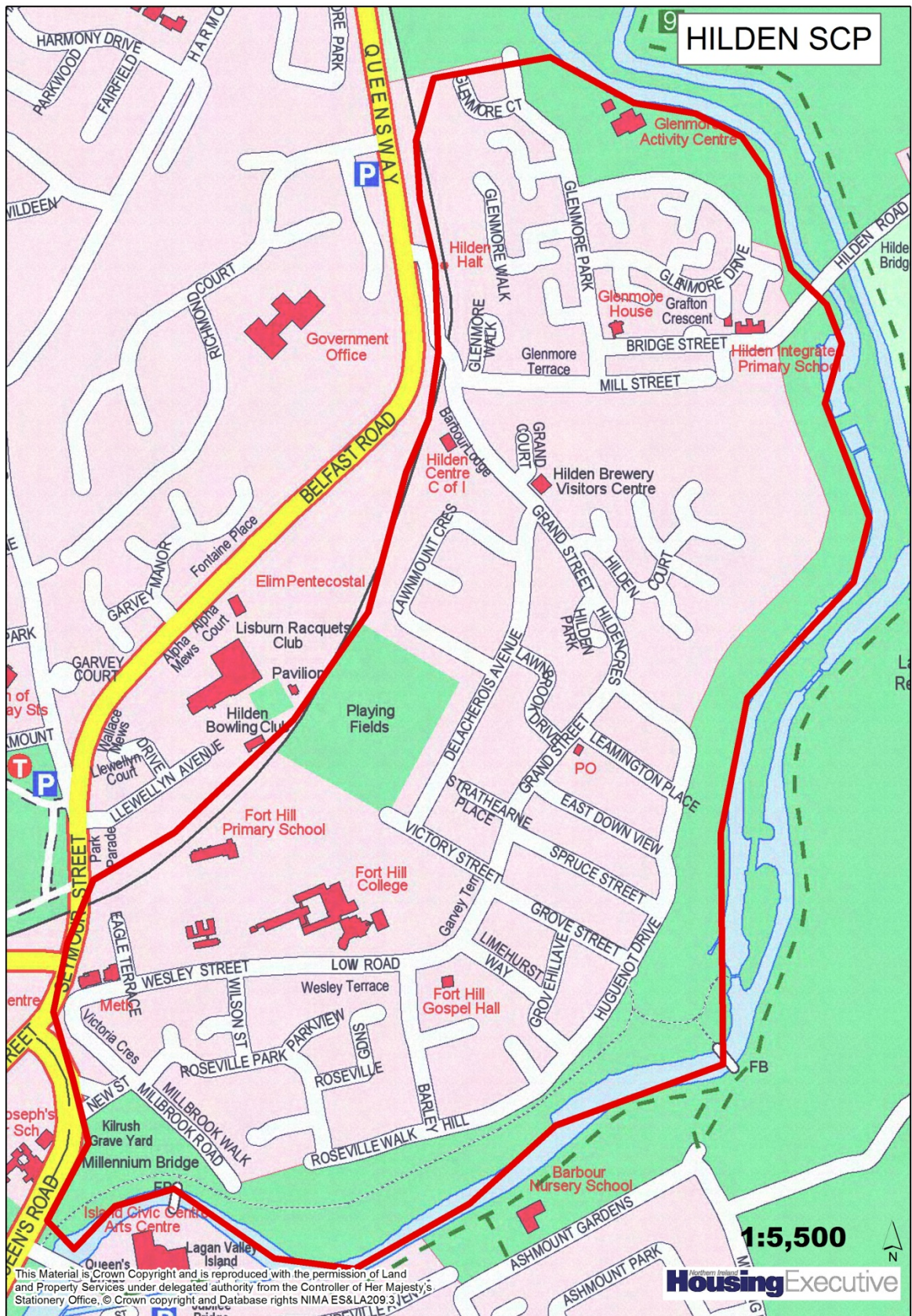

- 2.9 A breakdown down of figures is available in the tabular results included in Appendix 2 (p. 29).
- 2.10 Due to rounding, some tables do not add to 100%. Also, for data protection purposes, and in particular where questions are considered sensitive, if the number of respondents is less than five the actual figures have been omitted and are shown as <5.
- 2.11 In some cases the base is less than 96, which may be due to some respondents not giving sufficient information when answering that question. This is recorded as non-response.

## 3.0 RESEARCH FINDINGS

### 3.1 HOUSEHOLD PROFILE

#### *Characteristics of households*

'Lone older' (18; 19%) and 'two older' (12; 13%), where at least one person is of pensionable age (65 for men; 60 for women), totalled almost one-third (30; 32%) of all households surveyed. More than one-fifth (20; 22%) were 'lone adult' households; a similar portion of respondents were 'small family' (16; 17%) or (15; 16%) 'two adults' households. Less than one-tenth (6; 7%) were 'lone parent' households. (For more information on household types see Table 1 of Appendix 2).

One-third (32; 33%) of households had a member(s) with a disability which affects their normal day to day activities. Of those households (n=32) the majority (26 households) had one member with a disability (Appendix Tables 2 and 3).

#### *Characteristics of Household Reference Person<sup>1</sup> (HRP)*

More than half (52; 54%) of HRPs were female, the rest (43; 45%) were male. One-third (31; 33%) of HRPs were aged between 40 and 59. More than one-third (34; 36%) of HRPs were 60 years or more at the time of the survey (16; 17% aged 60 to 74 and 18; 19% aged 75 years or more). More than one-quarter (27; 29%) were aged between 25 and 39 and one percent was aged between 16 and 24 (Appendix Tables 4 and 5).

More than half (51; 53%) of all HRPs were working (full-time, part-time or self-employed) at the time of the survey and almost one-third (30; 31%) were retired. One-tenth (10; 10%) of HRPs were permanently sick or disabled; three per cent were looking after family home and two percent were not working at the time of the survey (Appendix Table 6).

In terms of ethnic origin, the vast majority (90; 97%) of HRPs were white. Four-fifths (77; 80%) of HRPs were British and more than one-tenth (12; 13%) were Northern Irish at the time of the survey (Appendix Tables 7 and 8).

Almost three-quarters (67; 70%) described the religious composition of their household as Protestant and more than one-tenth (12; 13%) as Catholic (Appendix Table 9).

<sup>1</sup>The household reference person (HRP) is the member of the household who owns or pays the rent or mortgage on the property. Where two people have equal claim (e.g. two persons cohabitating who jointly own or rent the property) the household reference person is the person with the highest annual income. The definition is for analysis purposes and does not imply any authoritative relationship within the household.



## 3.2 CHARACTERISTICS OF THE HOME AND AREA

### *Length of time living in the Hilden area*

Almost half (45; 47%) of respondents had lived in their present home for more than 15 years at the time of the survey. Almost one-fifth (17; 18%) had lived in their present home for one year or more but less than five years (Appendix Table 10).

At the time of the survey almost half (47; 49%) of respondents lived outside the local area but within Lisburn City Council before their present home and more than one-third (34; 35%) had lived in the same local area (Hilden) (Appendix Table 11).

Four-fifths of respondents (77; 80%) stated they were unlikely to move from the local area in the next two years. Nine per cent (9 respondents) reported that they were likely to move and one-tenth (10; 10%) were undecided. Reasons given by respondents for moving away varied from needing a bigger house, would like to buy a property and employment reasons (Appendix Table 12).

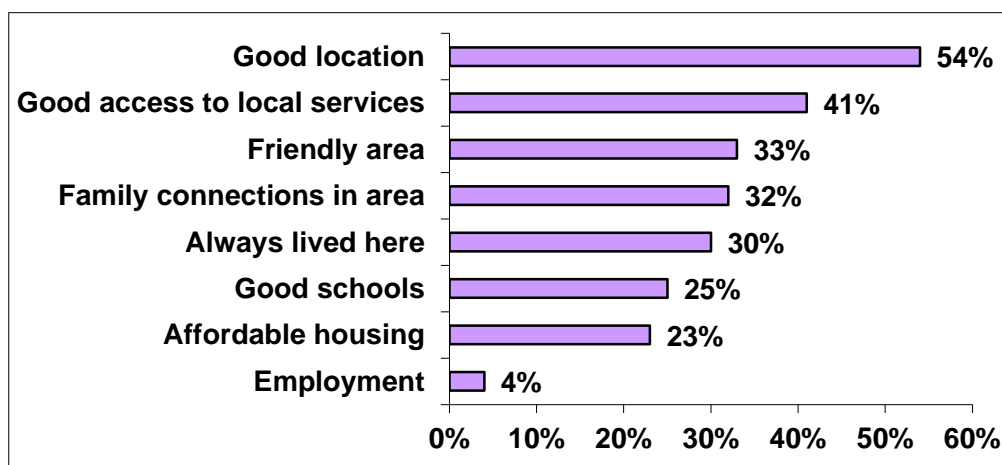
### *Dwelling tenure*

Almost three-fifths (57; 59%) of respondents owned their own home; more than one-quarter (25; 26%) rented from the Housing Executive; more than one-tenth (12; 13%) rented from a private landlord and the remaining two per cent (2 respondents) rented from a housing association at the time of the interview (Appendix Table 13).

### *Reasons for staying in the Hilden area*

Respondents were asked why they continue to stay in the Hilden area and included in the questionnaire was a list of reasons. In the event, the vast majority (95; 99%) stated at least one reason as to why they continued to stay the Hilden area.

**Figure 3.1: Respondents' reasons for staying in the Hilden area**



As Figure 3.1 above illustrates, the most common reason among respondents for staying in the Hilden area was because they felt it was a 'good location' with more than half (52; 54%) stating that this was the case. More than two-fifths (39; 41%)

stated it was 'good access to local services' and one-third (32; 33%) stated it was a 'friendly area' as reasons for staying in the Hilden area; 'employment' was the reason least cited among respondents (4; 4%) (Appendix Table 14).

### ***Community spirit in the Hilden area***

Respondents were asked to gauge the level of community spirit in the Hilden area. Almost three-quarters (69; 72%) of respondents felt that community spirit in their area was either 'very good' or 'good'; nearly one-quarter (22; 23%) felt it was 'neither good nor poor'. A small proportion (2; 2%) felt community spirit in the area was either 'poor' or 'very poor'; three per cent (3 respondents) did not know of the level of community spirit in the area (Appendix Table 15).

## **3.3 SERVICES AND FACILITIES**

### ***General services and facilities***

Respondents were asked about a number of services and facilities in their area and whether they found them satisfactory or unsatisfactory. The majority of respondents found many of the services and facilities in the area satisfactory. For example, all respondents (100; 100%) found the 'primary school', 'chemists' (95; 99%), 'secondary school' (94; 98%), 'higher/further education' (93; 97%), 'emptying of wheelie bins' (91; 95%), 'advice services' (90; 94%), 'adult education' (89; 93%) and 'sport/leisure services' (88; 92%) satisfactory. Conversely, more than half (51; 53%) of respondents stated that 'dog fouling' in the area was unsatisfactory. One-third of respondents also found 'car parking' (32; 33%), 'policing in the area' (29; 30%); 'repairing of roads and pavements' (27; 28%) and 'street lighting' (16; 17%) to be unsatisfactory (Appendix Table 16).

### ***Level of awareness and use of the Hilden Community Association***

When asked if they were aware of Hilden Community Association, more than two-thirds (65; 68%) reported they were aware; less than one-third (31; 32%) were not aware. Of those respondents who stated that they were aware of the community association (65; 68% of all respondents) one-fifth (13; 20%) said they attended or used activities/facilities provided at the community centre. Respondents who reported not attending/using activities/facilities were asked an open-ended question as to why. In the event, 52 respondents made 52 comments, the most common reasons given include: not aware of what Hilden community association provides (16 respondents), never felt the need to use it (11 respondents), not enough time (7 respondents) and not interested or too old (2 respondents), (Appendix Tables 17 to 18b).

### ***Future community events/activities/projects***

Respondents were asked what events/activities/projects they or any member of their household would choose to attend/use if it were provided locally. Similar proportions of respondents said a 'summer festival' (39; 41%) and 'keep fit' (38; 40%) was the event/activity/project had the highest level of interest. Equal

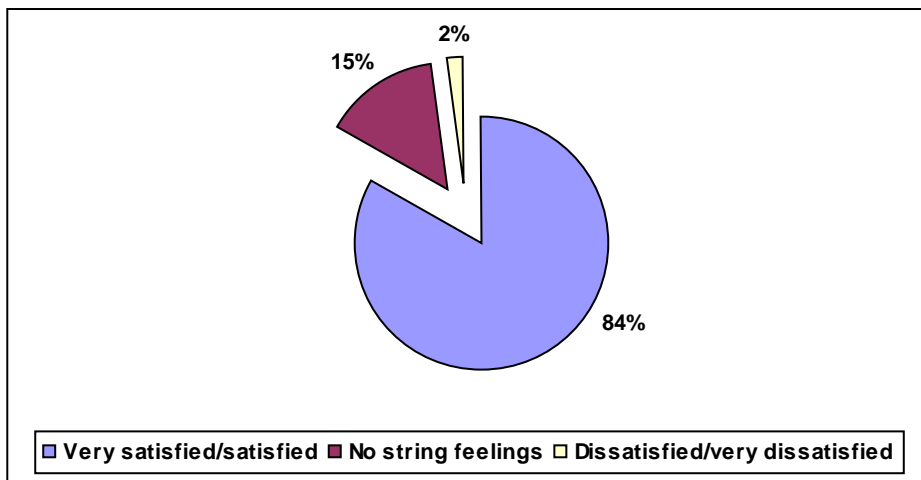
proportions (32; 33% in each case) would attend either a ‘community centre’ or ‘football’. Survey findings show respondents would be least likely to attend a ‘women’s group’ (17; 18%) and ‘youth drop-in’ (17; 18%) (Appendix Table 19).

***Satisfaction with Hilden as a place to live***

Respondents were asked to rate their overall satisfaction of the Hilden area as a place to live. As Figure 3.2, shows, more than four-fifths (80; 84%) of all respondents were either ‘very satisfied’ or ‘satisfied’ with the Hilden area as a place to live; more than one-tenth (14; 15%) had ‘no strong feelings’. Two per cent (2 respondents) were either ‘dissatisfied’ or ‘very dissatisfied’ (Appendix Table 20a).

Respondents were asked to state any changes they would like to see in the Hilden area. In total 41 respondents (46%) gave 65 comments. Of these, eight themes emerged which were each commented on by up to nine respondents: tidy up the area (9 respondents) more traffic calming measures (8 respondents), more parking (7 respondents), regenerate the main street/local shopping area (7 respondents), more police presence (4 respondents), more facilities for children/young people (4 respondents), more pedestrian crossings (3 respondents), more social housing (3 respondents), more measures to tackle dog fouling (3 respondents) (Appendix Table 20b).

**3.4 ATTITUDES TO COMMUNITY RELATIONS**

***Perceptions of community relations***

In the first instance, respondents were asked how concerned they were about relations between people of different community backgrounds in the Hilden area. Almost four (76; 79%) of respondents were ‘not very concerned’ or ‘not at all concerned’. More than one-fifth (20; 21%) were either ‘very concerned’ or ‘slightly concerned’. The main reason for concern was ‘a continuing community divide’ (Appendix Tables 21a and 21b).

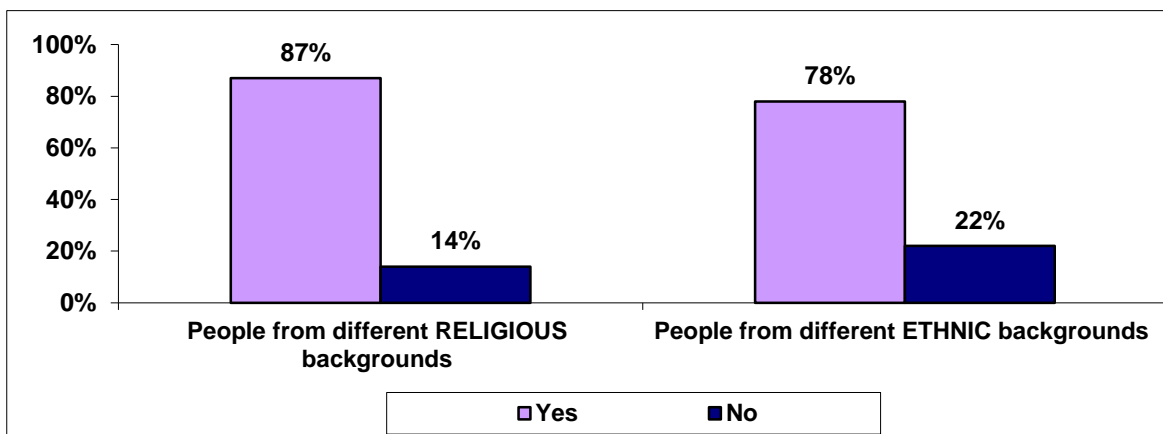


In terms of levels of concern between people of different community backgrounds in Northern Ireland as a whole; more than two-thirds (65; 68%) were either 'not very concerned' or 'not at all concerned', almost one-third (30; 32%) of respondents were either 'very concerned' or 'slightly concerned' about Northern Ireland as a whole rather than their own area. Respondents were asked to state why they were concerned. In total 30 respondents (32%) gave 30 reasons why. Three themes emerged which were each commented on by four or more respondents and related to concerns that Northern Ireland is not as inclusive as it should be (18 respondents); negative attitudes towards foreign nationals (8 respondents) and a continuing community divide (Protestant/Catholic)(4 respondents) (Appendix Table 22a and 22b).

***Mixing with people from different backgrounds***

In order to measure respondents' attitudes to mixing with people from different backgrounds respondents were asked if they would attend events/activities/projects which would include people from different backgrounds. As Figure 3.3 below shows, more than four-fifths (83; 87%) of respondents stated they or a member of their household would attend shared events/activities/projects which would include people from different *religious* backgrounds. Fewer (75; 78%) stated that they or a member of their household would attend shared events/activities/projects which would include people from different *ethnic* backgrounds (Appendix Table 23).

Respondents were also asked whether they already mixed frequently, sometimes, never or haven't had the opportunity to mix with people from a different community or religious background. At the time of the survey the majority (88; 92%) of respondents said that they or members of their household did mix with people from a different community or religious background (53; 55% 'frequently'; 35; 37% 'sometimes'); 7 per cent (7 respondents) stated they hadn't had the opportunity to do so and the remaining respondent (1%) stated they never mixed with people from a different community or religious background (Appendix Table 24).

### ***Perception of community relations in the Hilden area***

When asked about their perceptions of community relations in the Hilden area less than one-fifth (18; 19%) of respondents stated that community relations were 'getting better', more than half (52; 54%) felt they were 'about the same' and less than one-tenth (9; 9%) felt they were 'getting worse'. Almost one-fifth (17; 18%) of respondents were unsure how to gauge community relations in the area (Appendix Table 25).

### ***Community relations in the future in Northern Ireland***

In terms of future community relations in Northern Ireland as a whole, almost one-third (30; 31%) of respondents felt relations between people of different community backgrounds are better now compared to five years ago. Similarly almost one-third (31; 32%) of respondents felt relations between people from different backgrounds would be better in five years' time. (Appendix Table 26 and Table 27).

### ***Moving towards a more mixed community***

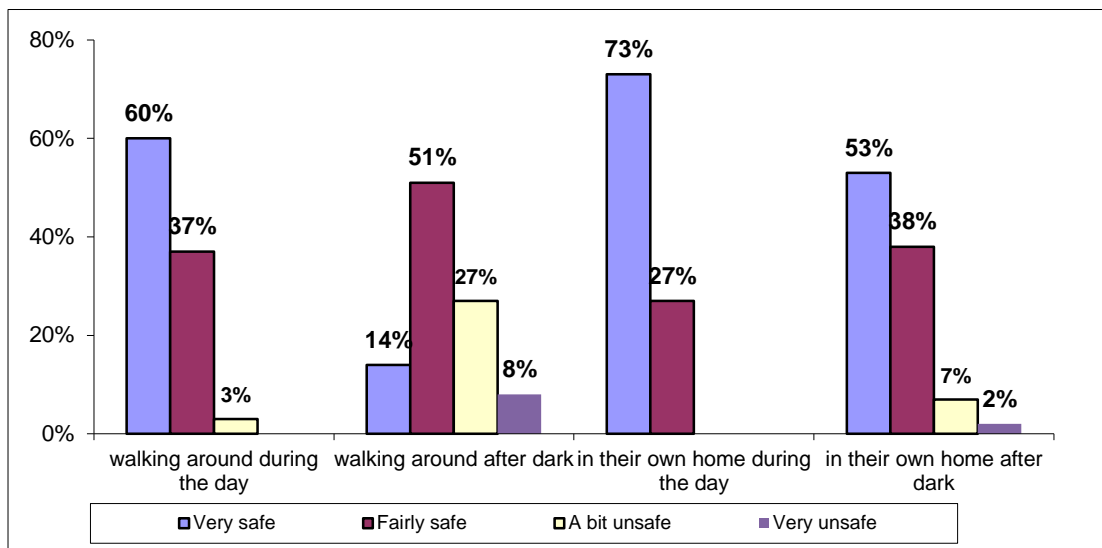
More than half (50; 52%) of respondents would be in favour of their area moving towards a more mixed community rather than predominantly Protestant; more than one-fifth (20; 21%) would not be in favour. However, more than one-quarter (26; 27%) of respondents were undecided (Appendix Table 28).

## 3.5 COMMUNITY SAFETY

### ***Perception of personal safety***

Respondents were asked about their feelings of personal safety in the Hilden area. As Figure 3.4 below illustrates, the majority (93; 97%) of respondents felt safe walking around the area during the day. Fewer (62; 65%) felt safe walking around the area after dark, (Appendix Tables 29 and 30).

All respondents (100; 100%) felt safe in their home during the day, and 91 per cent (87 respondents) felt safe in their home after dark ; although 9 per cent (9 respondents) did not feel safe in their own homes after dark (Appendix Tables 31 and 32).

Those respondents who reported not feeling safe to any of the pervious questions were asked an open-ended question regarding what would make them feel safer. In the event, 25 respondents made 25 comments. These were various and numbers are too small to report, however the main reason stated was 'more police presence' (17 respondents) (Appendix Table 33).

### ***Respondents' concerns within the Hilden area***

Respondents were given a list of issues that might affect residents living within any given neighbourhood and were asked whether they were concerned or not concerned about these issues within the Hilden area. Table 3.2 below shows that more than two-thirds (66; 69%) of residents were concerned about 'Burglary and theft' in the area and the same proportion (66; 69%) were concerned about 'Dog fouling'. Almost two-thirds of respondents were concerned with 'Attacks on elderly people' (60; 63%).

Respondents were least concerned about 'People making a noise (during the day)' (16; 17%) (Appendix Table 34).

### ***Keeping residents informed***

The majority (90; 94%) of respondents thought the best way to keep people aware of and interested in community activities in the area was through a community newsletter. A further four per cent (4 respondents) felt the best way to keep residents informed was through community meetings and the remaining two per cent (2 respondents) stated feedback from existing community groups as a best means (Appendix Table 35).

### **3.6 ADDITIONAL COMMENTS**

Finally, on completion of the questionnaire, all respondents were given the opportunity to make general comments about living in the Hilden area and/or the research being carried out. In total 24 respondents made 34 comments. The main comment from respondents was that they were happy living in the Hilden area (7 respondents) and that the area needed to be tidied up (5 respondents) (Appendix Table 36).

## 4.0 SUMMARY

- Survey findings show that ‘good location’ and ‘good access to local services’ were the most common reasons given for why respondents continued to live in the Hilden area.
- Survey findings also show that the majority of residents found many of the services and facilities in the Hilden area satisfactory. Dog fouling however, was the exception.
- Nevertheless, more than two-thirds were either ‘very satisfied’ or ‘satisfied’ with the Hilden area as a place to live, with only a small minority feeling dissatisfied. Although, when asked to state what changes they would like to see, the most common suggestions included tidying up the area, more car parking and more facilities for children.
- More than two-thirds were aware of the Hilden Community Association. However, of those respondents who were aware, only one-fifth reported using/attending any of the facilities/activities provided; the main reasons given for not using the facility was not aware of what Hilden Community Association provides.
- Whilst proportions were relatively small, there was some interest in possible future activities that could be provided locally and these included a ‘summer festival’ and ‘keep fit classes’.
- In terms of cross-community activities there was a willingness among residents to mix with people from different ethnic as well as religious backgrounds. Furthermore, the majority (88; 92%) of respondents reported that they already mixed with people from different community or religious backgrounds.
- In terms of living together, however, just more than half (50; 52%) would be in favour of their area moving towards a more mixed community rather than being predominantly Protestant.
- In general people feel safe in the Hilden area. However, far fewer respondents felt safe walking around the area at night than during the day; when asked what would make them feel safer, more police presence was the most common response.
- Moreover, the main concerns for residents in the area were ‘Burglary and theft’, ‘Dog fouling and ‘attacks on the elderly’.
- Lastly, almost three-quarters (69; 72%) of all respondents felt community spirit in the area was either ‘very good’ or good’, with the majority of respondents stating that a newsletter was the best way to keep residents informed of community activities.

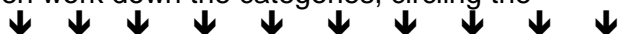
