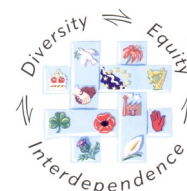

## Reflection and Years Ahead continued

The purpose of the events was to share the learning arising from our exploration of the first half of the decade of centenaries and to think about the challenges ahead and how we approach them. A similar format was used - dramatic input and its effectiveness, case studies focusing on grassroots activity, council programmes and council supported museum programmes, educations, outreach and creativity; and facilitated workshops. The ensuing discussion was informative and has provided much food for thought. A summary report is currently being drafted.

### **Eamon Phoenix ‘A Divided Ireland in a Dividing Europe’**

How we mark, or commemorate, the centenary events in the years to 2023 will be complicated and involve us in difficult conversations. The centenaries ahead are arguably the most challenging. Emerging from the afterglow of 1916, the rise of Sinn Fein and the fall of Redmond’s Irish Parliamentary Party and the March 1918 Irish Conventions, soldiers return from the Great War to a dividing Ireland in a dividing Europe.

## Survey of the Decade of Centenaries

## North Belfast Women’s Voices—Exploring Identity, Culture and the Future

The purpose of this research is to give voice to women in North Belfast, by capturing their lived experiences of 4 decades of conflict, which was disproportionately concentrated in this part of the city. As such, this study explores how the conflict has affected/impacted on them, their families, their community, and in turn, their geographical, and cultural relationships. This report will bear witness to the realities of women that are working in both single identity and/or cross community groups in this locality; women who are well versed in dealing with the grassroots issues that arise from cultural, social and political instability throughout the conflict. In sum, this study will highlight the issues that are of importance to them in terms of culture, identity, and flags, whilst sketching out a number of recommendations which the women themselves feel are required to move their community forward namely in terms of dealing with paramilitaries, funding for work with women and young people, housing and political leadership

## Remembering '68: The Civil Rights Movement in Northern Irish Memory

*Are you a '68er? Did you go to university in Northern Ireland during the 1960s? Were you an activist in the civil rights movement or counter-movements? If so, the 'Remembering '68' project would like to interview you!*

This project explores how the civil rights movement is remembered in Northern Ireland. Issues of civil rights, past and present, remain vital to the contested political culture in Northern Ireland. Since 1998, society in Northern Ireland has been marked by a tendency towards divided memory. Events, such as those during the civil rights movement, which are often referred to as the start of the conflict have been interpreted in contrasting ways and the facts themselves are often disputed. There has been very little consensus about what happened, why it happened, and crucially, how to remember what happened. Even *within* communities, there has been a tendency to promote one set of memories over others. The overall aim of this research project is to create a many-voiced oral history archive about the civil rights movement, and to explore its wide-ranging legacies which would have the potential to present non-violent alternatives of engaging in politics in the region and encourage reaching out to communal rivals. The initial research questions are:

1. *How do men and women of different generations, social positions, religious identities, and political views narrate their experience of the civil rights movement?*
2. *How did participation in student activism affect the participants' identities and their subsequent activism? And how did the transformation of this '68 generation manifest itself in Northern Ireland?*
3. *How do participants evaluate the achievements and failures of the civil rights movement?*
4. *Does the 1998 Good Friday Agreement, recent economic problems, and failure to address issues relating to the legacies of the conflict influence recollections of the past?*

Ulster University have been at the forefront of offering postgraduate studies in Peace and Conflict Studies for the past 25 years. From the 2017/18 academic year (starting in September 2017), the Postgraduate Diploma / Masters Degree is being offered on the Jordanstown campus, Belfast. The programme is delivered by academics based within INCORE (International Conflict Research Institute) and draws on the expertise of a range of policymakers and practitioners working on peacemaking and peacebuilding efforts in Northern Ireland and internationally.

This programme has a strong focus on post-violence peacebuilding, which is appropriate given that it is rooted in a society emerging from decades of protracted violence. However, the geographical scope of INCORE's work in research, policy, and practice is both local and global and this is reflected in the modules offered on the programme. The overall approach seeks to develop the critical, theoretical and analytical skills necessary for working in conflicted societies – in ways that are grounded in real life application and case studies. Students of this programme are well placed to follow a number of distinct career opportunities, based on their specific interests and core strengths. The past decades have seen tremendous changes in the global context. As a result, the demand for well-trained individuals to work on the myriad of peace and conflict issues continues to rise. The knowledge and capacities developed by INCORE peace and conflict studies students are transferrable across sectors and regions, making their skill set mobile and flexible within a globalised job market.

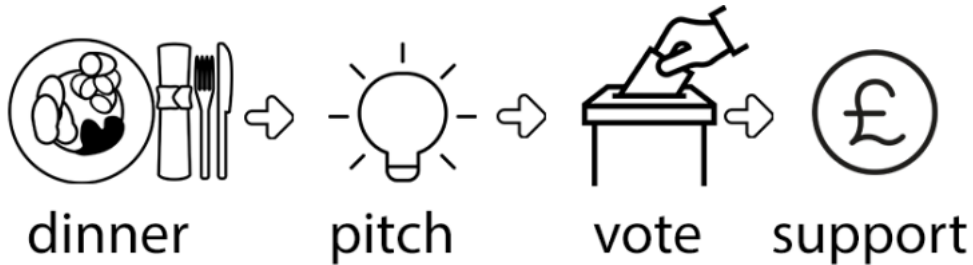

### Free schools workshops to explore the Battle of Messines



Creative Centenaries will launch a new graphic novel resource on the Battle of Messines in May to mark the centenary of the First World War campaign that took place in June 1917.

To mark the launch of the new educational resource, a programme of free digital workshops for schools will take place at the Public Record Office of Northern Ireland (PRONI) on May 31, June 6 and June 8.

Using the new graphic novel, students will learn about the battle through the experiences of soldiers William Redmond and John Meeke from the 16th (Irish) and 36th (Ulster) Divisions respectively.

The attack is particularly remembered in Ireland for the part played by both divisions who fought alongside each other.

Students can then choose from a digital workshop using stop motion animation to recreate the beginning of the battle or use digital comic book technology to design and feature in their own graphic novel story.

Workshops will take place at PRONI where schools can also receive a behind the scenes tour of PRONI's First World War archives and visit a travelling art installation inspired by the Battle of Messines. All participating students will also receive a free copy of the new Battle of Messines graphic novel.

#### Program overview

The summer institute will focus on the enormous achievements of local activists and agencies in bringing Armagh to its current state of peace, through years of community dialogue, negotiation and with the formation of new institutions and processes.

Representing a chance for participants to engage with local peace-builders, this ten-day program aims to deliver mutual benefits for participants and locals. Students learn about the Northern Ireland conflict, get an intimate perspective of the methods and practices used to address this dispute and in dialogue with local practitioners, and critically evaluate their effectiveness in Northern Ireland and their utility in other contexts.

The program will be led by Professor Marie Breen-Smyth, a native of Northern Ireland who has written extensively about conflict in Northern Ireland and elsewhere. The Institute's faculty contains a range of experts and practitioners from Northern Ireland and the US and is organized in partnership with a consortium of Armagh community groups led by the charity Diversity Challenges working on conflict resolution, reconciliation and storytelling. The local consortium will organize the logistics and participate in classes and visits. There will be a mixture of local and international participants who are working on peace-building thus facilitating learning, exchange of local and international perspectives and networking opportunities.

The ten-day institute will focus on the achievements of the past and the key contemporary challenges still facing peace-building in Northern Ireland: dealing with the past and provision for victims: memorials; parading; flags and paramilitaries. The program will begin with a survey of the issues, with expert speakers on each topic and then focus in more detail on two of these issues: dealing with the past and parading.

Local participants can either stay in en-suite accommodation in the Charlemount Hotel or attend daily and classes will be held in the hotel or on site at venues. In addition, the program includes visits to Belfast, with a tour of the city's peacelines and political murals.
