## **NI MOVES UP EU PRICES LEAGUE TABLE**

HE EU Deadweight Cattle Prices League Table provides a useful comparison of the prices paid at the farmgate for R3 grade heifers across the EU.

During the w/e 23 April 2017 the average R3 heifer price in the EU was 384.6c/kg, an increase of 2.6c/kg from the w/e 26 March 2017 when the average price was 382c/kg. It is also slightly higher than the corresponding week in 2016 when the average R3 heifer price in the EU was 378.1c/kg.

Sweden continues to maintain first place in the EU league table with an average R3 heifer price the equivalent of 447.1c/kg. However despite remaining in first position in the league table the R3 heifer price in Sweden was back by the equivalent of 27.8c/kg from the w/e 26 March 2017.

With an R3 heifer price the equivalent

of 420.5c/kg GB moved up one position in the league table into second place in the week ending 23 April 2017. This is an increase of 14c/kg from the w/e 26 March 2017 when it was 406.5c/kg.

While a firming in the deadweight cattle trade in the UK has contributed to this notable increase in deadweight prices the uplift in euro terms has also been partly driven by a weakening in the value of euro against sterling. In the week ending 26 March 2017 €1=  $\pm 0.866$  and in the w/e 23 April 2017 this had come back to €1=  $\pm 0.839$ . This accounts for a 3.2 per cent decline in the value of the euro against sterling.

Deadweight prices for R3 grade heifers in NI have also recorded an improvement due to a firmer deadweight cattle trade and a weaker euro. In NI the R3 heifer price was the equivalent of 417.7c/kg in the w/e 23 April 2017, an increase of 14.2c/kg from the previous month when it was the equivalent of 403.5c/kg. This put the R3 heifer price in NI 33.1c/kg above the EU average price and 2.8c/kg below the GB price in the w/e 23 April 2017. NI is in third position in the league table in the w/e 23 April 2017, up one position from the previous month.

Meanwhile in ROI a firming in the deadweight cattle trade has placed it in fourth position in the EU league table in the w/e 23 April 2017. This has moved it up from seventh position in the w/e 26 March 2017. The R3 heifer price in ROI was 405.9c/kg during the w/e 23 April 2017, up by 14.7c/kg from the previous month. The R3 heifer price in ROI was 11.8c/kg lower than the equivalent price in NI during the w/e 23 April 2017 and 21.3c/kg higher than the average EU R3 heifer price.

## UKECP TO HOST CHINESE DELEGATION

RECT access for the UK to the valuable Chinese market for beef will be one step closer next week following a study tour of UK beef production controls by Chinese officials. The study tour is being facilitated by the UK Export Certification Partnership (UKECP) and includes visits to factories, feed mills, competent authorities, farms and government laboratories across the UK.



Gaining access to important markets beyond the EU in Asia, Northern America and the Middle East is a key priority for Northern Ireland's meat exporters. This access to third country markets has become increasingly important in recent times following the decision by the UK to leave the EU and the uncertainty that surrounds continued access to this market outlet.

LMC plays a strategic role facilitating the opening of new markets through its membership of the UKECP. LMC is a co-founder of this joint industry/government programme, the aim of which is to establish access for UK red meat products into third country markets.

## DECLINE IN CONFORMATION SCORES OF PRIME CATTLE KILL IN QUARTER 1

URING the first quarter of 2017 there was a general downward movement recorded in the conformation scores awarded to prime cattle killed in local plants.

Analysis of the price reported steer kill has indicated that during the 2017 period 18.2 per cent of steers achieved a U grade compared to 21 per cent of the kill during the corresponding period in 2016. The proportion of steers achieving an R grade during the 2017 period accounted for 36.8 per cent of the steer kill during Q1, back from 38.5 per cent of the kill in Q1 2016.

Meanwhile there was an increase in the proportion of both O and P grading cattle in the NI price reported steer kill. O grading steers accounted for 33.9 per cent of the kill in the 2017 period, up from 30.7 per cent in the 2016 period. P grading steers accounted for 10.8 per cent of the kill in the 2017 period, up from 9.4 per cent from year earlier levels.

This general decline in conformation scores achieved coincides with a reduction in the average carcase weight of price reported steers. During Q1 2017 the average steer carcase weight was 350kg, back from 357kg in Q1 2016. This decline by 7kg represents a 2 per cent decline in the average carcase weight year on year and has occurred despite no change in the NI slaughter mix. In the 2017 period 61 per cent of steers were of suckler origin, 23 per cent were beef crosses from the dairy herd and the remaining 16 per cent were dairy males.

The downward movement in conformation scores awarded can also be observed in the



During the 2017 period 16.5 per cent of price reported heifers achieved a U grade compared to 22 per cent of heifers during the corresponding period in 2016. The proportion of R grading carcases also recorded a decline from 49.7 per cent of the kill in the 2016 period to 47 per cent in the 2017 period.

As with the price reported steer kill the proportion of heifer carcases awarded an 0 or P grade recorded an increase. In the first quarter of 2017 30.2 per cent price reported heifers were awarded an 0 grade, a 7 percentage point increase from the 2016 period when 23.2 per cent of heifers were in this category. Meanwhile the proportion of P grades

recorded a slight increase to account for 6.1 per cent of the reported heifer kill in the 2017 period.

The average heifer carcase weight also recorded a 7kg decline year on year to 317kg in the 2017 period. However unlike the steers there was a slight shift in the source of heifers killed in local plants which may have contributed to changes in the conformation scores. Suckler origin heifers accounted for 69 per cent of the kill in the 2017 period, back 3 percentage points from 2016 levels when 72 per cent of heifers were of suckler origin. Meanwhile beef cross heifers from the dairy herd accounted for 25 per cent of the kill in the 2017 period, up from 23 per cent in Q1 2016.

#### Deadweight Cattle Trade

THE deadweight cattle trade in NI has remained firm with base quotes for U-3 grade prime cattle this week ranging from 346-354p/kg. The majority of plants are quoting from 350-354p/kg for in spec cattle however with reports of higher prices available producers should use these quotes as a starting point for negotiation. Quotes for good quality 0+3 grade cows ranged from 250-264p/kg across the plants this week. A slight increase in quotes is expected for all types of cattle early next week.

Throughput of prime cattle in NI plants last week totalled 6,626 head, the highest weekly throughput since the first week of March this year. The plants have reported steady supplies of prime cattle coming forward for slaughter to meet demand from their major customers. Cow throughput in NI last week totalled 1,671 head taking throughput for the year to date to 30,646 head. This is an increase of 1,500 head from the corresponding period in 2016.

Imports of prime cattle from ROI for direct slaughter in NI plants last week totalled 223 head with 50 cows also imported. A further 8 prime cattle and 91 cows were imported from GB for direct slaughter in NI plants last week. There were no cattle exported from NI for slaughter in GB plants last week while 47 prime cattle and 141 cows were exported to ROI for direct slaughter.

The deadweight cattle trade in NI continued to firm last week with the average steer price up 1.5p/kg to 347.7p/kg while the R3 steer price was up marginally to 357.3p/kg. The average heifer price in NI last week was 347.8p/kg, up marginally from the previous week, while the R3 heifer price was 355.2p/kg, up 1.8p/kg. Reported deadweight prices for young bulls also improved in NI last week with the average young bull price up by 6p/kg to 334.6p/kg. The R3 young bull price in NI last week was 348.5p/kg, up 6.8p/kg from the previous week. The cow trade has meanwhile remained fairly steady with the average cow price up by 1p/kg to 248.7p/kg.

The deadweight trade for prime cattle also continued to improve in GB last week with the average steer price up by 1p/kg to 350.4p/kg. Average steer prices increased in Scotland, Northern England and Southern England last week while they came back in the Midlands. The average R3 steer price in GB last week was 359.7pkg, up by 1.7p/kg from the previous week. The average heifer price in GB last week was up by 2.3p/kg to 352.3p/kg while the average R3 heifer price was up by 4.1p/kg to 359.9p/kg. The cow trade firmed in all the GB regions last week with the average cow price up by 5.2p/kg to 240.4p/kg.

The R3 steer price in ROI last week increased by the equivalent of 5p/kg to 336.9p/kg while the R3 heifer price increased by 4.1p/kg to 346.5p/kg. The cow trade also firmed in ROI last week with the O3 cow price up by 4.3p/kg to 279.3p/kg. This is 14.3p/kg higher than the equivalent price in NI. Prime cattle throughput in ROI last week totalled 24,342 head while 6,422 cows were also slaughtered.

#### Deadweight Sheep Trade

UOTES from the major processors for R3 grade hoggets this week ranged from 400-415p/kg up to 22kg however the plants have indicated that the hogget season is coming to an end. Quotes for spring lambs this week were in the region of 450-460p/kg up to 21kg with similar quotes expected for early next week. Hogget/lamb throughput in NI last week totalled 5,209 head while a further 5,012 sheep were exported to ROI for direct slaughter. The deadweight hogget price in NI last week was up 4.1p/kg to 404.7p/kg while the deadweight lamb price was back by 1p/kg to 442.1p/kg. In the same week last year the deadweight lamb price in NI was 414.7p/kg. In ROI last week the combined hogget/lamb deadweight price was up by 17.3p/kg to 424.7p/kg due to an increased proportion of spring lambs in the slaughter mix.

#### This week's marts

HE number of hoggets passing through the sale rings has continued to decline in line with normal seasonal trends while the number of spring lambs on offer has remained subdued across many of the marts. In Massereene on Monday 129 hoggets sold from 380-412p/kg while 207 spring lambs sold from 400-436p/kg. This compares to 380 hoggets selling from 360-395p/kg and 104 spring lambs selling from 400-430p/kg the previous week. In Rathfriland on Tuesday 141 spring lambs sold to an average of 422p/kg compared to 160 spring lambs the previous week selling to an average of 432p/kg. In Ballymena on Wednesday 251 hoggets sold to an average of 330p/kg while 198 spring lambs sold to an average of 405p/kg. The ewe trade weakened this week with top reported prices generally ranging from £95-110.

## LMC TO MARK DOUBLE CELEBRATION AT BALMORAL SHOW 2017

Farmers coming on to the LMC stand at Balmoral will also receive a realistic perspective on what Brexit has to hold for our beef and sheep sectors.

Credit must be given where credit is due: Commission Chairman Gerard McGivern has been very clear, from the outset, regarding the respective challenges and opportunities that Brexit represents. And, no doubt, he and the other LMC board members will have their thoughts on this subject further refined by the time we get around to show time.

Recent weeks have seen the Commission appointed by DAERA to co-ordinate the BVD PI Removal Incentivisation Scheme. It goes without saying that any farmer with any queries on the matter should make a bee line for the LMC stand. It will be fully manned throughout the four days of the event.
