CONSUMER PURCHASING OF MEAT EASES BACK IN LATEST KANTAR DATA

NALYSIS of the latest available data from Kantar has indicated a decline in the volume and value of sales of all types of meat in NI retailers during the 12 week period ending 17 June 2018 when compared to the same period in 2017.

The volume of retail meat sales in NI totalled 12,461 tonnes during the 12 weeks ending 17 June 2018, a five per cent decline from the same period in 2017. Meanwhile the value of meat sales in the region totalled £70.6 million in the 2018 period, back 4.3 per cent from the £73.7 million spend on meat in the same period in 2017.

Beef sales

The volume of retail beef sales in NI totalled 3,454 tonnes during the 12 week period ending 17 June 2018, a 9.2 per cent decline from the same period in 2017 when 3,803 tonnes of beef were sold locally. The volume of all the major beef cuts including frying/grilling steaks, roasting joints and stewing pieces recorded notable declines in volume sales when

compared to the corresponding period in 2017.

Mince sales meanwhile held steady in NI during the 12 weeks ending 17 June 2018 when compared to year earlier levels. Mince continues to be the most popular type of beef sold in the major retailers in NI as outlined in Figure 1. In terms of volume mince sales accounted for 45 per cent of total retail beef sales during the 12 weeks ending 17 June 2018. This was an increase from 41 per cent of sales in the same period in 2017 however it was a similar proportion to 2016 levels.

While volume sales of beef in NI have declined during the 2018 period this was off the back of a very strong sales during the corresponding 12 week period in 2017. Volume sales of beef during the 2018 period were only 1.6 per cent lower than the corresponding 12 week period in 2016.

The strong decline in the volume of beef sales locally has been offset to some degree by an increase in the average retail price of beef. In the 12 week period ending 17 June 2018 the average retail price of beef was £7.96/kg. This was 47p/kg higher than the same period in 2017 when the average retail price was £7.49/kg and 56p/kg higher than the same period in 2016 when the average retail price was £7.40/kg.

Retail beef sales were valued at £28.5 million in NI during the 12 weeks ending 17 June 2018. This was a 3.6 per cent decline from the corresponding period in 2017 when retail beef sales in the region were valued at £28.5 million. However the value of beef sales in NI during the 12 week period ending 17 June 2018 was 5.7 per cent higher than the corresponding period in 2016 when sales were valued at £26 million.

Lamb sales


Lamb remains a minority meat in NI with retail lambs sales totalling 702 tonnes during the 12 week period ending 17 June 2018. This meant lamb accounted for 5.9 per cent of total meat sales in NI in terms of volume during

this period. The volume of retail lamb sales in NI during the 2018 period was seven per cent lower than the corresponding period in 2017.

During the 2018 period the value of retail lamb sales in NI was £4.9 million, back 13 per cent from the same period in 2017 when the total retail spend on

lamb in NI was £5.7 million. Much of this decline in the total value of sales has been driven by a drop in the average retail price of lamb. In the 12 weeks ending 17 June 2018 the average retail price of lamb in NI was £7.04/kg compared to £7.50/kg in the same period in 2017.

POOR GRASS GROWTH IMPACTING LAMB PERFORMANCE

HE on-going dry weather and difficult grass growing conditions have had an impact on lamb performance on many NI farms. In addition to longer production times the major processors are reporting an increase in the number of underfinished lambs being presented for slaughter in recent weeks.

Meeting market specifications at point of slaughter will help maximise returns from finishing lambs. The current specification from the major processors is for R grading lambs or better with a fat score of 2 or 3 and a carcase weight of 21kg. Processors also have a strong preference for lambs with FQ status with bonuses available in some plants while other plants will not handle non assured lambs.

Analysis of sheep price reporting figures indicated that while lambconformation scores have remained similar to previous years the level of fat cover has shown a slight decline. During the four weeks ending 29 July 2018 29 per cent of price reported lambs in NI achieved a fat class two, this was an increase from 26 per cent a during the same period last year. Meanwhile the proportion of lambs achieving a fat class three decreased from 69 per cent in the 2017 period to 66 per cent in the 2018 period.

Lamb output from the NI sheep flock has also been impacted by the dry weather conditions with lambs taking longer to finish than usual. A total of 32,276 lambs were killed in local plants during the four weeks ending 29 July 2018. This is a notable 19 per cent decline from the corresponding period in 2017.


During the four week period ending 29 July 2018 the average lamb carcase weight in NI was 20.9kg, up marginally from the corresponding period in 2017 when the average carcase weight was 20.8kg. With lower lamb throughput and carcase weights almost unchanged the volume of lamb processed in NI during the four weeks ending 29 July 2018 was 26 per cent lower than the same period last year.

Meanwhile there has also been an increase in the number of lambs being exported from NI for direct slaughter in plants in ROI. During the four weeks ending 29 July 2018 26,198 lambs were exported, a 14 per cent increase from the same period in 2017 when 22,911 lambs were exported. This puts the combined lamb output from the NI sheep flock at 58,474 head over the last four weeks compared to 61,336 head in the corresponding period last year. This accounts for a five per cent decline year on year.

Reports from GB have indicated that very high lamb mortality rates during spring 2018 are having an impact on the availability of lambs for slaughter in GB plants. While no figures are currently available for lamb mortality in NI the difficult production conditions earlier this year may also be impacting the availability of lambs for slaughter locally.

Lamb slaughterings in GB during June 2018 (latest available figures) totalled 841,949 head, a notable 16 per cent decline from June 2017 levels. Meanwhile in ROI lamb throughput in the last four weeks has totalled 197,795 head. This is a one per cent decline from the same period last year.

Deadweight Cattle Trade

ASE quotes from the plants for U-3 grade prime cattle this week ranged from 348-352p/kg with the majority of plants quoting 350p/kg for steers and heifers. Similar base quotes are expected for Monday. Quotes for good quality 0+3 grade cows ranged from 252-270p/kg this week with the majority of plants quoting in the region of 260-270p/kg.

The plants have reported steady supplies of cattle to meet demand for beef with throughput of prime cattle last week totalling 5,750 head. This was a decrease of 357 head from the previous week and 295 head higher than the 5,455 head killed during the same week last year. Throughput of prime cattle in the local plants during July totalled 23,048 head, an eight per cent increase from July 2017 levels when 21,359 prime cattle were killed in local plants. Cow throughput in NI last week also held steady at 2,219 head which brings cow throughput for July 2018 to 7,998 head. This is a 12 per cent increase on the 7,140 cows killed in local plants during July 2017.

Prime cattle imports from ROI for direct slaughter last week totalled 78 head with five cows also imported. Imports from GB for direct slaughter consisted of 12 prime cattle and 129 cows. Meanwhile cattle exports from NI for direct slaughter in ROI last week included seven steers, 198 cows and 14 bulls. A total of 67 prime cattle and seven cows made the journey to GB for direct slaughter.

The NI deadweight trade for prime cattle continued to come under pressure last week with the majority of prices reported indicating a decline compared to the previous week. The average steer price was back by 0.7p/kg to 350.6p/kg while the R3 steer price decreased by a penny to 360.3p/kg. The average heifer price last week was also back by 1.3p/kg to 352.2p/kg while the R3 heifer price decreased by 1.6p/kg to 358.1p/kg. Meanwhile the cow trade continued to come under pressure with the average cow price back 3.2p/kg to 255.3p/kg. The O3 cow price last week was back by 5.1p/kg to 273.4p/kg.

The deadweight trade for prime cattle also continued to come under pressure in all of the GB regions last week. The average steer price was back by 4p/kg to 359.1p/kg last week while the R3 steer price reported a decline of 2.9p/kg to 367p/kg. The R3 steer price recorded a strong decrease in Scotland where it was back by 4.8p/kg to 377.8p/kg. The average heifer price in GB last week was 360.9p/kg, back 3.3p/kg from the previous week while the R3 heifer price was back 5.1p/kg to 366.9p/kg. The R3 heifer price reported the strongest decline in Midlands and Wales where it was back 8.2p/kg to 362.4p/kg.

The deadweight cattle trade has also continued come under pressure in ROI with prices reporting declines in all cattle grades. The R3 steer price was back by 2.6p/kg to the equivalent of 342.3p/kg while the R3 heifer price was back by 3.2p/kg to the equivalent price of 351.9p/kg. This puts the differential between ROI and NI at 6.2p/kg or £20 on a 320kg carcase.

Deadweight Sheep Trade

HE NI deadweight trade for lambs improved early in the week with quotes from the plants ranging from 410-420p/kg up to 21kg. Similar quotes are expected for early next week. Lamb throughput in NI plants last week totalled 9,802 head, an increase of 762 lambs from the previous week. A further 9,441 sheep were exported from NI to ROI for direct slaughter which takes total exports for July to 32,565 head. In the same period last year 28,339 sheep were exported to ROI. The deadweight lamb price in NI last week was 399.2p/kg, back by a smaller margin of 2.9p/kg from the previous week. In ROI last week the deadweight lamb price was the equivalent of 473.7p/kg, up half a penny from the previous week.

This week's marts

00D numbers of lambs passed through the marts this week with the live trade strengthening. In Massereene on Monday 1,067 lambs sold from 380-405p/kg compared to 1,005 lambs last week selling from 365-392p/kg. In Saintfield this week 904 lambs sold from 365-416p/kg compared to 977 lambs last week selling from 353-389p/kg. In Rathfriland on Tuesday 751 lambs sold from 352-398p/kg (avg 381p/kg) compared to 660 lambs last week selling from 343-392p/kg (avg 369p/kg). In Enniskillen on Wednesday 842 lambs sold from 364-409p/kg compared to 500 lambs last week selling from 347-402p/kg. A large entry of 1,340 lambs in Markethill this week sold from 355-382p/kg compared to 800 lambs last week selling from 370-400p/kg. The ewe trade remained steady this week with top reported prices ranging from £80-120.

THREE LMC BOARD MEMBERS HAVE TERMS **EXTENDED**

MC is delighted to confirm that The Department of Agriculture, Environment and Rural Affairs (DAERA) has announced a six month extension to the term of appointment for three members of the LMC Board until 30 December 2018.

The Livestock and Meat Commission board Members are appointed by the Minister of Agriculture, Environment and Rural Affairs (who also appoints the Chairman) for three-year terms. There are currently six members of the Board including the Chairman.

The Board has corporate responsibility for ensuring that LMC fulfils the aims and objectives set by DAERA and approved by the Minister, and for promoting the efficient, economic and effective use of staff and other resources by LMC.

Harry Sinclair, Jim Lennon and Oonagh Chesney were first appointed to the LMC Board on 01 July 2015 and the extensions to their terms have been made in accordance with the Commissioner for Public Appointments' Code of Practice.

Harry Sinclair is a suckler cow, beef and sheep farmer and as a past President of the UFU, he has extensive experience of advocacy on behalf of the farming community. He has served as Chairman of the UFU's Hill Farming and Beef and Lamb Committees and is a founder member of the Farm Safety Partnership.

Harry has served as Vice-President of the Committee of Professional Agricultural Organisations ("COPA") and has represented the UK on the EU Commission's Sheep and Beef Advisory Committees. He has also served as Chairman of AgriSearch's Beef Committee and as a producer representative on the Red Meat Taskforce.

Jim Lennon is a beef farmer specialising in the production of Aberdeen Angus cattle and is also involved in the Derrynoose Farming Community Group which promotes investment and training in livestock production. He has significant wider senior public sector experience shown in both his current role as Head of Corporate Service for Middletown Centre for Autism and various senior roles in the National Health Service.

Oonagh Chesney is Company Secretary for Fane Valley Co-op Society Ltd and its group subsidiary companies including Linden Foods Ltd. She has an active role in the family beef farming business. She has represented Fane Valley on a number of bodies including the Area Based Strategy Action Group and cross community programmes in Armagh.

combines Oonagh marketing experience with a good understanding of the challenges facing the LMC and has brought her experience of red meat production and processing to the

work of the LMC Board.

FQAS REMINDER: NEW STANDARD FOR FOAS PARTICIPANTS WHO KEEP HORSES ON FARM

Quality Assurance Scheme (NIBL FQAS) has introduced new standards to prevent cross contamination of cattle and sheep with drugs administered to horses.

FQAS Manager Gillian Davis commented "Following the investigative work carried out by scientists at the Agri-Food and Biosciences Institute (AFBI) there are clear risks of inadvertently contaminating cattle/sheep through the use of Phenylbutazone (Bute). We would encourage farmers to take extreme care when using the non-steroidal anti-inflammatory drug Bute to treat horses.'

Bute is a highly effective treatment for inflammation and pain that can be injected intravenously or given orally as a powder or paste to horses. It is not authorised for use in any animal, including horses. destined for the human food chain.

Chairman of the FQAS Standard Setting Committee Ian Stevenson added that "In order to keep pace with the latest scientific advice available to us, raise awareness and to ensure robust standards on farm. the FOAS standards have been updated to capture this requirement. In June 2018 LMC issued an Addendum to the Northern Ireland Beef and Lamb Farm Quality Assurance Scheme Standard (April 2018), which highlights a new standard and associated guidance with regards to Phenylbutazone (Bute) and the cross-contamination risks on farms that have used Bute to treat horses and also keep cattle/sheep."

■HE Northern Ireland Beef and Lamb Farm FQAS inspectors will be inspecting against this requirement from 01 August 2018.

> The studies undertaken by AFBI, using Bute in its powder form have shown there may be crosscontamination of illegal residues in cattle arising through the use of:

- A shared bucket (i.e. if a horse was to be fed from a bucket containing Bute and then the same bucket used to feed cattle)
- A shared pen
- Through contaminated pasture (manure spread and cattle/sheep allowed to graze)



Bute is commonly used in the treatment of horses and many cattle and sheep farmers keep horses on the same holding, it is therefore critically important that those using the drug take extreme care to avoid contamination of their cattle/sheep.
