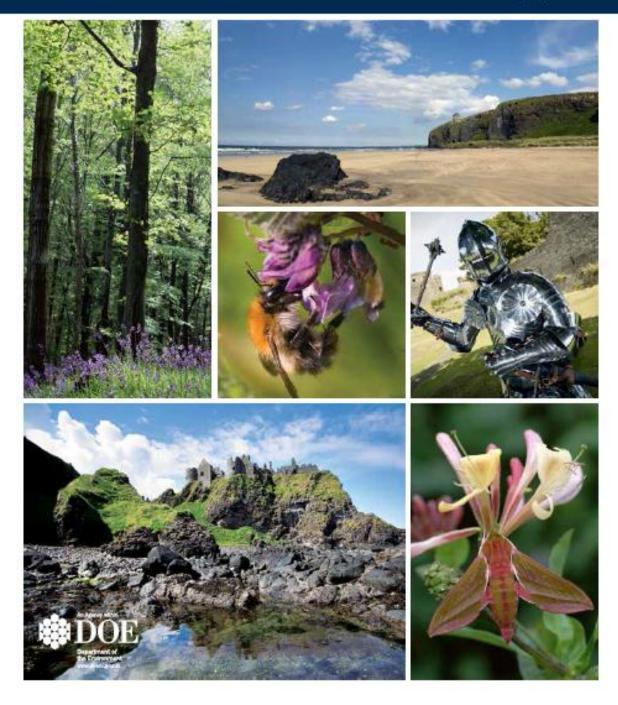

CHIEF EXECUTIVE'S FOREWORD

I am pleased to present the Northern Ireland Environment Agency's (NIEA) Business Plan for 2014-15. It sets out how we will play our role in delivering the Department of Environment's aims for 2014-15.

The Minister's vision for the Department's work is "A Better Environment - A Stronger Economy". This is simple and clear language which powerfully expresses one of the key challenges of the 21st Century: how to bring environmental and economic aims together. The Minister has emphasised that he wants us to deliver this vision "on the ground" in real outcomes, not in more documents and strategies.

In the year just gone, we have set the foundations for this challenge.

We have reformed our Board processes to be more strategic. We have developed a new Delivery Framework to ensure that all our work is designed to implement the Department's overall aims. Finally, we have started to engage with our customers and stakeholders in new ways - supporting and partnering with those who have a responsible and progressive approach to environment and heritage management and getting tougher with those who want to take short cuts and risk damage to our environment and heritage.

The coming year will be a year of major change at NIEA.

We have set ambitious reform aims in the way we regulate and the way we provide input to planning decisions. Following the discovery of a major illegal waste in the north-west and the subsequent findings of the Mills Report, we have set priorities in two key areas in the waste management field. We will put a major emphasis on promoting resource efficiency to reduce the amount of waste created and we will strengthen our regulatory oversight of the residual waste that is created. Our historic environment will receive major attention with a large capital investment of £3m in our premium community assets such as Carrickfergus and Dundrum Castles.

We will build even stronger partnerships with our customers and stakeholders. We will work with businesses to unlock the economic opportunities provided by the climate change and resource efficiency agendas. We will work much more closely with local councils to ensure that waste is responsibly managed. We will work with the public and community groups to help them implement local environment and heritage activities, including increased use of state care monuments and country parks.

Our Business Plan sets out these and other priorities in clear detail so that our staff know what they have to deliver, our customers and stakeholders know what to expect from us and the public knows what targets to hold us to account against.

We look forward to working with all of our partners and meeting the expectations set out in this 2014-15 Business Plan.

Introduction

This is the Business Plan for the Northern Ireland Environment Agency (NIEA) for the 2014-15 year. It describes the strategic context within which the NIEA operates, identifies the key priorities for the year and sets out through the Balanced Scorecard the specific targets the Agency is seeking to achieve to meet its Programme for Government, Departmental and Agency commitments in 2014-15.

Who we are

The NIEA is an Executive Agency within the Department of Environment (DOE) in Northern Ireland operating within the context of the Department's overall vision and strategic objectives and is designed to protect Northern Ireland's environment and built heritage.

We have a total staff complement of c.719 staff (Full Time Equivalents) who are located in offices and regional sites across Northern Ireland. There are three major sites; two in Belfast and one in Lisburn, with the Agency's headquarters located in the Klondyke Building, Belfast. <u>Structure</u>

The NIEA sits within the Environment and Marine Group of the Department and is headed by a Chief Executive and a Board of Directors which spans four Divisions – Historic Environment, Innovation Strategies, Natural Environment and Resource Efficiency. An organisational chart showing all the Divisions within the Agency is at **Annex A** (page 27).

Three Statutory Advisory Councils provide the Agency with independent advice on environmental issues and activities. These are: the Council for Nature Conservation and the Countryside (CNCC), the Historic Buildings Council (HBC) and the Historic Monuments Council (HMC).

The Chief Executive of the Agency is also the Agency Accounting Officer with the responsibilities and delegations outlined in Chapter 3 of the Department of Finance & Personnel (DFP) Guide - Managing Public Money Northern Ireland.

The strategic objective of the Agency is:

To create prosperity and well being through environment and heritage excellence.

This objective underpins the Department's overall vision, "A better environment, a stronger economy".

<u>Values</u>

The Agency seeks to ensure high standards are maintained by its entire staff in fulfilling their role of supporting the Minister and developing good quality services to our customers.

In doing this we will observe the core NICS values of integrity, honesty, objectivity and impartiality.

This one year Business Plan represents the third year of the NIEA Corporate Plan 2012-15 which set out the strategic objectives for NIEA over the period, including its key commitment contained with the Executive's Programme for Government 2011-15.

Our environment and our heritage are essential to the development and rebalancing of the economy and they are a foundation for the wealth, health and well being of the people of Northern Ireland.

The development of our 2014-15 Business Plan has been influenced by our draft Delivery Framework. This draft Delivery Framework is designed to help us plan and conduct our work with much greater consistency, discipline and effectiveness. It has been developed with input from staff. The key component is the following four Operating Principles which will guide all our work, in protecting and improving Northern Ireland's environment and heritage:

- 1. We will make it easy for people to do good business and difficult for people to do bad business;
- 2. We will help create a resource efficient Northern Ireland;
- 3. We will help people see our environment and heritage as an opportunity not a barrier; and
- 4. We will be a customer focused and people centred organisation.

These Operating Principles have helped us set priorities for 2014-15 that are designed to deliver our components of the Department's aims and objectives.

The NIEA has specified five strategic objectives which are contained in the Results quadrant of the Balanced Scorecard (page 11), as follows:

- Deliver effective compliance and implementation of legislation and international obligations;
- Improve understanding and appreciation of our environment and heritage;
- Support a sustainable economy;
- To deliver reformed and effective planning; and
- To deliver regulatory change agenda.

The main activities relating to these objectives are the protection of the environment through regulation and enforcement; statutory designations; research and monitoring; provision of grant aid; raising public awareness of the environment and their role in protecting it; and management and promotion of our sites, monuments and parks.

Using our professional and technical expertise the NIEA contributes to environmental policy development and delivery across other departments and agencies thereby raising awareness and understanding of society's impact on the environment and heritage.

The Agency also provides scientific and technical advice to Government on the development of legislation and policy.

The NIEA has one important environment related priority for 2014-15 which is included as a Key Commitment within the Executive's 2011/15 Programme for Government. This commitment relates to having in place an action plan to implement the new Biodiversity Strategy which will work towards halting the loss of biodiversity by 2020.

The Agency has also identified four other key priorities for delivery of its strategic objectives and new opportunities in 2014-15 following developments in 2013, as follows:

- 1) To deliver all the actions in the Minister's Implementation Response to the Mills Report, following the identification of the illegal waste site in the townland of Mobuoy near Londonderry. The Agency will develop a coherent strategy to deliver increased resource efficiency which will reduce the amount of waste created and also to strengthen our regulatory regime. We will, in particular, develop stronger partnerships with local councils and businesses.
- 2) The establishment of a Regulatory Transformation Programme which aims to put in place an intelligent, outcome-focused regulatory system, to make it easy for responsible businesses to comply and difficult for those who try to flout the law. The main focus for 2014-15 will be the introduction of the Environmental Better Regulation Bill and trialling a number of integrated environmental permits and associated voluntary Prosperity Agreements.
- 3) To support and deliver effective planning under the planning reform programme, which will require the development of new structures and clear responsibilities in responding to the new council arrangements starting in April 2015.
- 4) The realisation of the economic and social benefits of the historic environment, through the delivery of new heritage led development, investment and experience by working with partners across both central and local government, business and communities.

The targets underpinning these priorities are included in the attached Balanced Scorecard for the Agency (Pages 11 to 23).

Further information about all the Agency's activities is available on our website at www.doeni.gov.uk/niea including information on a wide range of publications, explaining or reporting on our work in greater detail.

This one year NIEA Business Plan covers the period from 1st April 2014 to 31st March 2015. The Agency is continuing to use the Balanced Scorecard format to present its objectives, targets and action plan over this period. The scorecard identifies the key business objectives and identifies the actions the Agency needs to take to achieve these objectives thereby enabling effective monitoring and communication of performance.

The Scorecard also sets out objectives across the four perspectives of the Balanced Scorecard in which NIEA must continue to excel if it is to continue to meet the expectations of its customers and stakeholders. While NIEA will measure its performance against all of the objectives identified in its Scorecard, to ensure that it remains focused on the key aspects of its business, the Minister has set **13** key performance targets for the Agency in 2014/15. The table on pages 25-26 shows the objectives and related key targets agreed with the Minister.

Each of the Agency's Divisions also uses the Balanced Scorecard approach to business planning which enables staff to link into the work of their Division and the Agency within their Personal Performance Agreements (PPAs).

Monitoring

A key aspect of this Business Plan will be the monitoring of performance against targets. The Agency Board will consider performance against the key targets agreed with the Minister on a quarterly basis and will receive monitoring reports prepared using a 'traffic light' system to illustrate the status of all targets in the scorecard along with a statement outlining the progress to date provided by the Business Areas with lead responsibility.

At the end of the financial year, we report our performance against these targets in the Agency Annual Report and Accounts which is laid before the Northern Ireland Assembly normally in the first week of July. The accounts are audited by the Comptroller and Auditor General in accordance with the Government Resources and Accounts Act.

Governance

The Agency's Corporate Governance Framework Document, which was revised in February 2014 and placed on the NIEA website, sets out in detail the Agency's approach to Corporate Governance providing information on the arrangements that have been put in place to ensure proper and effective management of the Agency's affairs. The Framework document reflects NIEA's compliance with the guidelines set out in HM Treasury's Code of Good Practice on Corporate Governance in Central Government Departments.

The Agency's primary source of funding in terms of Departmental Resources and Capital Expenditure comes from Central Government. For the 2014/15 financial year, the Agency has been allocated £35.1 million for Current (Resource) expenditure and £4.2 million for Capital expenditure. The Agency also funds additional expenditure on programmes through income from services. Income for 2014-15 is estimated to be £11.3 million.

Annex B (page 28) provides a breakdown of the current and capital funding.

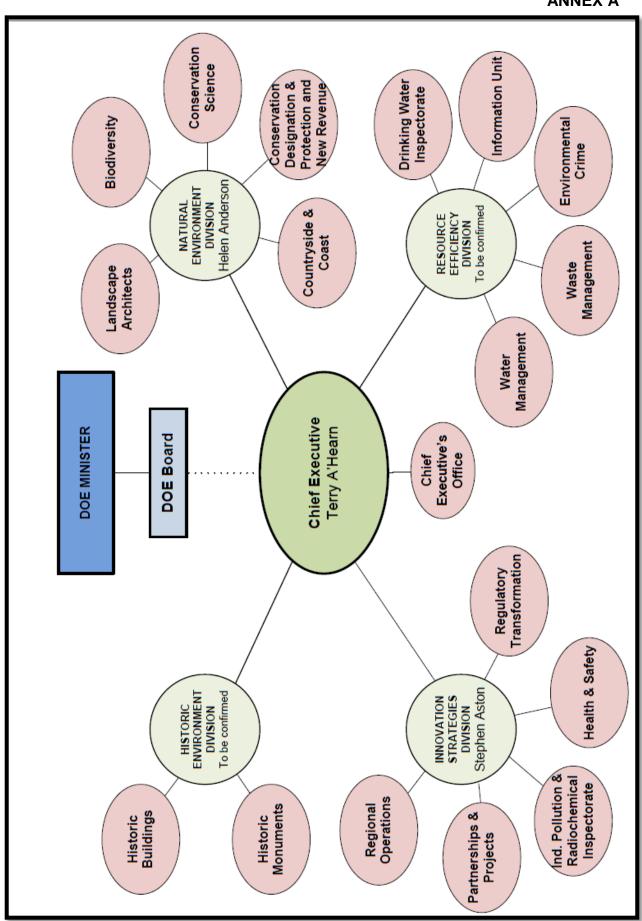
