1 Key Findings

This report provides an overview of Children Order and County, Court of Appeal, Crown, High and Magistrates' Courts' business during 2023 and how it compares with the comparative figures for the previous year. The key findings are summarised below -

Children Order

- During the year there were 1,868 sittings (5,154 hours), 4,632 Children Order applications received and 4,244 disposed.
- At 70% the most common reason for transferring children order applications was complexity, the most common reason each year across the five-year time series.
- In terms of orders made, 1,412 were own motion,
 9,035 were interim and 5,793 were final.
- The average waiting time for applications disposed was 50.5 weeks for public and 32.0 weeks for private law.
- Average processing times in weeks for both public and private law applications have generally increased between 2019 and 2022, before decreasing in 2023.

County Court

- County Court and District Judges sat a total of 4,555 sitting days during the year. Within those days 2,440 (54%) were majority Crown Court days, 1,493 (33%) were majority County Court Judge civil days, and 622 (14%) were majority District Judge civil days.
- In terms of receipts there were 11,177 Civil bills, 161 equity,
 817 ejectment and 8,264 small claims cases received.
- In terms of disposals there were 9,189 Civil bills, 144 equity,
 631 ejectment and 8,019 small claims cases disposed.
- 1,291 divorce decrees were granted, and 1,298 decrees absolute issued.
- There was a general increase in the number of cases received and disposed and the time taken to disposal generally decreased across the different business areas compared with figures for the previous year.

Court of Appeal

- Judges sat a total of 89 days on criminal Court of Appeal business and 137 days on civil Court of Appeal business.
- There were 102 criminal appeals received and 95 disposed, and 92 civil appeals received and 89 disposed.

Crown Court

- During the year there were 2,718 Crown Court sittings with 1,440 cases and 1,794 defendants received and 1,423 cases and 1,724 defendants disposed.
- Average time from committal to hearing was 182 days and from conviction to disposal was 85 days.
- In comparison to the previous year the number of cases and defendants received increased, and the number of cases disposed increased, while the number of defendants disposed decreased.

1 Key Findings

High Court

- There were 2,086 High Court sitting days during the year. The highest proportion of these days was spent on Judicial Reviews business (19%).
- The Chancery Division received 1,996 and disposed of 1,316 cases. Of the 1,996 cases received 65% were Chancery, 20% bankruptcy and 14% companies.
- In terms of King's Bench business, 3,758 writs and originating summons were received and 3,274 were disposed; 1,898 applications were received and 1,458 applications were disposed.
- There were 338 applications for leave to apply for Judicial Review, 77 applications for Judicial Review and 4 ancillary applications received.
- There were 92 adoption cases and applications received and 56 disposed. The average time taken from issue to disposal was 22 weeks.
- There were 2,338 divorce petitions received (974 (42%) for 2 years separation with consent), 875 decrees granted and 854 decrees absolute issued.

Magistrates' Court

- Within the 4,381 Magistrates' sitting days during the year, 72% were adult criminal, 6% youth criminal and 22% civil and family days.
- There were 360 new civil applications, 3,526 new family applications and 38,726 new adult and 1,207 new youth defendants received.
- In terms of disposals there were 300 civil and 3,159 family applications and 38,050 adult and 1,168 youth defendants disposed.
- The average waiting times from summons/charge to disposal in the adult and youth criminal courts were 16 and 22 weeks respectively; from date of receipt to disposal the average waiting time was 23 weeks for civil applications and 8 weeks for family applications.
- Most parameters, except family applications received, were higher than the comparative figures for the previous year; disposals were all higher, with the exception of family applications which decreased by 5%.

2 Introduction

Accredited Official Statistics

Accredited Official Statistics are official statistics that have been independently reviewed by the Office for Statistics Regulation (OSR) and confirmed to comply with the standards of trustworthiness, quality and value in the Code of Practice for Statistics. Producers of accredited official statistics are legally required to ensure they maintain compliance with the Code. Accredited official statistics are called National Statistics in the Statistics and Registration Service Act 2007.

This report is an Accredited Official Statistics publication. The statistics were independently reviewed by OSR in May 2011 in the <u>Assessment of Court Statistics in Northern Ireland</u> with <u>accreditation confirmed</u> in July 2012. They comply with the standards of trustworthiness, quality and value in the Code of Practice for Statistics and should be labelled as Accredited Official Statistics (previously known as National Statistics).

- Business received and disposed, waiting times and sitting days in the Chancery, King's Bench and Family Divisions of the High Court (section 7);
- The number of youth and adult defendants received and disposed, charges and outcomes, sittings, civil applications received and disposed and waiting times at Magistrates' Courts (section 8);
- A summary of some other miscellaneous business areas such as Enforcement of Judgments Office, Coroners and Pension Appeal Tribunals (section 9); and
- A breakdown of the Judge Court sitting days split by the majority type of business heard (section 10).

2 Introduction

Comparative information for the previous year is also provided, along with an indication of whether any change is higher or lower. Trend information for the last five years is also included for some of the statistics.

Background information about the Children Order and the County, Court of Appeal, Crown, High and Magistrates' Courts along with a glossary is available in the accompanying <u>user</u> guide and <u>background quality report</u>.

Data in all tables and charts in the bulletin, along with supplementary data, are available from the DoJ website in the accompanying spreadsheet.

The next update covering the calendar year 2024 will be published in June 2025. A full publication schedule is available on the DoJ website.

3 Children Order

Annual Business Overall

- During the year there were 1,868 sittings (5,154 hours), 4,632 Children Order applications received and 4,244 disposed.
- A total of 6,206 children were involved in the applications disposed. Gender and age breakdowns of the children were 50:49 male:female and 28% 0-4 years, 31% 5-8 years, 25% 9-12 years and 16% 13-16 years.
- Like each of the last five years, the most common reason for transferring children order applications during the year was complexity (70%, 497 of 707 reasons). This was followed by Consolidation (97), Jurisdiction (62), Convenience (19), Return to Lower Court (16), Gravity (11), and Point of Law (5).
- In terms of orders made -
 - > 1,412 were own motion;
 - > 9,035 were interim; and
 - \triangleright 5,793 were final.
- The average waiting time for applications disposed was 50.5 weeks for public and 32.0 weeks for private law.
- Table 1 shows that all parameters were lower than the comparative figures the previous year except for the applications received.



3 Children Order

Five Year Trend


• Figure 1 shows the trend in applications received generally decreased between 2019 and 2020, before increasing by 11% between 2020 and 2021 and then decreasing by 11% in 2022 and then increasing again by 8% in 2023. The trend in applications disposed also decreased between 2019 and 2020, before increasing by 68% between 2020 and 2021 to 4,928 their highest level across the time series. The disposals then decreased in 2022 by 9% and a further 5% in 2023. The disposals were at their lowest level across the time series in 2020, however this is due to the COVID-19 pandemic, and therefore should be treated with caution.

Figure 1: Children Order applications received and disposed 2019 to 2023



• Figure 2 shows the average waiting times for public law has increased by 6% between 2019 (47.5) and 2023 (50.5). The average time peaked in 2021 at 57.2 weeks. Public law applications involve the local authorities and can often deal with complex and serious issues in relation to the welfare of a child, and this can affect waiting times. The trend in average waiting times for private law applications between 2019 and 2023 increased by 24% from 25.8 to 32.0 weeks. Caution should be taken when interpreting these waiting times, as the 2020 and 2021 data has been severely impacted by the COVID-19 pandemic.

Annual Business Overall

- County Court and District Judges sat a total of 4,555 sitting days during the
 year. Within those days 2,440 (54%) were majority Crown Court days, 1,493
 (33%) were majority County Court Judge civil days, and 622 (14%) were
 majority District Judge civil days.
- During the year
 - > 11,177 Civil bills were received and 9,189 disposed.
 - ➤ In terms of cases 161 equity, 817 ejectment, 8,264 small claims and 8 criminal damage cases were received; 144 equity, 631 ejectment, 8,019 small claims and 10 criminal damage cases were disposed.
 - ➤ 1,291 divorce decrees were granted and 1,298 decrees absolute issued.
 - ➤ 257 licence applications were received and 251 disposed.
- Table 2 shows there was a general increase in the number of cases received and disposed compared with figures for the previous year except for Divorces. Average waiting times generally decreased when compared to the previous year.

Figure 3: Civil bills with notice of intention to defend received 2019 to 2023




Figure 4: Civil bills disposed by method of disposal 2019 to 2023





Figure 5: Ejectment cases received and disposed 2019 to 2023

Figure 6: Small claims cases received 2019 to 2023




Figure 7: Criminal damage cases received and disposed 2019 to 2023





Figure 8: Divorce petitions by number of decrees granted by type 2019 to 2023



5 Court of Appeal

Annual Business Overall

- During the year there were 89 sitting days spent on criminal appeals and 137 sitting days on civil appeals.
- There were 102 criminal and 92 civil appeals received, and 95 criminal appeals and 89 civil appeals disposed.
- Compared to the previous year the number of criminal appeals received increased and civil appeals received decreased; disposals decreased for both appeal types.



6 Crown Court


Annual Business Overall

- During the year there were 2,718 sittings (5,534 hours sat). County Court Judges disposed of 98% of defendants (1,690), a figure that has remained relatively stable over the last five years (98-99%).
- There were 1,440 cases and 1,794 defendants received during the year;
 1,423 cases and 1,724 defendants were disposed. In comparison to the previous year the number of cases and defendants received, and cases disposed all increased. The number of defendants disposed decreased.
- Average time from committal to hearing was 182 days and from conviction to disposal was 85 days. Compared to the previous year, average time from committal to hearing and from conviction to disposal both increased.
- The majority of defendants disposed were charged with a combination of offences, a similar pattern seen in each of the last five years (Figure 10 on following page).

Five Year Trend

- Figure 11 shows Crown Court cases received fluctuated and cases disposed generally increased between 2019 and 2023; apart from a decline in 2020 due to COVID-19.





Figure 12: Average Crown Court waiting times 2019 to 2023

- Figure 12 shows the average waiting times from committal to hearing peaked in 2023 at 182 days. The average waiting times from conviction to disposal have fluctuated over the last five years peaking at 85 days in 2023. Some figures will have been affected by delays resulting from the COVID-19 pandemic.

Figure 11: Crown Court cases received and disposed 2019 to 2023

Annual Business Overall

- There were 2,086 High Court sitting days during the year, the highest proportion of which was spent on Judicial Review business (19%).
- King's Bench business included -
- ➤ 3,758 writs and originating summons received and 3,274 disposed;
- > 1,898 applications received and 1,458 disposed; and
- ➤ 338 applications for leave to apply for Judicial Review, 77 applications for Judicial Review and 4 ancillary applications received.
- Chancery Division business included –
- ➤ Receipt of 1,996 (65% which were Chancery, 20% bankruptcy and 14% companies cases) and disposal of 1,316 cases; and
- > 7,538 grants issued in the Probate office.

- ➤ 2,338 divorce petitions received (974 (42%) for 2 years separation with consent), 875 decrees granted (2 years separation with consent (317, 36%) and 'Combination of grounds/ other' (200, 23%) and 854 decrees absolute issued;
- ➤ 178 Official Solicitor's Office Patients cases received and 145 disposed with a current caseload of 420 cases at the end of the year.
- Table 5 shows that apart from King's Bench writs and divorce petitions, receipts increased compared to the previous year.

Figure 13: Chancery cases received 2019 to 2023




Figure 14: King's Bench cases received 2019 to 2023





Figure 15: Applications for Judicial Review received 2019 to 2023

Figure 16: Adoption cases and applications received and disposed 2019 to 2023





Figure 17: Decrees granted by type 2019 to 2023

Annual Business Overall

- Within the 4,381 total sitting days, 72% were adult criminal, 6% were youth criminal and 22% were civil and family days.
- There were 360 new civil and 3,526 new family applications and 38,726 new adult and 1,207 new youth defendants received.
- There were 38,050 adult and 1,168 youth defendants and 300 civil applications and 3,159 family applications disposed.
- All receipts and disposals, except for those for family applications, were higher than the comparative figures for the
 previous year. Supplementary data relating to the Magistrates' Court, are available from the DoJ website in the



Five Year Trend


- Figure 18 shows the volume of both adult criminal defendants received and disposed over the last 5 years. The number received and disposed decreased between 2019 and 2020 and then increased by 26% and 40% respectively in 2021, before increasing again by 4% and 3% respectively between 2021 and 2023.
- The volume of youth defendants received and disposed followed a similar pattern, also both decreasing by 30% and 34% respectively between 2019 and 2020 before increasing again by 35% and 41% respectively between 2020 and 2023.

- Figure 19 shows the average waiting time in the adult Magistrates' court from summons / charge to disposal had risen from 12 weeks in 2019 to 17 weeks in 2020 and 2021, before decreasing to 16 weeks in 2022 and 2023.
- The average waiting time in the youth court from summons / charge to disposal had risen from 16 weeks in 2019 to 23 weeks in 2020, and then decreasing to 22 weeks in 2021, before decreasing again to 20 weeks in 2022 and then increasing to 22 weeks in 2023.

9 Miscellaneous

Percentage changes between 2022 and 2023 for receipts and disposals, fluctuated across the miscellaneous business areas. The EJO Notices of Intention to enforce lodged, applications for enforcement accepted and repossessions completed increased by 32%, 56% and 25% respectively.

11 Appendix 1 - Methodology

Data Source and Coverage

The statistics are produced using administrative data sourced from the Integrated Court Operations System (ICOS). ICOS is a live operating system used in each court tier to process every part of court business, from receipt of payments through to the production of final orders made. The data are input into this system on a daily basis by court clerks, and this information is checked and confirmed by another member of staff to ensure the data entries are correct.

Full details of data relevance, accuracy, timeliness, accessibility, coherence, user need, cost and confidentiality is available in the accompanying <u>background quality</u> <u>report</u>. Details of the data quality checks and processes that DoJ has in place are available in the Quality Assurance of Administrative Data (<u>QAAD</u>) document on the DoJ website.

Counting Rules

Children Order

Receipts are counted from the date the case is entered onto ICOS. Disposals are counted from the result date that a final order was made against the case changing the case status to dealt with.

County Court

Receipts are counted from the date the case is entered onto ICOS and the fees are receipted. Disposals are counted from the result date that a final order was made against the case or the date an applicant withdraws or discontinues their application prior to the hearing, changing the case status to dealt with.

Court of Appeal

Receipts are counted from the date the appeal is entered onto ICOS. Disposals are counted from the result date that a final order was made against the appeal changing the appeal status to dealt with.

Crown Court

Receipts are counted from the date the case is committed to the Crown Court from the Magistrates' Court. Disposals are counted from the result date that a final order was made against the case changing the case status to dealt with.

11 Appendix 1 - Methodology

High Court

Receipts are counted from the date the case is entered onto ICOS and the fees are receipted. Disposals are counted from the result date that a final order was made against the case, or the date an applicant withdraws or discontinues their application prior to the hearing, changing the case status to dealt with.

Magistrates' Court

Receipts are counted from the date a served summons or a charge sheet is received by the Magistrates' Court office. Disposals are counted from the result date that a final order was made against the case changing the case status to dealt with.

Miscellaneous

Receipts are counted from the date the case is entered onto the specific operating system used by the business area. Disposals are counted from the result date that the case was finally marked as closed on the operating system.

Judge Court Sitting Days

A court sitting day is counted as any day where the judiciary sit in court. It does not include time in chambers or days where judiciary are sitting in chambers.
