ROAD TRAFFIC AND VEHICLES

The Waiting Restrictions (Draperstown) Order (Northern Ireland) 2024

Made - - - - 20th November 2024

Coming into operation 16th December 2024

The Department for Infrastructure(a), makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) ("the 1997 Order") and now vested in it(c).

In accordance with paragraphs 1 and 2 of Schedule 1 to the 1997 Order, the Department has consulted such persons as it considers appropriate.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representations have been received.

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Waiting Restrictions (Draperstown) Order (Northern Ireland) 2024 and shall come into operation on 16th December 2024.
 - (2) In this Order —

"medical practitioner" means a fully registered person within the meaning of section 55(1) of the Medical Act 1983(d);

"postal packet" has the same meaning as in section 65(1) of the Postal Services Act 2011(e); and

"universal service provider" has the same meaning as in section 65(1) of the Postal Services Act 2011.

Lengths of road on which vehicles must not wait

2. Save as provided in Article 3, a person shall not cause or permit a vehicle to wait at any time on the lengths of road specified in the Schedule.

Exceptions

- 3.—(1) Nothing in Article 2 shall render it unlawful for a person to cause or permit a vehicle to wait on the carriageway of a length of road specified in the Schedule where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident or for so long as may be reasonably necessary to enable—
 - (a) a person to board or alight from a vehicle provided that such boarding or alighting does not cause the vehicle to wait in the same place for more than 2 minutes;
 - (b) the vehicle to be used in an emergency by a medical practitioner, or for fire and rescue, ambulance, police or customs purposes or for the purposes of the security forces;
 - (c) the vehicle to be used by or on behalf of a universal service provider for the purposes of the delivery to, or collection from, premises situated adjacent to the length of road of postal packets;
 - (d) the vehicle, if it cannot conveniently be used for such purposes outside that length of road, to be used—
 - (i) in connection with any building, repair or demolition operations;
 - (ii) in connection with the removal of any obstruction to traffic;
 - (iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
 - (iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker's functions;
 - (v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992(a) or of a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996(b); or
 - (vi) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in paragraph 5 of Schedule 3A to the Communications Act 2003(c).
 - (e) Nothing in Article 2 shall render it unlawful to cause or permit a vehicle to wait on the carriageway of a length of road specified in Part 1 of the Schedule for so long as may be reasonably necessary to enable goods to be loaded or unloaded from the vehicle.
- (2) For the purposes of paragraph (1)(a) a vehicle shall be deemed to wait in the same place for more than 2 minutes if any one part of the carriageway is below any part of the vehicle or its load (if any) throughout a period exceeding 2 minutes whether or not the vehicle is moved during that period.

Revocation

4. The Waiting Restrictions (Draperstown) Order (Northern Ireland) 2021 is revoked.

SCHEDULE

Article 2

Waiting Restrictions in Draperstown

PART 1

No Waiting at any time (Loading and Unloading Permitted)

- 1. Magherafelt Road (north side) from its junction with Gortnaskey Road for a distance of 42 metres in an easterly direction.
- 2. Magherafelt Road (north side) from its junction with Gortnaskey Road for a distance of 40 metres in a westerly direction.

PART 2

No Waiting at any Time (Loading and Unloading Not Permitted)

Back Lane (both sides) – from a point 15 metres north-west of its junction with High Street for a distance of 25 metres in a north-westerly direction.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prohibits vehicles waiting at any time on lengths of Magherafelt Road, Draperstown specified in Part 1 of the Schedule.

Vehicles are excepted from the prohibition in certain circumstances (Article 3).

This Order also revokes the Order specified in Article 4 and re-enacts the waiting restriction therein.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
